Dear Member,

SEASONS GREETINGS AND BEST WISHES FOR A HAPPY AND PROSPEROUS NEW YEAR



At the outset, I wish to congratulate the newly elected Stewards and Committee Members. I am very confident that with the rich experience they bring to the Club, the sport of racing will benefit immensely.

I also wish to convey my heartfelt thanks to all my colleagues on the Managing Committee for having reposed faith and elected me as

Chairman for the second successive year. I am extremely delighted to inform Members that THE BANGALORE DERBY scheduled on Monday, 26th January 2015 would be sponsored by THE LEGACY GROUP from the construction industry.

The Republic Day would also be of considerable significance, in view that the Club would be showcasing the historical association of Horse Racing with Bangalore and THE BANGALORE RACECOURSE 152ND YEAR COMMEMORATION TROPHY has been scheduled on this day to mark this feature. I am sure the public at large would cherish the role played by the Club in continuously promoting Horse Racing at the Bangalore Racecourse and retaining its greenery and its eco-friendly character, over the past 150 years in the Garden City of Bangalore.

I am happy to report that the Hon'ble High Court of Karnataka vide its judgement dated 26th September 2014 has held that stake money or prize money paid by Race Clubs to Racehorse Owners would not attract the provisions of Section 194B of the Income Tax Act, 1961. The Hon'ble High Court of Karnataka has allowed the writ petitions filed by the Club and has also held that the Bangalore Turf Club is not an assessee in default and has quashed notices and demand issued by the Income Tax Department as being ultra vires of the provisions of the Income Tax Act, 1961.

The Club based on legal advise is also in the process of approaching the Regional Director, Employees State Insurance Corporation seeking exemption in respect of past coverage under the spirit of the New Amnesty Scheme 2014.

The Club has filed an appeal before the Standing Committee (Appeal) Bruhat Bangalore Mahanagara Palike, Bangalore, seeking reduction of the annual rental value from about Rs. 6.75 crores claimed by BBMP to Rs. 1.36 crores with effect from the year 2008-09.

The Club has also accordingly remitted the differential amount of Rs. 3.72 crores towards property tax under the Self Assessment Scheme (SAS). The appeal is pending disposal. While the Special Leave Petition before the Hon'ble Supreme Court of India is posted for hearing on 13th January 2015, efforts are on with the Government of Karnataka to try and reach an amicable settlement in the matter relating to the tenure of the existing Racecourse.

On behalf of my colleagues and on my own, I can assure the Members that this Committee will strive to deliver the best in the challenging circumstances. I look forward to the support of Members in addressing these matters.

- 2. Hiring of Display Board for displaying bookmaker odds involving a cost of Rs. 18 lakhs for 300 betting days in a year.
- 3. Mr. K.P.G. Appu Appointed as Assistant Starter cum Assistant Captain, BARI

- 5. The Rotation of Race Day Staff: Earlier the betting terminal operators were the only category of staff who were on rotation. Now all the categories of staff such as Supervisors, Shroff Section, General Staff, runners for tote, ticket checkers, etc., around 33 categories of employees who have been deployed to work in various places have been codified for rotation and the application software has been enhanced accordingly. A test check has been completed and it is ready for a trial run. This will ensure better management of the individual functioning of the employees. ## **Legal Matters**

- The matter before the Supreme Court pertaining to shifting of race course was listed on 25th November 2014 but did not reach the court. The matter is now listed for hearing on Tuesday, 13th January 2015.
- 2. TDS on Stake Money: A Writ Petition was filed in the Hon'ble High Court of Karnataka with a contention that deduction of Tax at Source on Stake Money U/s 194B was not applicable. The matter was admitted for hearing during the financial year 2012-13 and after several hearings, the Hon'ble Court has passed an order favouring the Club stating that Section 194B (TDS on Stake Money) is not applicable and the stake money is outside the purview of Section 194B. The gist of the order are:
- Stake Money or Prize Money paid by the Race Clubs to horse owners would not attract provisions of Section 194B of the Income Tax Act, 1961.
- b) Declare the Petitioner BTC (Owners & Trainers) cannot be treated as Assessee in Default U/s 201 of the Income Tax Act 1961 and the demand raised for the earlier years 2006-07, 2007-08, 2008-09 & 2009-10 have been quashed as ultravirus of the provisions of the Income Tax Act, 1961.
