I hereby authorize B.T.C Ltd., to debit from my racing account with the Club towards licence fee, fines and applicable taxes, etc., or any other amount payable by me to the Club.

I agree to abide by and be bound by Bangalore Turf Club Ltd., Rules of Racing, Notification and Instructions issued by the Stewards of the Bangalore Turf Club Ltd., from time to time. I will also present myself for a medical checkup by the Club's Medical Officer, if so desired by the Stewards of the Bangalore Turf Club Ltd.,

I declare that whilst carrying on my vocation as a Jockey in India, I do not desire to acquire any money in India for remittance outside India and no money's received by me in India will be remitted outside India, without prior written approval of the Reserve Bank of India.

I undertake to comply with the relevant laws applicable to me for my stay in India as also with regard to the money's earned by me in carrying on my profession or vocation as a Jockey.

I hereby declare that I hold a valid Jockey's licence/ Amateur Ride's permit for flat races/ steeple chase and hurdle races issued by

I am not subject to any suspension or Medical Restriction at this time and I agree to be bound in all respects by the Rules of the recognized Turf Authority concerned when riding abroad and I accept that any suspension which may be imposed on me by that Authority may be extended by other Racing Authorities under their Domestic Rules and in accordance with their laws of Public Order.

have applied for "A" / "B" Jockey Licence from BTC, solemnly undertake the following:

1. To ride out the race assigned to me on its merit without demure.
2. Not consorted with, or have an ownership, partnership or other commercial interest with or business ties to any person who is or has been involved with, or has in any jurisdiction at any time pleaded guilty, been found guilty or been convicted of, forfeited bail or been fined for, or currently has a criminal indictment or complaint pending for, illegal gambling, extortion, racketeering involving organized crime, fraud, misrepresentation, race-fixing or any other effort to pre-determine the outcome of a race, bookmaking, bet solicitation, or other similar conduct, or its equivalent.
3. I will not be involved in any unlawful activities with respect to Horseracing.
4. I authorize BTC to debit and adjust my account for licence fee, fines, applicable taxes and any other dues payable by me against the credit in my account, or else will pay the said dues within 15 days from the end of the month in which the debit was incurred.
5. I have read and I am aware of the Rules of Racing, Notifications and Instructions issued by BTC and its Stewards from time to time and I will abide and I am bound by the same.
6. I will also be present for a Medical and Physical Test whenever mandated by BTC or by its Stewards.
7. I will not engage in conduct that involves Cruelty to Animals.
8. I am not using, any Illegal Drug, Narcotic or Controlled Substance, or is engaging in the excessive use of Alcohol.
9. I have not knowingly made a false statement of a material fact in my Application or have not knowingly failed to disclose any information requested by BTC.
