RACING INCIDENTS
(8-14)

GOING : Good

PENETROMETER READING: 3.9 Cms.

RAILING POSITION : Railing fixed at average width of 6 Meters from 1600 Meters to winning post from its original position.

1st Race: 8. The Esquire Plate - (About) 1100 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (9 Runners).

SEA OF CORTEZ (P. Trevor) was examined before running of the race and was observed to be trotting lame on right fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds. Trainer Mr. Neil Darashah was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

COMMODUS (Prashant P. Dhebe) was extremely fractious at the start and refused to be stalled. Under the circumstances, it was permitted to be withdrawn before coming under starter's order.

It was observed that Jockey Neeraj Rawal, the rider of KNIGHT TEMPLAR accidentally lost his left rein approaching 200 Metres which he regained passing the 100 Metres.

Routine Sample was taken for analysis from the winner dk b g MEGA IKON.

2nd Race: 9. The Udhagamandalam Plate - (About) 1200 metres. Horses rated 00 to 20 (12 Runners).

GLORIOUS DAYS (Amy Merchant) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. S. Inayathulla was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

JERSEY STORM (Chetan Kalay S.) jumped awkwardly outwards and inconvenienced PURITY (Mudassar Nazar) soon after jumping out of the starting gates.

Jockey A.A. Vikrant, the rider of ARROGANCE was fined Rs.1,000/- for coming 'in' and causing interference to LADY DIANA (T. S. Jodha) on his inside approaching 1150 Metres.

Jockey Amy Merchant, the rider of GLORIOUS DAYS was fined Rs.1,000/- for shifting 'in' and causing interference to LADY DIANA (T. S. Jodha) on his inside along the rails passing the 900 Metres.

Jockey N. B. Kuldeep, the rider of LOVEMYBOSS was fined Rs.1,000/- for shifting 'in' and causing interference to GLORIOUS DAYS (Amy Merchant) on his inside along the rails passing the 750 Metres.

ISLAND PEARL (Raghu K) was impounded for veterinary examination. On examination, it was found to have burst its blood vessels (Endoscopy Grade - IV). Trainer Mr. Narayana Gowda V. was informed that he must produce a Fitness Certificate from the Club's

Veterinary Officer before accepting with it again.

Surprise sample was taken for analysis from b m ISLAND PEARL.

Routine Sample was taken for analysis from the winner b m HIGH ADMIRAL.

3rd Race: 10. The Dr. T. Thimmaiah Memorial Trophy - (About) 1400 metres. Horses rated 45 to 65 (12 Runners).

Jockey P.S. Chouhan, the rider of GOOD TIME INDEED was reprimanded for shifting out and inconveniencing CASTAWAY (A. Imran Khan) on his outside soon after the start.

Routine Sample was taken for analysis from the winner b f BLUE MOON.

4th Race: 11. The Sir Cecil Youngsters Million - (About) 1400 metres. 3-year-old horses (foaled in 2016). (10 Runners).

Jockey Akshay Kumar, the rider of ESTEVA was fined Rs.2,000/- for shifting 'in and causing interference to THAILAND (A. Sandesh) on his inside passing the 1100 Metres.

VICTORY PARADE (Kiran Naidu) was impounded for veterinary examination but no abnormality was reported.

MIRABILIS (Neeraj Rawal) was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f ANJEZE.

5th Race: 12. The Poonawalla Stud Plate - (About) 1200 metres. Horses rated 30 to 50 (11 Runners).

RECZAI (Irvan Singh) was extremely fractious at the gates as a result the bridle snapped. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

Jockey A.R. Pradeep, the rider of NAGARJUNA was severely reprimanded for travelling wide from 1000 Metres till rounding the final bend for no apparent reason.

BLUEJACK (Raghuveer Singh) sustained superficial bleeding injury on right hind cannon.

Routine Sample was taken for analysis from the winner ch g ALPHA.

6th Race: 13. The Managing Committee Gold Cup - (About) 1400 metres. Horses rated 75 and above (7 Runners).

Permission was granted to Trainer Mr. Irfan Ghatala to withdraw TOROROSSO on veterinary grounds as it was bleeding from left nostril and also found to have abrasions on back of hocks. He was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Hindu Singh replaced the indisposed Jockey Rajesh. N on INTO THE SPOTLIGHT

Routine Sample was taken for analysis from the winner b f ARABIA.

7th Race: 14. The Lady Gibraltar Plate - (About) 1200 metres. Horses rated 15 to 35, 5 years old and over (Whips not allowed) (12 Runners).

AMALFI COAST (Raghu K) took a fly jump.

Jockey Raghuveer Singh, the rider of PRINCEAZEEM was reprimanded for shifting out and inconveniencing AMALFI COAST (Raghu.K) soon after the start.

Jockey Irvan Singh, the rider of INCITATUS was fined Rs.1,000/- for shifting 'in' and inconveniencing the horses on his inside viz; INKY BLACK (Vishal N Bunde), AMALFI COAST (Raghu K) and PRINCEAZEEM (Raghuveer Singh) soon after the start.

It was reported after the race that PRINCEAZEEM (Raghuveer Singh) burst its blood vessels (Endoscopy - Grade III). Trainer Mr.M. Rajendra Singh was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b m MAHANATI.
