RACING INCIDENTS

(55-62)

GOING : Good

PENETROMETER READING: 3.5 Cms.

RAILING POSITION : Railing fixed at average width of 5 Meters from 1600 Meters to winning post from its original position.

1st Race: 55. The Everynsky Plate - (About) 1100 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible). (8 Runners).

It was observed that the shadow band on TOUCHWOOD (P. Mani) loosened soon after the start and apparently fell off passing the 350 Metres. Trainer Mr. Warren Singh was fined Rs.3,000/- for his negligence.

Routine Sample was taken for analysis from the winner b f PORT OF BEAUTY.

2nd Race: 56. The Kranji Plate - Div. II - (About) 1400 metres. Horses rated 00 to 20, 4 years old and over (10 Runners).

MIMING (M. Ravi) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Prithviraj B. was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

It was observed that ABLE MASTER (N. B. Kuldeep) had to shift out to avoid striking the front runner MIMING (M. Ravi), thereby taking out TURF PROSPECTOR (Prashant P.Dhebe) on its outside passing the 550 Metres.

MIMING (M. Ravi) ran detached after rounding the final bend. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Prithviraj B. was informed to ensure better performance of his charge in future.

SHIVALIK SHOW (Suraj Narredu) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner ch f GLORIOUS DAYS.

3rd Race: 57. The Diablo Plate - Div. II - (About) 1200 metres. Horses rated 15 to 35, 4 years old and over (10 Runners).

DESERT GOLD (S. Mubarak) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Dheeraj.V was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Nazerul Alam, the rider of GALVARINO was fined Rs.1,000/- for coming 'in' and causing interference to the horses on his inside viz; UNBROKEN (Prashant P.Dhebe) and ANAKIN (A.Ramu) soon after the start.

Jockey Aryn Merchant, the rider of LOVELY SIERRA reported that his mount was trying to run out after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported.

UNBROKEN (Prashant P.Dhebe) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g DEPTH CHARGE.

4th Race: 58. The K. N. Chennabasappa Memorial Trophy - (About) 1200 metres. Horses rated 45 to 65 (12 Runners).

Trainer Mr. Pradeep Annaiah was fined Rs.1,000/- for failing to produce the declared colors at the scales in respect of his charge ATTORNEY GENERAL . Subsequently All Black emergency colors were permitted to be used.

WAR HERO (Prashant P.Dhebe) jumped awkwardly inwards and inconvenienced VICTORY PARADE (P. Trevor) soon after the start.

ANGELS KISS (Mudassar Nazar) jumped awkwardly inwards and inconvenienced WAR HERO (Prashant P.Dhebe) soon after the start.

Jockey A.Imran Khan, the rider of CASTAWAY was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

ALPHA (Nikhil Naidu) was subjected to veterinary examination but no abnormality was reported.

CADILLAC (A. Sandesh) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f SPIRITOUS.

5th Race: 59. The Winner's Circle Trophy - (About) 1200 metres. Horses rated 75 and above (9 Runners).

Routine Sample was taken for analysis from the winner dk b f LADY LEGEND.

6th Race: 60. The Lumbini Stud Plate - (About) 1600 metres. Horses rated 30 to 50, 5 years old and over (11 Runners).

BACK OF BEYOND (Koushik. P) took a fly jump.

AMAZING SKILL (Yash Narredu) was subjected to veterinary examination but no abnormality was reported.

Trainer Mr. Irfan Ghatala and Jockey P. S. Chouhan were questioned regarding running and riding of LYCURGUS. Especially with specific reference to the use of whip by the Jockey in the final 200 Metres. The trainer instructed the Jockey to whip the horse only when it was necessary. The Jockey followed the instructions of the trainer and whipped the horse only twice. As the horse was finishing on strongly in the end, the Trainer and Jockey were severely reprimanded for such practice of giving instructions and riding out the horse.

Routine Sample was taken for analysis from the winner b m WILD WILD ANGELS.

7th Race: 61. The Kranji Plate - Div. I - (About) 1400 metres. Horses rated 00 to 20, 4 years old and over (9 Runners).

Permission was granted to Trainer Mr. Sharat Kumar to withdraw SOUTH BELL on veterinary grounds as it was found to be trotting lame on right hind and also sustained injuries on right hind cannon. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Trainer Mr. Azhar Ali was fined Rs.5,000/- for discrepancy in shoeing in respect of his charge SHIVALIK KISS (1st infringement).

Jockey Irvan Singh, the rider of SCARLET PRINCESS was fined Rs.2,000/- for shifting 'in' and causing interference to the horses on his inside viz; FIND (S. John) and GREAT CELEBRATION (Amyn Merchant) soon after the start.

SCARLET PRINCESS (Irvan Singh) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f SHIVALIK KISS.

8th Race: 62. The Diablo Plate - Div. I - (About) 1200 metres. Horses rated 15 to 35, 4 years old and over (10 Runners).

It was reported after the race that HABANERO (K. Raja Rao) had apparently lost its left fore shoe during the race.

HABANERO (K. Raja Rao) was subjected to veterinary examination but no abnormality was reported.

An enquiry was held on 17-6-2019 by the Stipendiary Stewards into the interference caused by Jockey K. Raja Rao on his mount HABANERO in that he shifted 'in' sharply under the use of whip and caused interference to REVAN STAR (Chetan Kalay.S) on his inside along the rails approaching 250 Metres and thereafter he did not maintain a straight course in the final stages of the race.

Jockey K. Raja Rao was interviewed by the Stipendiary Stewards. The Stipendiary Stewards after considering the submissions made by Jockey K. Raja Rao and after viewing the CCTV replay of the race charged Jockey K. Raja Rao for careless riding for contravention of Rule No. 161 (i) of the BTC Rules of Racing. The Stipendiary Stewards thereafter suspended the Jockey's Licence granted to K. Raja Rao with effect from 27-6-2019 to 30-6-2019 (both days inclusive) for contravention of Rule No. 161 (i) of the BTC Rules of Racing for Careless Riding on his mount HABANERO (he is permitted to ride work and was informed of his right to appeal).

Routine Sample was taken for analysis from the winner ch f CANDLELIGHTQUEEN.
