**RACING INCIDENTS**  
**(63-70)**

GOING : Good

PENETROMETER READING: 3.2 Cms.

RAILING POSITION : Railing fixed at average width of 5 Meters from 1600 Meters to winning post from its original position.

**1<sup>st</sup> Race: 63. The Ich Dien Plate - (About) 2000 metres. Horses rated 15 to 35 (7 Runners).**

SANTIAGO (S. Zervan) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. S. Dominic was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey T. S. Jodha, the rider of EXTREMELYDANGEROUS was reprimanded for shifting out and inconveniencing TRACK STRIKER (Antony Raj S.) on his outside in the final 100 Metres.

EXTREMELYDANGEROUS (T. S. Jodha) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g HERE AND NOW.

**2<sup>nd</sup> Race: 64. The His Majesty Plate - (About) 1200 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible). (9 Runners).**

Jockey P. Trevor, the rider of DESERT COMBAT reported that his mount was hanging out throughout the race. The horse was subjected to veterinary examination but no abnormality was reported. Trainer Mr. Prasanna Kumar was informed to take appropriate corrective measures before accepting with it again.

AIR FORCE ONE (Prashant P. Dhebe) was impounded for veterinary examination. On examination, it was found to have pulled up lame on right fore. Trainer Mr. S. Narredu was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Surprise sample was taken for analysis from b f AIR FORCE ONE.

Routine Sample was taken for analysis from the winner b f ABIRA.

**3<sup>rd</sup> Race: 65. The Aboline Plate - (About) 1100 metres. Horses rated 15 to 35 (9 Runners).**

Jockey A. Ramu, the rider of MISCHIEF FLYER was fined Rs. 3,000/- for shifting out under the use of whip and taking out INDUSTRIALIST (D'nuSingh Deora) on his outside between the 250 Metres and 150 Metres.

Jockey A.R. Pradeep, the rider of MORRANE GABRIELLA was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

An enquiry is being held into the running and riding of ANDRA KING, trained by Trainer Mr. Pradeep Annaiah and ridden by Jockey Surya .P in the above race.

Routine Sample was taken for analysis from the winner b f ANFIA.

**4<sup>th</sup> Race: 66. The Mystic Memory Plate - Div. I - (About) 1200 metres. Horses rated 30 to 50, 4 years old and over (11 Runners).**

Jockey Abhay Singh, the rider of BAYMAX was fined Rs.2,000/- for not sufficiently persevering with his mount in the final 200 Metres.

PROPINE (M. Prabhakaran) was subjected to veterinary examination. On examination, it was found to have pulled up lame on left fore and also sustained bleeding injury on right hind outer bulb of heel. Trainer Mr. Kishan Thomas was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g AIR COMMAND.

**5<sup>th</sup> Race: 67. The Mayor's Cup - (About) 1600 metres. Horses rated 60 and above (10 Runners).**

Permission was granted to Trainer Mr. Azhar Ali to withdraw BUSCADERO (A.R.Pradeep) on veterinary grounds as it was found to be suffering from Diarrhoea & fever. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Permission was granted to Trainer Mr. Arjun Mangalorkar to withdraw SEA KING (Antony Raj S.) on veterinary grounds as it was found to be lame on left fore due to inflamed tendon. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

FABULOUS (S. John) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Arjun Mangalorkar was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

It was reported after the race that FABULOUS (S. John) pulled up lame on left fore. Trainer Mr. Arjun Mangalorkar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

AUTOMATIC (Shamaz Shareef) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f LA RONDINE.

**6<sup>th</sup> Race: 68. The Krishnaraja Wadiyar Cup - (About) 1600 metres. 4 years old and over. (8 Runners).**

STAR SUPERIOR (Suraj Narredu) sustained bleeding injury on left hind cannon.

Routine Sample was taken for analysis from the winner b r STAR SUPERIOR.

**7<sup>th</sup> Race: 69. The Xisca Plate - (About) 1100 metres. Horses rated 00 to 20 (10 Runners).**

As Jockey Ahsan Qureshi was unable to fulfill his riding engagement (as his father was ill). Permission was granted to trainer Mr. Irfan Ghatala to declare Jockey Vinod Shinde to ride SAVISA in place of the declared rider.

ODYSSEY (Irvan Singh) was extremely fractious and refused to be stalled. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

An enquiry is being held into the interference caused by Jockey Arshad Alam, the rider of PREMIER PREMISES in the above race.

An enquiry is being held into the interference caused by Jockey S.Mubarak, the rider of HIGH HAWK in the above race.

Routine Sample was taken for analysis from the winner ch f MY LEXICON.

**8<sup>th</sup> Race: 70. The Mystic Memory Plate - Div. II - (About) 1200 metres. Horses rated 30 to 50, 4 years old and over (12 Runners).**

KINGSFIELD (S.Mubarak) after jumping out, slightly swerved left, did not raise a fluent gallop, lost many lengths and thereafter ran detached from the field. In view of its behaviour, Trainer Mr.S. Narredu was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey S. Zervan, the rider of MULTIFACETED was fined Rs.1,000/- for coming 'in' and causing interference to WINGS OF DESIRE (P. S. Chouhan) on his inside approaching 1100 Metres.

Jockey A.R.Pradeep, the rider of NAGARJUNA was reprimanded for travelling wide throughout the race for no apparent reason.

RAW GOLD (Vivek) sustained bleeding injury on right fore cannon.

Routine Sample was taken for analysis from the winner b g MULTIFACETED.

**ADDITIONAL REPORTS**

**BANGALORE SUMMER MEETING 2019**  
**FIFTH DAY, SATURDAY, 1st June, 2019**

**Race: 30. The Mamma's Mink Plate - Div. I - (About) 1200 metres. Horses rated 15 to 35, 4 years old and over.**

(A)

An enquiry was held on 10-6-2019 by the Stipendiary Stewards into the excess weight (1.2 Kgs) carried by Jockey R. Vaibhav, the rider of FANTASTIC APP in relation to the weight, he weighed

out with.

Jockey R. Vaibhav was interviewed by the Stipendiary Stewards. The Stipendiary Stewards after considering the submissions made by Jockey R. Vaibhav decided to charge for contravention of Rule No. 180 of the BTC Rules of Racing as regards "WEIGHING IN". The Stipendiary Stewards thereafter suspended the Jockey's Licence granted to R. Vaibhav with effect from 20-6-2019 to 23-6-2019 (both days inclusive) for contravention of Rule No. 180 of the BTC Rules of Racing as regards "WEIGHING IN" on his mount FANTASTIC APP (he was permitted to ride work and was informed of his right to appeal).

**(B)**

The Stipendiary Stewards reported Jockey Ryan Marshall, the rider of SAHARA to the Stewards for contravention of Rule No. 159 (b) of the BTC Rules of Racing in that:

As the rider of "SAHARA"

- (a) You were in a comfortable lead of about 2 lengths approaching 100 Metres marker, thereby you dropped hands and eased up your mount and you choose to look at the screen within which you had a challenger which came in the end on your outside and beat you on the post.
- (b) You realized the challenger much too late and your efforts to ride out again after the challenger had passed was futile.
- (c) You did not use your whip at any point of time in the race, when you had all the opportunity to do so.

The Stewards held an enquiry on 16-6-2019 and interviewed Jockey Ryan Marshall and his Spokesman Trainer Mr. Darius R. Byramji.

The Stewards after considering the submissions made by his spokesman Trainer Mr. Darius R. Byramji and after viewing the CCTV replay of the race and after deliberations decided to:

- (a) Suspend the Jockeys Licence granted to him w.e.f 26-6-2019 to 25-9-2019 (both days inclusive) for contravention of Rule No. 159 (b) of the BTC Rules of Racing on his mount SAHARA.
- (b) He is not permitted to ride work.
- (c) He was informed of his right to appeal.

**EIGHTH DAY , SUNDAY , 9<sup>TH</sup> JUNE ,2019**

**Race: 49. The June Plate - (About) 1200 metres. Horses rated 00 to 20.**

An enquiry was held on 10-6-2019 by the Stipendiary Stewards into the interference caused by Jockey V. R. Jagadeesh on his mount ALL BY MYSELF in that he shifted out and caused severe interference to SONGKRAN (P. S. Chouhan), which in turn passed it onto DARAHASINI (Surya P.) on his outside passing the 150 Metres.

Jockey V. R. Jagadeesh was interviewed by the Stipendiary Stewards. The Stipendiary Stewards after considering the submissions made by Jockey V. R. Jagadeesh and after viewing the CCTV replay of the race charged Jockey V. R. Jagadeesh for careless riding for contravention of Rule No. 161 (i) of the BTC Rules of Racing. The Stipendiary Stewards thereafter suspended the Jockey's Licence granted to V. R. Jagadeesh with effect from 20-6-2019 to 29-6-2019 (both days inclusive) for contravention of Rule No. 161 (i) of the BTC Rules of Racing for Careless

Riding on his mount ALL BY MYSELF (he is permitted to ride work and was informed of his right to appeal).

**Race: 54. The Fire Haven Plate - (About) 1400 metres. Horses rated 15 to 35.**

An enquiry was held on 15-6-2019 by the Stipendiary Stewards into the interference caused by Jockey Nikhil Naidu on his mount SIR PIGGOT in that he shifted out and caused severe interference to the horses on his inside viz; NOSTRADAMUS (Surya P.), HAFNIUM (Arshad Alam) and GREY CHANNEL (Amyn Merchant) approaching 200 Metres.

Jockey Nikhil Naidu was interviewed by the Stipendiary Stewards. The Stipendiary Stewards after considering the submissions made by Jockey Nikhil Naidu and after viewing the CCTV replay of the race charged Jockey Nikhil Naidu for careless riding for contravention of Rule No. 161 (i) of the BTC Rules of Racing. The Stipendiary Stewards thereafter suspended the Jockey's Licence granted to Nikhil Naidu with effect from 25-6-2019 to 30-6-2019 (both days inclusive) and as he had pleaded guilty of the charge for contravention of Rule No. 161 (i) of the BTC Rules of Racing for Careless Riding on his mount SIR PIGGOT (he is permitted to ride work and was informed of his right to appeal).
