PENETROMETER READING: 3.0 Cms.

RAILING POSITION: Railing fixed at average width of 7.5 Meters from 1600 Meters to winning post from its original position.

1<sup>st</sup> Race: 35. The Glorious Colours Plate - (About) 1600 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (Outstation horses eligible). (10 Runners).

Jockey A. Sandesh, the rider of INDIAN DEMOCRAT was fined Rs.1,000/- for coming 'in' and causing interference to CALL OF THE BLUE (Koushik) on his inside along the rails passing the 450 Metres.

Jockey C.Umesh, the rider of NOVA SCOTIA was fined Rs.3,000/- for coming 'in' and causing interference to INDIAN DEMOCRAT (A. Sandesh) on his inside along the rails passing the 400 Metres.

Routine Sample was taken for analysis from the winner b g WIZARD OF STOCKS.

# 2<sup>nd</sup> Race: 36. The Iflookscouldkill Plate - (About) 1100 metres. Horses rated 00 to 20 (8 Runners).

Permission was granted to Trainer Mr. Faraz Arshad to withdraw COUNTRY'S STAR (Ravi R.) on veterinary grounds as it was found to be trotting lame on left fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

ARROGANCE (Suraj Narredu) stumbled soon after jumping out of the starting gates.

Jockey A.S.Peter, the rider of QUEEN ISABELLA was fined Rs.2,000/- for coming 'in' and causing interference to ZEDCLASS (V.R.Jagadeesh) on his inside along the rails passing the 950 Metres.

Jockey Mudassar Nazar, the rider of PURITY was reprimanded for travelling wide from 500 Metres till passing the winning post for no apparent reason.

An enquiry was held on 3<sup>rd</sup> June, 2019 by the Stipendiary Stewards for the above race in respect of Jockey A.S. Peter pertaining to his riding on his mount QUEEN ISABELLA, "In that he did not exhibit sufficient vigour in riding out his mount with the aid of the whip when his mount was full of running in the final 200 Metres."

Jockey A.S. Peter was interviewed by the Stipendiary Stewards. The Stipendiary Stewards, after considering the submissions made by Jockey A.S. Peter and trainer Mr. Faraz Arshad and after viewing the CCTV replay of the race decided to charge Jockey A.S. Peter for Incompetent Riding, Rule No. 161 (ii) of the BTC Rules of Racing.

The Stipendiary Stewards thereafter suspended Jockey A.S. Peter with effect from 15<sup>th</sup>

June, 2019 & 16<sup>th</sup> June, 2019 (both days inclusive) for Incompetent Riding Rule No. 161 (ii) of the BTC Rules of Racing on his mount QUEEN ISABELLA (he is permitted to ride work and was informed of his right to appeal).

ARROGANCE (Suraj Narredu) was impounded for veterinary examination but no abnormality was reported.

PURITY (Mudassar Nazar) was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner dk b m ZAFRINA.

# 3<sup>rd</sup> Race: 37. The Bergamo Plate - (About) 1200 metres. Horses rated 30 to 50, 5 years old and over (12 Runners).

FLORENCIA (C.Umesh) jumped awkwardly outwards and bumped BIRCHWOOD (Manish R) on its outside soon after the start.

Routine Sample was taken for analysis from the winner b g STANDOUT.

### 4<sup>th</sup> Race: 38. The Brig. R. C. R Hill Memorial Trophy - (About) 1600 metres. Horses rated 45 to 65 (8 Runners).

Jockey Darshan R.N, the rider of PLAY SAFE was fined Rs.1,000/- for coming 'in' and causing interference to SUPER SMART (Nikhil Naidu) on his inside soon after the start.

Jockey Akshay, the rider of MASADA was fined Rs.1,000/- for shifting out and causing interference to SUPER SMART (Nikhil Naidu) on his outside soon after the start

Jockey S. Zervan, the rider of EXCLUSIVE BLUE reported that he accidentally lost his whip passing the 100 Metres.

PLAY SAFE (Darshan R.N) was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner dk b c IMPAVID.

# 5<sup>th</sup> Race: 39. The Karnataka Juvenile Million (Grade III) - (About) 1400 metres. 3-year-old horses (foaled in 2016). (10 Runners).

PRINCESS ANNABEL (S.A. Amit) was examined at the starting gate by the Club's Veterinary Officer and was found to be trotting lame on right fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. Altamash Ahmed was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was observed that TRAFALGAR (A. Sandesh) could not get a clear run between the 300 Metres to 200 Metres due to closely packed field.

It was observed that BLAZER (C.Umesh) ran detached after passing the 300 Metres.

Jockey Neeraj Rawal, the rider of HUNT FOR GOLD reported that he could not get a clear run from 150 Metres till passing the winning post due to a closely packed field.

MISSING YOU (Suraj Narredu) sustained small injury on right hind.

Compulsory samples were taken for analysis from the following I,II & III placed horses viz:

#### 6<sup>th</sup> Race: 40. The Prabalo Plate - (About) 1200 metres. Horses rated 15 to 35 (7 Runners).

SLOVENIA (P. Trevor) was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f HARMONIA.

## 7<sup>th</sup> Race: 41. The Belmont Park Plate - (About) 1600 metres. Horses rated 00 to 20 (8 Runners).

As Jockey Vishal N Bunde was unable to fulfill his riding engagement due to health issues. Permission was granted to trainer Mr.Neil Darashah to declare Jockey A.S.Peter to ride PRINCESS AMU in place of the declared rider.

MERITORIOUS (Darshan R.N) after jumping out, did not raise a fluent gallop for the first 100 Metres. In view of its behaviour, Trainer Mr.S. Ganapathy was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Trainer Mr. S.S. Attaollahi was questioned regarding the running of his charge APOLLO BAY (P. Trevor) in the above race.

The trainer stated that:

- (a) He had given a jump out and quite a few canters on the inner sand track;
- (b) He felt that the horse had a strong chance as it was facing a mediocre company and much to his surprise the horse ran a very deplorable race;
- (c) The trainer's log book/work books were inspected and were found to be in order. His explanations were noted for future reference and he was informed to ensure better performance of his charge in future.

SULTANA (Nazerul Alam) was impounded for veterinary examination but no abnormality was reported.

APOLLO BAY (P. Trevor) was impounded for veterinary examination but no abnormality was reported.

Surprise sample was taken for analysis from b g APOLLO BAY.

Routine Sample was taken for analysis from the winner dk b g WINX.

Race: 7. The Littleover Plate - (About) 1100 metres. Horses rated 15 to 35, 4 years old and over.

An enquiry was held on 29<sup>th</sup> May, 2019 by the Stipendiary Stewards into the running and riding of IDO WHAT I DO, trained by Mr. Prasanna Kumar and Jockey Harish.B in the above race. "In that he did not make sufficient effort to ride out his mount with the aid of the whip when his mount was full of gallop after rounding the final bend."

Jockey Harish.B was interviewed by the Stipendiary Stewards. The Stipendiary Stewards,

after considering the submissions made by Jockey Harish.B and trainer Mr. Prasanna Kumar and after viewing the CCTV replay of the race decided to charge Jockey Harish.B for Unsatisfactory Riding, Rule No. 161 (ii) of the BTC Rules of Racing.

The Stipendiary Stewards thereafter suspended Jockey Harish.B with effect from 8<sup>th</sup> June, 2019 to 16<sup>th</sup> June, 2019 (both days inclusive) for Unsatisfactory Riding Rule No. 161 (ii) of the BTC Rules of Racing on his mount IDO WHAT I DO (he is permitted to ride work and was informed of his right to appeal).

#### THIRD DAY, SATURDAY, 25th MAY, 2019

#### Race: 20. The Santorini Star Plate - (About) 1200 metres. Horses rated 15 to 35.

HAPPY DANCING (Tauseef Ahmed) jumped out awkwardly whereby the Jockey got totally unbalanced and was dislodged from his mount soon after jumping out of the starting gates. In view of its behaviour, Trainer Mr. Sharat Kumar was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.
