PENETROMETER READING: 3.2 Cms.

RAILING POSITION : Railing fixed at its original position.

**1<sup>st</sup> Race: 78. The Sports Authority of India Cup - Div. II - (About) 1200 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (Outstation horses eligible). (9 Runners).**

SASAKWA (N. S. Parmar) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. P. Shroff was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

STRATEGIST (Koushik. P) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. R.H.Sequeira was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Vivek, the rider of SKY MOON reported that his mount was running green throughout the race. The horse was subjected to veterinary examination but no abnormality was reported.

SUPER GLADIATOR (Rayan Ahmed R.) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f ROSINA.

**2<sup>nd</sup> Race: 79. The Sweet Memories Plate - Div. II - (About) 1100 metres. Horses rated 15 to 35, 4 years old and over (10 Runners).**

QUEEN ISABELLA (A.S.Peter) was extremely fractious, reared up and sat down with left fore leg stuck over the gates for a considerable period of time. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order.

Jockey Ahsan Qureshi, the rider of GRECIAN LIGHT was reprimanded for riding an indifferent race.

CAPSTONE (M. Prabhakaran) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner dk b m CAPSTONE.

There was a mild drizzle during the running of the 3rd race.

**3<sup>rd</sup> Race: 80. The Sports Authority of India Cup - Div. I - (About) 1200 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (Outstation horses eligible). (9 Runners).**

Jockey David Allan, the rider of ICE FLOE was fined Rs.3,000/- for shifting 'in' and causing interference to YOURS FOREVER (P. S. Chouhan) on his inside approaching 200 Metres.

Jockey Harish B., the rider of GIETHORN reported that his mount was not galloping fluently after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner ch f ICE FLOE.

**4<sup>th</sup> Race: 81. The A. M. C. Gowda Memorial Trophy - (About) 2000 metres. Horses rated 45 to 65 (6 Runners).**

Jockey Neeraj Rawal, the rider of ROYAL CRYSTAL was reprimanded for shifting 'in' and inconveniencing STRIKING GREY (Darshan R.N) on his inside passing the 1600 Metres.

DR LOGAN (Ahsan Qureshi) accidentally stumbled passing the 750 Metres.

Jockey Bhawani Singh, the rider of PLAY SAFE reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. Trainer Mr. Aravind G. was informed to take appropriate corrective measures before accepting with it again.

SALVADOR DALI (A. Sandesh) was subjected to veterinary examination. On examination, it was found to have pulled up lame on left fore. Trainer Mr. S. Padmanabhan was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b c SECRETIVE FORCE.

The penetrometer reading before the start of the 5th race was 4.2 cms.

**5<sup>th</sup> Race: 82. The Fillies Championship Stakes(Grade I) - (About) 1600 metres. 3-year-old Indian Fillies (Foaled in 2016) (9 Runners).**

ROLL CALL (Akshay Kumar) was subjected to veterinary examination but no abnormality was reported.

Compulsory samples were taken for analysis from the following I,II & III placed horses viz:

b f WELL CONNECTED I

dk b f THAILAND II

b f ANJEZE III

**6<sup>th</sup> Race: 83. The Nanoli Stud Plate - (About) 1200 metres. Horses rated 30 to 50 (11 Runners).**

Permission was granted to Trainer Mr. M. Rajendra Singh to withdraw BLUEJACK (Amyr Merchant) on veterinary grounds as it was found to be lame on right hind due to severe injury. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

HARMONIA (P. S. Chouhan) jumped awkwardly outwards and inconvenienced KARADENIZ (A.Imran Khan) on its outside soon after the start.

HARMONIA (P. S. Chouhan) was subjected to veterinary examination but no abnormality was reported.

DESERT ROSE (P. Trevor) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b c ROMA VICTOR.

**7<sup>th</sup> Race: 84. The Sweet Memories Plate - Div. I - (About) 1100 metres. Horses rated 15 to 35, 4 years old and over (11 Runners).**

Jockey Harish .B replaced the indisposed Jockey M. Prabhakaran on BELLA MAMMA.

BELLA MAMMA (Harish B.) was slowly away, lost few lengths, did not raise a fluent gallop and thereafter ran detached. In view of its behaviour, Trainer Mr. Kishan Thomas was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

It was reported after the race that ISLAND PEARL (A.S.Peter) burst its blood vessels. Trainer Mr. Narayana Gowda V. was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

BELLA MAMMA (Harish B.) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f VARCASVA.

**BANGALORE SUMMER MEETING 2019**  
**EIGHTH DAY, SUNDAY, 9TH JUNE, 2019**

**Race No: 49. The June Plate - (About) 1200 metres. Horses rated 00 to 20.**

An enquiry was held on 22-6-2019 by the Stipendiary Stewards into the interference caused by Jockey Ahsan Qureshi on his mount SHOW GIRL in that he shifted 'in' and caused severe interference to to the horses on his inside viz; SEABORN (Md.Akram), IRISH PRINCE (M. Mark) and DUTY CALL (Nikhil Naidu) soon after the start.

Jockey Ahsan Qureshi was interviewed by the Stipendiary Stewards. The Stipendiary Stewards

after considering the submissions made by Jockey Ahsan Qureshi and after viewing the CCTV replay of the race charged Jockey Ahsan Qureshi for careless riding for contravention of Rule No. 161 (i) of the BTC Rules of Racing. The Stipendiary Stewards thereafter suspended the Jockey's Licence granted to Ahsan Qureshi with effect from 2-7-2019 to 7-7-2019 (both days inclusive) for contravention of Rule No. 161 (i) of the BTC Rules of Racing for Careless Riding on his mount SHOW GIRL (he is permitted to ride work and was informed of his right to appeal).

**NINTH DAY , SATURDAY , 15<sup>TH</sup> JUNE ,2019**

**Race No: 62. The Diablo Plate - Div. I - (About) 1200 metres. Horses rated 15 to 35, 4 years old and over.**

DON DELA VEGA (S.Mubarak) planted and did not take any practical part in the race. In view of its behaviour, Trainer Mr. Dheeraj.V was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least two Mock Races.

**TENTH DAY , SUNDAY , 16<sup>TH</sup> JUNE ,2019**

**Race No: 69. The Xisca Plate - (About) 1100 metres. Horses rated 00 to 20.**

**(A)**

An enquiry was held on 22-6-2019 by the Stipendiary Stewards into the interference caused by Jockey Arshad Alam on his mount PREMIER PREMISES in that he shifted 'in' and caused severe interference to HIGH HAWK (S. Mubarak), which in turn passed it onto SAVISA (Vinod Shinde) along the rails passing the 950 Metres. The Stipendiary Stewards after considering the submissions made by Jockey Arshad Alam decided to fine him a sum of Rs.5,000/- and severely cautioned him.

**(B)**

An enquiry was held on 22-6-2019 by the Stipendiary Stewards into the interference caused by Jockey S. Mubarak on his mount HIGH HAWK in that he shifted 'in' and caused severe interference to the horses on his inside viz; AEROSPEED (Yash Narredu) and GLOBAL RULER (P.Mani) which had to be checked by their respective riders and fall back approaching 1000 Metres. The Stipendiary Stewards after considering the submissions made by Jockey S. Mubarak decided to fine him a sum of Rs.5,000/- and severely cautioned him.

**TWENTYSIXTH DAY , FRIDAY , 22<sup>ND</sup> MARCH 2019**

**Race No: 190. The Champion Jockey Trophy - Div. I - (About) 1400 Metres. Horses rated 15 to 35.**

The Stewards of the Bangalore Turf Club Ltd. at their meeting held on Saturday, 22<sup>nd</sup> June, 2019 considered the Charge Sheet No: 673 dated 5<sup>th</sup> June, 2019 submitted by Chief Stipendiary Steward pertaining to the positive finding of THEOBROMINE (Class -IV) and CAFFEINE (Class -II) prohibited substances in the urine sample taken from b.rig ANOTHER RAINBOW winner of Race No. 190. The Champion Jockey Trophy Div-I - (About) 1400 Metres. Horses rated 15 to 35, run on 22<sup>nd</sup> March, 2019. The horse trained by Mr. Mahmood Khan and owned by Mr. A. Wajid.

The Stewards examined trainer Mr. Mahmood Khan and after deliberations decided to suspend the trainer's licence granted to Trainer Mr. Mahmood Khan w.e.f 2<sup>nd</sup> July, 2019 to 1<sup>st</sup> September, 2019 (both days inclusive) and fine him a sum of Rs.15,000/- for infringement of Medication Rules laid down under BTC Calendar Notification under the

heading "Medication and treatment of horses in Training and Racing and Anti-Doping Control" in respect of his charge **b.rig ANOTHER RAINBOW** reading as follows:

"The trainer is always responsible for the protection and security of the horse in his care. The trainers are warned that they will be held responsible if an examination of a horse, results in the finding of any prohibited substances"

He was informed of his right to appeal.
