**RACING INCIDENTS**  
**(42-47)**

**GOING : Good**

**PENETROMETER READING: 3.8 Cms.**

**RAILING POSITION : Railing fixed at average width of 8.5 Meters from 1600 Meters to winning post from its original position.**

**1<sup>st</sup> Race: 42. The Royal Challenge Plate - Div. II - (About) 1400 metres. Horses rated 30 to 50, 4 years old and over (8 Runners).**

TURF JAGUAR (Hindu Singh) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. R. V. Manohar was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Adarsh G., the rider of ULTIMATE SPEED reported that his mount was hanging out after entering the straight. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. V. Lokanath was informed to take appropriate corrective measures before accepting with it again.

BLUEJACK (Aryn Merchant) was impounded for veterinary examination. On examination, it was found to have pulled up lame on right fore. Trainer Mr. M. Rajendra Singh was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that TURF JAGUAR (Hindu Singh) burst its blood vessels. Trainer Mr. R. V. Manohar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner ch f ORENDA.

**2<sup>nd</sup> Race: 43. The Prince Khartoum Trophy - (About) 1200 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible). (9 Runners).**

Permission was granted to Trainer Mr. Neil Darashah to withdraw TENNO SHO on veterinary grounds as it was found to be trotting lame on left fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Trainer Mr. Prithviraj .B was fined Rs.5,000/- for discrepancy in shoeing in respect of his charge RICHMOND HILL (1st infringement).

RICHMOND HILL (Manish R) was examined at the starting gate by the Club's Veterinary Officer and was found to be trotting lame on right fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. Prithviraj B. was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey S. Zervan, the rider of AKASI reported that his mount was lugging out throughout the race. The horse was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g COMMODUS.

**3<sup>rd</sup> Race: 44. The Star Supreme Plate - (About) 1400 metres. Horses rated 15 to 35, 5**

**years old and over (12 Runners).**

As Jockey Shamaz Shareef was unable to fulfill his riding engagement due to health issues. Permission was granted to trainer Mr. Irfan Ghatala to declare Jockey D.R. Shubham to ride FIORENZO in place of the declared rider.

Jockey Surya P., the rider of AGNAR reported that his mount was hanging out throughout the race. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Pradeep Annaiah was informed to take appropriate corrective measures before accepting with it again.

Jockey Aryn Merchant, the rider of ZALA PRINCESS was severely reprimanded for not exhibiting adequate vigour in the final 300 Metres.

Jockey N. S. Parmar, the rider of JAYADRATHA reported that his mount was hanging 'in' in the final 200 Metres. The horse was impounded for veterinary examination but no abnormality was reported.

It was reported after the race that FIORENZO (D.R. Shubham) pulled up lame on right fore. Trainer Mr. Irfan Ghatala was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

DECLARATION OF LOVE (Manish R) was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner ch g INCITATUS.

**4<sup>th</sup> Race: 45. The Civil Service Cup - (About) 1200 metres. Horses rated 60 and above (9 Runners).**

MINIVER ROSE (Manish R) was extremely fractious in the paddock, injured the rider and as no suitable substitute Jockey was available. Permission was granted to trainer Mr. Prithviraj.B to withdraw it from the above race.

HAEDI'S FOLLY (Irvan Singh) was extremely fractious, broke out of the front barrier and thereafter refused to be stalled. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

REGAL MUSIC (Md.Akram) after jumping out, veered out to the left and lost many lengths. In view of its behaviour, Trainer Mr. Prithviraj B. was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

CERISE NOIR (A. Sandesh) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.S. S. Attaollahi was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Rayan Ahmed R., the rider of LIFE AWAITS was fined Rs.2,000/- for shifting out and taking out the horses on his outside viz; FIRE GLOW (T. S. Jodha) and CERISE NOIR (A. Sandesh) passing the 850 Metres.

Routine Sample was taken for analysis from the winner ch g COURAGE.

**5<sup>th</sup> Race: 46. The Meydan Plate - (About) 1200 metres. Horses rated 15 to 35 (9 Runners).**

As Jockey Ajay Kumar.R was unable to fulfill his riding engagement due to health issues. Permission was granted to trainer Mr.Dheeraj.V to declare Jockey A.S.Peter to ride DESERT GOLD in place of the declared rider.

Jockey Surya P., the rider of YOURESOHANDSOME reported that he momentarily lost

his reins passing the 350 Metres which regained within a few strides.

Jockey Akshay, the rider of AFTER HOURS reported that he accidentally lost his whip passing the 250 Meters.

Trainer Mr. Prasanna Kumar and Jockey Anjar Alam were questioned regarding the running and riding of PRODIGAL. The trainer stated that he had to declare Jockey Anjar alam as his horse was carrying 60 kilos and he could not find a top weight Jockey, also he was satisfied with his riding and felt that he was beaten by a better horse. Considering the history of the horse wherein it dropped the rider in its previous outing the trainer preferred to declare this Jockey instead of Jockey P. Trevor. The Jockey corroborated the statements and stated that he did his best as instructed by the trainer. Their explanations were noted for future reference.

Routine Sample was taken for analysis from the winner b h STARI GRAD.

**6<sup>th</sup> Race: 47. The Royal Challenge Plate - Div. I - (About) 1400 metres. Horses rated 30 to 50, 4 years old and over (9 Runners).**

Jockey Raghuveer Singh replaced the indisposed Jockey Manish.R on BEOND REACH.

Routine Sample was taken for analysis from the winner b g AEOLUS.
