GOING: Good

PENETROMETER READING: 3.4 Cms.

RAILING POSITION: Railing fixed at average width of 8.5 Meters from 1600 Meters to winning post from its original position.

1st Race: 48. The Endorsement Plate - (About) 1800 metres. Horses rated 00 to 20 (8 Runners).

Jockey A.S.Peter replaced the indisposed Jockey Manish. R on EXTREMELYDANGEROUS.

Trainer Mr. Neil Darashah was fined Rs.5,000/- for discrepancy in shoeing in respect of his charge PRINCESS AMU (1st infringement).

GALINO (Akshay) was impounded for veterinary examination. On examination, it was found to have pulled up lame on right fore. Trainer Mr. Mahmood Khan was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

SIMPLY MAGICAL (Yash Narredu) was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g TRACK STRIKER.

2nd Race: 49. The June Plate - (About) 1200 metres. Horses rated 00 to 20 (12 Runners).

Jockey A.S. Peter replaced the indisposed Jockey Manish.R on DESERT ANGEL.

DESERT ANGEL (A.S.Peter) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. S. Dominic was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey V.R.Jagadeesh, the rider of ALL BY MYSELF was fined Rs.1,000/- for shifting out and causing interference to RANCHO (N. B. Kuldeep) on his outside soon after the start.

Jockey P. S. Chouhan, the rider of SONGKRAN placed 5th by the judge objected against Jockey Surya P., the rider of DARAHASINI placed 1st and also against Jockey V.R.Jagadeesh, the rider of ALL BY MYSELF placed 3rd for "In the final furlong ALL BY MYSELF shifted out and at the same time the winner shifted 'in' and both the horses took my ground and hampered my run which cost me a certain race". The Stewards held an enquiry immediately after the race and interviewed the Jockeys concerned. After deliberations, they decided to overrule the objection against Jockey Surya P., the rider of DARAHASINI and upheld the objection against Jockey V.R.Jagadeesh, the rider of ALL BY MYSELF and revised the order of placings as under:

DARAHASINI I
CHULA VISTA II
DUTY CALL III
SONGKRAN IV
ALL BY MYSELF V

Jockey Ahsan Qureshi, the rider of SHOW GIRL shifted 'in' and caused severe interference to the horses on his inside viz; SEABORN (Md.Akram), IRISH PRINCE (M. Mark) and DUTY CALL (Nikhil Naidu) soon after the start. An enquiry is being held into the incident.

It was observed that Jockey M. Ravi, the rider of PROUDWISH had to shift out to avoid striking the front runner ASTRON (Irvan Singh) along the rails, thereby taking out DESERT ANGEL (A.S.Peter) on his outside approaching 900 Metres.

Jockey V.R.Jagadeesh, the rider of ALL BY MYSELF shifted out and caused severe interference

to SONGKRAN (P. S. Chouhan), which in turn passed it onto DARAHASINI (Surya P.) on his outside passing the 150 Metres. An enquiry is being held into the incident.

RANCHO (N. B. Kuldeep) ran detached from the field. Trainer Mr. Praveen Jesu was informed to ensure better performance of his charge in future.

SEABORN (Md.Akram) ran detached from the field. Trainer Mr. Sriram Komandur was informed to ensure better performance of his charge in future.

IRISH PRINCE (M. Mark) ran detached from the field. Trainer Mr. Sharat Kumar was informed to ensure better performance of his charge in future.

It was reported after the race that RANCHO (N. B. Kuldeep) pulled up lame on left fore. Trainer Mr. Praveen Jesu was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b f DARAHASINI.

3rd Race: 50. The Flirting Vision Plate - (About) 1600 metres. Horses rated 15 to 35, 4 years old and over (8 Runners).

RED INDIAN (Irvan Singh) ran detached after passing the 700 Metres. The horse was impounded for veterinary examination but no abnormality was reported. Trainer Mrs. Parvati Byramji was informed to ensure better performance of his charge in future.

Jockey S. Zervan, the rider of NATALMA was fined Rs.3,000/- for the excessive use of whip on his mount during the race (1st infringement).

KING CREOLE (A. Sandesh) was impounded for veterinary examination. On examination, it was found to have burst its blood vessels (Endoscopy Grade - III). Trainer Mr. S. Padmanabhan was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Surprise sample was taken for analysis from b g KING CREOLE.

Routine Sample was taken for analysis from the winner b f NATALMA.

4th Race: 51. The Y. S. Surender Memorial Trophy - (About) 1400 metres. Horses rated 45 to 65, 5 years old and over (12 Runners).

Jockey P. Trevor replaced the indisposed Jockey P.S. Chouhan on GOOD TIME INDEED.

STARRY WIND (V.R.Jagadeesh) threw its head up while jumping out and lost many lengths. In view of its behaviour, Trainer Mr.Darius R. Byramji was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

GOOD TIME INDEED (P. Trevor) jumped awkwardly outwards and SET TO WIN (S. Zervan) jumped awkwardly inwards and inconvenienced GYPSY (N. Rawal) soon after the start.

Jockey Nazerul Alam, the rider of BROOKLYN SUPREME was severely cautioned for not exhibiting sufficient vigour in the final 200 Metres.

STRIKING GREY (Darshan R.N) was impounded for veterinary examination but no abnormality was reported.

STARRY WIND (V.R.Jagadeesh) was impounded for veterinary examination but no abnormality was reported.

Surprise sample was taken for analysis from gr g STRIKING GREY.

Routine Sample was taken for analysis from the winner b g SET TO WIN.

5th Race: 52. The Shapoorji Pallonji Million - (About) 1200 metres. 4 years old and over. (12 Runners).

Jockey Prashant P. Dhebe replaced the indisposed Jockey P.S. Chouhan on SOUTHPAW.

SUBAH KA TARA (J. Chinoy) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Samar Singh informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey P. Trevor, the rider of TUTANKHAMUN was fined Rs.2,000/- for shifting 'in' and causing interference to the horses on his inside viz; ORGANIC (Yash Narredu), SMILE STONE (Naveen M.), CAPTAIN COURAGE (Neeraj Rawal) and ACCOLADE (Suraj Narredu) soon after the start.

Jockey A. Sandesh, the rider of MAURITANIA was reprimanded for shifting 'in' and inconveniencing TUTANKHAMUN (P. Trevor) on his inside rounding the final bend.

MAURITANIA (A. Sandesh) was impounded for veterinary examination but no abnormality was reported.

BLUE BLAZER (Arshad Alam) was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b c KNOTTY ASH.

6th Race: 53. The Moonlight Romance Plate - (About) 1400 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible). (11 Runners).

Jockey J. Chinoy replaced the indisposed Jockey P.S. Chouhan on SIR LANCELOT.

Jockey Hindu Singh, the rider of AQABA was reprimanded for shifting out and inconveniencing TRULY DELIGHTFUL (Prashant P.Dhebe) on his outside passing the 1200 Metres.

Jockey Darshan R.N, the rider of SCINTILLA reported that his mount was not galloping fluently after entering the straight. The horse was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner ch f KIRKWOOD.

7th Race: 54. The Fire Haven Plate - (About) 1400 metres. Horses rated 15 to 35 (8 Runners).

Jockey P. Trevor replaced the indisposed Jockey P.S. Chouhan on MARCO POLO.

AZEEMKI PRINCESS (Raghuveer Singh) was extremely fractious inside the stalls, broke out from the stalls and thereafter ran rider less around the course. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

MARCO POLO (P. Trevor) jumped awkwardly outwards and inconvenienced the horses on its outside viz; HAFNIUM (Arshad Alam) and GREY CHANNEL (Amyn Merchant) soon after the start, whereby the rider of GREY CHANNEL lost balance momentarily.

Jockey Amyn Merchant, the rider of GREY CHANNEL was fined Rs.2,000/- for shifting 'in' and causing interference to HAFNIUM (Arshad Alam) on his inside passing the 1300 Metres.

Jockey Nikhil Naidu, the rider of SIR PIGGOT shifted out and caused severe interference to the horses on his outside viz; NOSTRADAMUS (Surya P.), HAFNIUM (Arshad Alam) and GREY CHANNEL (Amyn Merchant) approaching 200 Metres. An enquiry is being held into the incident.

Jockey Amyn Merchant, the rider of GREY CHANNEL reported that he accidently lost his whip in the final 100 Meters.

Routine Sample was taken for analysis from the winner b g RENEGADE.
