# BANGALORE SUMMER MEETING 2019 SEVENTEENTH DAY, SATURDAY, 13<sup>TH</sup> JULY, 2019 RACING INCIDENTS (115 - 120)

**GOING: Good** 

PENETROMETER READING: 3.4 Cms.

RAILING POSITION: Railing fixed at average width of 6.5 Meters from 1600 Meters to winning post from its original position.

1<sup>st</sup> Race: 115. The Mount Everest Plate - (About) 1200 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible). (8 Runners).

Permission was granted to Trainer Mr.Prasanna Kumar to withdraw HARBOUR SUNRISE (P. Trevor) on veterinary grounds as it was found to have sustained poll injury. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was observed that HEAVENLY ANGEL (Darshan R.N) was inclined to run out thereby inconvenienced SUN SPLASH (Neeraj Rawal) passing the 1000 Metres.

Jockey P. S. Chouhan, the rider of SILVER SWIFT reported that he accidently lost his whip passing the 200 Meters.

HEAVENLY ANGEL (Darshan R.N) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner ch f WINALL.

# 2<sup>nd</sup> Race: 116. The Galilee Plate - (About) 1600 metres. Horses rated 15 to 35, 5 years old and over (8 Runners).

Jockey S.Mubarak, the rider of FOTOGENIC was reprimanded for not being alert in wearing his goggles at the starting gates. Subsequently, he put the goggles on passing the 1400 Metres.

It was observed that Jockey Manish .R, the rider of ADMIRAL ONE had to steady his mount due to crowding of the field passing 1000 Metres.

Jockey S.Mubarak, the rider of FOTOGENIC was reprimanded for travelling wide from 650 Metres till rounding the final bend for no apparent reason.

Jockey G Sai Vamshi, the rider of GOLD MIST was reprimanded for travelling wide from 650 Metres till rounding the final bend for no apparent reason.

Jockey G Sai Vamshi, the rider of GOLD MIST was reprimanded for dropping hands before passing the winning post.

EXTREMELYDANGEROUS (T. S. Jodha) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g TRACK STRIKER.

### 3<sup>rd</sup> Race: 117. The Brave Dancer Plate - (About) 1200 metres. Horses rated 00 to 20 (8 Runners).

Permission was granted to trainer Mr. Sharat Kumar to withdraw FIRST STEP from the

above race.

It was observed that the saddle on SAVISA (Shamaz Shareef) had shifted back passing the 450 Meters as such the Jockey could not offer any assistance to his mount thereafter. After due examination of the equipment, Trainer Mr. Irfan Ghatala was fined Rs.5,000/- for faulty saddling.

Jockey P. S. Chouhan, the rider of DALLAS was reprimanded for shifting out and inconveniencing ARROGANCE (Yash Narredu) on his outside in the final 150 Metres.

Jockey A.R.Pradeep, the rider of CROZIET was reprimanded for dropping hands in the final 100 Metres.

ARROGANCE (Yash Narredu) was subjected to veterinary examination but no abnormality was reported.

CROZIET (A.R.Pradeep) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner dk b g SINGHSAAB.

#### 4<sup>th</sup> Race: 118. The Squanderer Trophy - (About) 2000 metres. Horses rated 60 and above (6 Runners).

Routine Sample was taken for analysis from the winner dk b c SECRETIVE FORCE.

## 5<sup>th</sup> Race: 119. The P. V. Shetty Memorial Trophy - (About) 1200 metres. Horses rated 45 to 65 (9 Runners).

Jockey Neeraj Rawal replaced the indisposed Jockey S. John on FAIR WARNING.

TREASURE DELIGHT (Yash Narredu) jumped awkwardly outwards and inconvenienced SUPER SUCCESS (R. Vaibhav) on its outside soon after the start.

Jockey A. Sandesh, the rider of CADILLAC was reprimanded for shifting 'in' and inconveniencing TREASURE DELIGHT (Yash Narredu) on his inside passing the 1000 Metres.

Jockey Akshay Kumar, the rider of ANFIA reported that his mount was inclined to run out despite his best efforts after rounding the final bend. The horse was subjected to veterinary examination but no abnormality was reported.

DREAM STAR (A.Ramu) was subjected to veterinary examination. On examination, it was found to have soft palate dislocation in the larynx (Endoscopy).

Routine Sample was taken for analysis from the winner b f CASTAWAY.

# 6<sup>th</sup> Race: 120. The Nanoli Stud Stakes - (About) 1600 metres. Horses rated 30 to 50, 4 years old and over (7 Runners).

Permission was granted to Trainer Mr.Imtiaz Khan to withdraw HIGH ADMIRAL (K. Sai Kiran) on veterinary grounds as it was found to be lame on left fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

AMAZING SKILL (R. Manjunath) planted and did not take any practical part in the race. In view of its behaviour, Trainer Mr.S. Narredu was informed that he must not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey P. Trevor, the rider of AUSTRALIS was fined Rs.3,000/- for the excessive use of whip on his mount during the race (1<sup>st</sup> infringement).

It was reported after the race that TRIGGAR (A.Ramu) burst its blood vessels. Trainer Mr.Imtiaz Khan was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b m AUSTRALIS.
