RACING INCIDENTS
(135 – 143)

GOING : Good

PENETROMETER READING: 3.6 Cms.

RAILING POSITION: Railing fixed at its original position.

1st Race: 135. The Indian Pattern Committee Cup - (About) 1200 metres. Horses rated 15 to 35 (9 Runners).

Routine Sample was taken for analysis from the winner b f CONSTANZA.

2nd Race: 136. The Hyderabad Cup - Div. I - (About) 1400 metres. Horses rated 15 to 35 (11 Runners).

AZEEMKI PRINCESS (T. S. Jodha) jumped out awkwardly.

KING OF SHADOWS (Shobhan Babu) ran detached from the field. The horse was subjected to veterinary examination. On examination, it was found to have burst its blood vessels. However, Trainer Mr. Nityanand G. was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

DUXTON (V.R.Jagadeesh) was subjected to veterinary examination but no abnormality was reported.

ANDRA KING (P. S. Chouhan) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f CRACK OF DAWN.

3rd Race: 137. The Kolkata Cup - (About) 2000 metres. Horses rated 30 to 50, 4 years old and over (8 Runners).

Jockey Arshad Alam replaced the indisposed Jockey Akshay Kumar on NITROMAX.

Jockey Adarsh G., the rider of TANOURA reported that he accidentally lost his right stirrup passing the 250 Metres as such he could not offer much assistance thereafter.

NITROMAX (Arshad Alam) sustained superficial bleeding injury on right side hip.

Routine Sample was taken for analysis from the winner dk b/br g LYCURGUS.

4th Race: 138. The Mumbai Cup - (About) 1400 metres. Horses rated 45 to 65 (10 Runners).

Jockey Y. S. Srinath replaced the indisposed Jockey Akshay Kumar on SAKURA.

PSYCHIC WARRIOR (M. Noornabi) was extremely fractious in the starting gates. On immediate examination by the Club's Veterinary Officer, it was found to be sore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. M. Rajendra Singh was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Y. S. Srinath, the rider of SAKURA was reprimanded for shifting out and inconveniencing TORSORO (Manish R) on his outside passing the 800 Metres.

NIKANDROS (Harish B.) ran detached from the field. The horse was subjected to veterinary examination. On examination, it was found to have pulled up lame on right fore. Trainer Mr. S. Inayathulla was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey S. Zervan, the rider of MULTIFACETED reported that he did not get a clear run between the 250 Metres and 200 Metres and again in the final 50 Metres due to closely packed field, thereby he could not ride the horse with the use of whip.

Routine Sample was taken for analysis from the winner gr f SAKURA.

5th Race: 139. The Mystical Million - (About) 1600 metres. Maiden 3-year-old Horses. (9 Runners).

Permission was granted to trainer Mrs. Parvati Byramji to withdraw PRAYER from the above race.

Jockey Prashant P.Dhebe replaced the indisposed Jockey Akshay Kumar on HOKKAIDO.

Jockey Prashant P.Dhebe, the rider of HOKKAIDO reported that his mount was running green throughout the race. The horse was subjected to veterinary examination but no abnormality was reported.

It was observed that NORTH WINDS (Yash Narredu) drifted out violently after passing the 250 Metres and raced wide on the outer grass despite the best efforts of the Jockey. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. M. Narredu was informed to take appropriate corrective measures before accepting with it again.

Routine Sample was taken for analysis from the winner b g SPEAKING OF STARS.

6th Race: 140. The B. T. C. Anniversary Cup (Grade II) - (About) 1400 metres. 4 years old and over. (12 Runners).

Jockey A. Sandesh replaced the indisposed Jockey Akshay Kumar on LA RONDINE.

Jockey Prashant P. Dhebe, the rider of STAR BARON reported that his mount accidentally slipped from its hind approaching 800 Metres.

Compulsory samples were taken for analysis from the following I,II & III placed horses viz:

7th Race: 141. The Kingfisher Ultra Derby Bangalore (Grade I) - (About) 2000 metres. 3-year-old Indian Horses (Foaled in 2016) (10 Runners).

Jockey Prashant P.Dhebe replaced the indisposed Jockey Akshay Kumar on ANJEZE.

Jockey Prashant P.Dhebe, the rider of ANJEZE reported that he accidentally lost his whip passing the 500 Meters.

8th Race: 142. The Admiral Henry John Rous Trophy - (About) 1200 metres. Horses rated 75 and above (10 Runners).

Jockey Darshan R.N replaced the indisposed Jockey A. Sandesh on BOLD COMMAND.

Jockey Antony Raj S replaced the indisposed Jockey Akshay Kumar on ARECA LEGEND.

Jockey Irvan Singh replaced the indisposed Jockey P.S. Chouhan on BORA BORA.

TOROROSSO (Shamaz Shareef) jumped out awkwardly.

Routine Sample was taken for analysis from the winner b g SAINT PETERSBURG.

9th Race: 143. The Hyderabad Cup - Div. II - (About) 1400 metres. Horses rated 15 to 35 (11 Runners).

LOVELY SIERRA (Amy Merchant) after jumping threw its head up in the air.

Jockey Amy Merchant, the rider of LOVELY SIERRA reported that his mount accidentally slipped approaching 900 Metres.

Jockey Antony Raj S., the rider of FIND was fined Rs.2,000/- for shifting 'in' and causing interference to the horses on his inside viz; GLORIOUS DAYS (T. S. Jodha) and COSMIC FEELING (Nazerul Alam) passing the 500 Metres.

Jockey Antony Raj S., the rider of FIND was fined Rs.2,000/- for shifting out and taking out COSMIC FEELING (Nazerul Alam) on his outside passing the 200 Metres.

Jockey Nazerul Alam, the rider of COSMIC FEELING placed 2nd by the judge objected against Jockey Antony Raj S., the rider of FIND placed 1st for "After 550 Metres I received a check from the winner which forced me to shift on the outside of the winner and when I was making my final spurt to win the race Jockey Antony Raj.S has lost control on his mount and in the process taken me out which cost me a certain race". The Stewards held an enquiry immediately after the race and interviewed the Jockeys concerned. After deliberations, they decided to overrule the objection.

An enquiry is being held into the running and riding of STROKE OF GENIUS, trained by Mr. Neil B Devaney and ridden by Jockey Naveen .M in the above race.

STROKE OF GENIUS (Naveen M.) was impounded for veterinary examination but no abnormality was reported.

Surprise sample was taken for analysis from dk b c STROKE OF GENIUS.

Routine Sample was taken for analysis from the winner dk b g FIND.
