# BANGALORE SUMMER MEETING 2019 TWENTSECOND DAY, SUNDAY, 28<sup>™</sup> JULY, 2019 RACING INCIDENTS (150 - 156)

**GOING:** Good

PENETROMETER READING: 3.4 Cms.

RAILING POSITION: Railing fixed at its original position.

<u>1<sup>st</sup> Race: 150. The Manitou Plate - (About) 1400 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible). (8 Runners).</u>

It was observed that Jockey Antony Raj S., the rider of CAVALIERE accidentally lost his right rein passing the 200 Metres, which he regained within a few strides.

Routine Sample was taken for analysis from the winner dk b g TENNO SHO.

### 2<sup>nd</sup> Race: 151. The Lively Emprey Plate - (About) 1200 metres. Horses rated 00 to 20 (13 Runners).

Permission was granted to Trainer Mr. Sharat Kumar to withdraw ASTRON on veterinary grounds as it was found to have burst its blood vessels (during Morning track work). He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was observed that DARAHASINI (S. John) accidentally struck the front runner SMILE OF COURAGE (Naveen M.) passing the 1100 Metres, thereafter SMILE OF COURAGE ran detached from the field. The horse was subjected to veterinary examination. On examination, it was found to have pulled up lame on right hind due to deep severe bleeding injury on back of mid third cannon. Trainer Mr. Samar Singh was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Mohd Asif Khan, the rider of MAJESTIC RAJKUMARI was fined Rs.3,000/- for the excessive use of whip on his mount during the race (1st infringement).

Jockey Mohd Asif Khan, the rider of MAJESTIC RAJKUMARI was fined Rs.2,000/- for the improper use of whip on his mount during the race.

Jockey A.Imran Khan, the rider of DEBONAIR was reprimanded for dropping hands in the final 75 Metres of the race.

Routine Sample was taken for analysis from the winner ch f ARROGANCE.

#### <u>3<sup>rd</sup> Race: 152. The Marilingaiah Memorial Trophy - (About) 1200 metres.</u> Horses rated 45 to 65 (14 Runners).

Jockey Adarsh. G replaced the indisposed Jockey M. Prabhakaran on SIYOUNI.

Jockey Chethan Gowda, the rider of SIDE WINDER was fined Rs.3,000/- for shifting 'in' and causing interference to the horses on his inside viz; TREASURE DELIGHT (Suraj Narredu) and MINIVER ROSE (R. Vaibhav) approaching 900 Metres.

Jockey P. Trevor, the rider of CONSTANTINOPLE reported that he could not ride from the desired position due to closely packed field from 1100 Metres to 1000 Metres.

Jockey R. Vaibhav, the rider of MINIVER ROSE was fined Rs.2,000/- for dropping hands in the final 200 Metres of the race.

Routine Sample was taken for analysis from the winner b g LIFE AWAITS.

## 4th Race: 153. The Tetrasoft Inc. Bangalore St. Leger(Grade II) - (About) 2800 metres. Indian Horses 4 years old and over (Foaled in 2015 or before). (6 Runners).

Jockey A. Sandesh, the rider of DESERT GOD was reprimanded for shifting 'in' and inconveniencing the horses on his inside viz; REUNION (Yash Narredu) and SALAZAAR (Suraj Narredu) soon after the start.

Jockey Suraj Narredu, the rider of SALAZAAR reported that his mount accidentally stumbled at 1400 Metres and 800 Metres.

Compulsory samples were taken for analysis from the following I,II & III placed horses viz:

b g POINT TO PROVE III

## 5<sup>th</sup> Race: 154. The Smart Chieftan Cup - Div. I - (About) 1200 metres. Horses rated 30 to 50, 4 years old and over (10 Runners).

SECRETSUPERSTAR (Manish R) was extremely fractious, reared up, flipped over, sat down for a considerable period of time, dislodged its rider and ran riderless. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

EMIDIO (R. Vaibhav) jumped out awkwardly.

TARINI (Yash Narredu) reared up while jumping out.

It was observed that Jockey K. Sai Kiran, the rider of CALL ME MAYBE had to steady his mount passing the 700 Metres.

It was reported after the race CALL ME MAYBE (K. Sai Kiran) pulled up lame on right fore. Trainer Mr. Imtiaz Khan was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b f ANGELS KISS.

### 6th Race: 155. The Allied Forces Plate - (About) 1100 metres. Horses rated 15 to 35, 4 years old and over (11 Runners).

Permission was granted to Trainer Mr.Imtiaz Khan to withdraw NAWABZAADI (K. Sai Kiran) on veterinary grounds as it was found to be lame on right fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was observed that HAPPY DANCING (M. Kumar) jumped awkwardly outwards and inconvenienced the horses on its outside viz; FANTASTIC APP (S. Zervan) and QUEEN ISABELLA (Nazerul Alam) soon after the start, as a result Jockey M. Kumar lost both his stirrup irons which regained passing the 500 Metres.

Jockey Nazerul Alam, the rider of QUEEN ISABELLA reported that his mount was hanging out badly after entering the straight despite his best efforts to keep it on an even course. The horse was subjected to veterinary examination. On examination, it was found to have pulled up lame on right fore. Trainer Mr. Faraz Arshad was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

HAFNIUM (Arshad Alam) was subjected to veterinary examination but no abnormality was reported.

It was reported after the race that SO QUICK (Darshan R.N) pulled up lame on left fore. Trainer Mr. S. Narredu was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

An enquiry is being held into the running of PRINCESS HOLLY (Raghu.K) in the above race as compared to its previous run in Race No. 132 i.e., The Chennai Cup - Div. I - (About) 1100 metres. Horses rated 15 to 35, 4 years old and over run on Saturday,  $20^{\text{th}}$  July, 2019 when it ran unplaced, trained by Mr. V. Narayana Gowda.

Routine Sample was taken for analysis from the winner dk b m PRINCESS HOLLY.

### 7<sup>th</sup> Race: 156. The Smart Chieftan Cup - Div. II - (About) 1200 metres. Horses rated 30 to 50, 4 years old and over (11 Runners).

Jockey Kiran Rai P replaced the indisposed Jockey A.R. Pradeep on DEPTH CHARGE.

Jockey S. Zervan, the rider of HELENKA was fined Rs.5,000/- for the excessive use of whip on his mount during the race (2nd infringement).

Jockey S. Zervan, the rider of HELENKA was fined Rs.2,000/- for the improper use of whip on his mount during the race.

BEOND REACH (Naveen M.) ran detached from the field. Trainer Mr. K.P.G Appu was informed to ensure better performance of his charge in future.

Routine Sample was taken for analysis from the winner b g DEPTH CHARGE.

Permission was granted to trainer Mr. Arjun Mangalorkar to deputize on behalf of

trainer Mr. S.S.Attaollahi who was unable to attend the races.
