RACING INCIDENTS
(108 – 114)

GOING : Good

PENETROMETER READING: 3.0 Cms.

RAILING POSITION: Railing fixed at average width of 8.5 Meters from 1600 Meters to winning post from its original position.

1st Race: 108. The Snow Dew Plate - (About) 1600 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible). (8 Runners).

Jockey A. Sandesh, the rider of ROMAN SENATOR was fined Rs.5,000/- for the excessive and extravagant use of whip on his mount during the race (1st infringement).

SILVER ECLIPSE (Rayan Ahmed R.) ran detached after rounding the final bend. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. S. Dominic was informed to ensure better performance of his charge in future.

STREAMING GOLD (Neeraj Rawal) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b c ROMAN SENATOR.

2nd Race: 109. The Ramkirpal Plate - (About) 1100 metres. Horses rated 00 to 20 (9 Runners).

Trainer Mr. Neil Darashah was fined Rs.10,000/- for having accepted his charge DONTBREAKTHERULES (Shamaz Shareef) when it was under B.T.F. BAN. Subsequently, permission was granted to him to withdraw the horse from the above race.

MAJESTIC HEROINE (Nazerul Alam) was examined at the starting gates by the Club's Veterinary Officer and was found to be trotting lame on right fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. Praveen Jesu was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

SONG AND DANCE (M. Noornabi) took a fly jump.

MAGNITUDE QUEEN (N. B. Kuldeep) was slowly away, did not raise a fluent gallop at any point in the race and pulled up in the final 100 Metres. On examination, it was found to be lame on right hind. Trainer Mr. Sharat Kumar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

TUDOR PRINCE (Ashok Kumar A.) was subjected to veterinary examination but no abnormality was reported.

PRIME STAR (Tauseef Ahmed) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner ch m SCARLET PRINCESS.

3rd Race: 110. The D. M. Shivaswamy Memorial Trophy - (About) 1400 metres. Horses rated 45 to 65 (7 Runners).

Permission was granted to Trainer Mr. Neil Darashah to withdraw NEW MOON (Arshad Alam) on veterinary grounds as it was found to be lame on left hind. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Harish B replaced the indisposed Jockey Aryn Merchant on ATTORNEY GENERAL.

ATTORNEY GENERAL (Harish B.) accidentally brushed the running rails passing the 1000 Metres.

Routine Sample was taken for analysis from the winner b g AEOLUS.

4th Race: 111. The Chief Minister's Cup (Grade III) - (About) 1200 metres. 4 years old and over. (12 Runners).

SMILE STONE (Irvan Singh) reared up as the gates opened and lost few lengths at the start. In view of its behaviour, Trainer Mr. Sharat Kumar was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

It was reported after the race that CAVALLO VELOCE (A. Imran Khan) pulled up lame on left fore. Trainer Mr. B. Suresh was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

INTO THE SPOTLIGHT (A. Sandesh) was subjected to veterinary examination. On examination, it was found to have burst its blood vessels. Trainer Mr. S. Padmanabhan was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Compulsory samples were taken for analysis from the following I, II & III placed horses viz:

5th Race: 112. The Basque Plate - Div. I - (About) 1400 metres. Horses rated 30 to 50, 4 years old and over (10 Runners).

Jockey S. Zervan, the rider of MYSTIC FLAME was fined Rs.2,000/- for shifting out under the use of whip and taking out GERONTOCRAT (S. John) on his outside in the final 75 Metres.

Trainer Mr. Narayana Gowda.V and Jockey Rajesh Kumar. M were questioned regarding running and riding of LAND OF LIBERTY. The trainer stated that he had instructed the Jockey to ride from 2nd/3rd/4th position and do his best in the straight. However, after viewing the CCTV replay of the

race he was of the opinion that the Jockey should have allowed his mount to go to the front and then settled it in 2nd/3rd /4th position as the horse always runs from a forward position and it had won from a forward position and also finished 2nd. The Jockey while corroborating the statement of the trainer was severely cautioned to be more careful and adhere to the trainers instructions in future.

LAND OF LIBERTY (Rajesh Kumar M) was subjected to veterinary examination but no abnormality was reported.

Surprise sample was taken for analysis from b c GERONTOCRAT.

Surprise sample was taken for analysis from dk b f BLACK WHIZZ.

Routine Sample was taken for analysis from the winner ch f SAHARA.

6th Race: 113. The Pendragon Plate - (About) 1600 metres. Horses rated 15 to 35, 4 years old and over (9 Runners).

Jockey Arshad Alam replaced the indisposed Jockey Yash Narredu on RADIANT TREASURE.

Jockey K. Raja Rao replaced the indisposed Jockey Aryn Merchant on INDIAN BRAHMOS.

ARMENIA (Suraj Narredu) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. S. Narredu was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey A. Sandesh, the rider of EKALAVYA was fined Rs.1,000/- for shifting out under the use of whip and taking out the horses on his outside viz; ULTIMATE POWER (Darshan R.N) and ARMENIA (Suraj Narredu) passing the 800 Metres.

OCEAN PARK (S.A. Amit) was subjected to veterinary examination but no abnormality was reported.

INDIAN BRAHMOS (K. Raja Rao) was subjected to veterinary examination but no abnormality was reported.

MARIACHI (T. S. Jodha) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner dk b g MARCO POLO.

7th Race: 114. The Basque Plate - Div. II - (About) 1400 metres. Horses rated 30 to 50, 4 years old and over (10 Runners).

Jockey P. Mani replaced the indisposed Jockey Aryn Merchant on BEOND REACH.

BEOND REACH (P. Mani) jumped awkwardly outwards and inconvenienced MAHANATI (Vinod Shinde) and QUICK ACTION (Naveen M.) on its outside soon after the start.

An enquiry is being held into the running and riding of PANAMA, trained by Mr. Nityanand G. and ridden by Jockey Arshad Alam in the above race.

WINNING HEART (S. Zervan) was impounded for veterinary examination. On examination, it was found to have burst its blood vessels (Endoscopy Grade – IV). Trainer Mrs. Parvati Byramji was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

PANAMA (Arshad Alam) was subjected to veterinary examination but no abnormality was reported.

Surprise sample was taken for analysis from dk b g WINNING HEART.

Routine Sample was taken for analysis from the winner b g BOLD MOVE.
