1st Race: 157. The August Plate - (About) 1100 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible). (8 Runners).

KNOTTY OAK (Antony Raj S.) stood flat footed and lost many lengths at the start. In view of its behaviour, Trainer Mr. Praveen Jesu (deputizing on behalf of Trainer Mr. Prasanna Kumar) was informed that he must not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey S. Zervan, the rider of WILL TO WIN was fined Rs.3,000/- for shifting 'in' and causing interference to the horses on his inside viz; ALTAIR (Irvan Singh) and COUNTRY'S JEWEL (Shelar R.) before passing the red marker post.

Jockey Arshad Alam, the rider of SANDARINA was fined Rs. 2,000/- for shifting out and taking out WILL TO WIN (S. Zervan) on his outside passing the 600 Metres.

DONNA BELLA (Suraj Narredu) sustained bleeding injury on right fore cannon.

WILL TO WIN (S. Zervan) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner dk b f DONNA BELLA.

2nd Race: 158. The Commanche Plate - Div. II - (About) 1400 metres. Horses rated 00 to 20, 5 years old and over (8 Runners).

Jockey Manish R replaced the indisposed Jockey Nazerul Alam on NOBLE SPLENDOR.

BAROG (Irvan Singh) was examined by the Club's Veterinary Officer before the start of the race, was found to be trotting lame on left fore and also the left fore clip of shoe had broken. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. Sharat Kumar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

STRING OF PEARLS (Rayan Ahmed R.) was examined at the starting gate by the Club's Veterinary Officer and was found to be trotting lame on right fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr.Hidayat Khan was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

NOBLE SPLENDOR (Manish .R) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Faraz Arshad was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey T. S. Jodha, the rider of WINX was reprimanded for shifting out and inconveniencing RACY PRINCESS (Amyn Merchant) on his outside passing the 300 Metres.

Routine Sample was taken for analysis from the winner dk b g WINX.

3rd Race: 159. The Lt. Col. Gaunt Memorial Trophy - (About) 1600 metres. Horses rated 45 to 65, 5 years old and over (12 Runners).

It was observed that Jockey Darshan R.N, the rider of STRIKING GREY, Jockey T. S. Jodha, the rider of STAR CRACKER and Jockey Irvan Singh, the rider of STARRY WIND had to steady their respective mounts due to a closely packed field passing the 1000 Metres.

Jockey T. S. Jodha, the rider of STAR CRACKER was reprimanded for travelling wide rounding the final bend for no apparent reason.

Jockey Chethan Gowda, the rider of SUPER SMART was fined Rs.1,000/- for shifting 'in' and causing interference to GOOD TIME INDEED (P. Trevor) on his inside passing the 250 Metres.

Jockey Arshad Alam, the rider of MASADA was reprimanded for shifting out and inconveniencing GYPSY (Suraj Narredu) on his outside passing the 200 Metres.

Jockey Irvan Singh, the rider of STARRY WIND reported that his mount was hanging out after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. Trainer Mr. Darius R. Byramji was informed to take appropriate corrective measures before accepting with it again.

STAR CRACKER (T. S. Jodha) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner gr g STRIKING GREY.

4th Race: 160. The Bangalore City Sprint Championship Gold Cup(Grade III) - (About) 1200 metres. 3 years old and over. (7 Runners).

Compulsory samples were taken for analysis from the following I,II & III placed horses viz:

5th Race: 161. The Karnataka Sub-Area Cup - (About) 1400 metres. Horses rated 60 and above (10 Runners).

HAEDI'S FOLLY (Irvan Singh) was extremely fractious at the starting gates and refused to be stalled. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

CASTAWAY (S. Zervan) was subjected to veterinary examination but no abnormality was reported.

SNOWDON (A. Sandesh) was subjected to veterinary examination but no abnormality was reported.

REGAL MUSIC (R. Vaibhav) was subjected to veterinary examination but no abnormality was reported.

INTO THE GROOVE (Suraj Narredu) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f SHESMYSCRIPT.

6th Race: 162. The Kunigal Stud Plate - (About) 1400 metres. Horses rated 30 to 50, 4 years old and over (10 Runners).

BERNARDINI (Suraj Narredu) reared up, flipped over at the starting gates and the bridle had come off. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

AMAZING SKILL (M. Mark) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Rajesh Narredu (deputizing on behalf of trainer Mr. S. Narredu) was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

COLONEL HARTY (Rajesh Kumar M) accidentally stumbled passing the 850 Metres.

An enquiry is being held into running and riding of COLONEL HARTY, trained by Mr. Narayana Gowda. V and ridden by Jockey Rajesh Kumar. M in the above race.

COLONEL HARTY (Rajesh Kumar M) was impounded for veterinary examination. On examination, it was found to have sharp molars on left side. Trainer Mr. Narayana Gowda. V was fined Rs.3,000/- for his negligence (1^{st} infringement).

COLONEL HARTY (Rajesh Kumar M) sustained clipped injury on right fore bulb of heel.

Surprise sample was taken for analysis from b g COLONEL HARTY.

Routine Sample was taken for analysis from the winner b c KERAZANO.

7th Race: 163. The Commanche Plate - Div. I - (About) 1400 metres. Horses rated 00 to 20, 5 years old and over (10 Runners).

Jockey Ravi R., the rider of ONLY PRINCE was fined Rs.1,000/- for shifting out and taking out BRAVADO (Amyn Merchant) on his outside passing the 900 Metres.

Jockey T. S. Jodha, the rider of INDIAN BRAHMOS was fined Rs.5,000/- for not making sufficient effort on his mount during the race.

Jockey Chethan Gowda, the rider of ABOVE THE REST reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination. On examination, it was found to have pulled up lame on right fore. Trainer Mr.V. Lokanath was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that SEABORN (Rayan Ahmed R.) burst its blood vessels (Endoscopy - Grade IV). Trainer Mr.Sriram Komandur was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that BRAVADO (Amyn Merchant) burst its blood vessels. Trainer Mr.S. Inayathulla was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

FIRST STEP (S. John) sustained bleeding injury on right fore cannon.

Routine Sample was taken for analysis from the winner b g GOOD WORD.

Permission was granted to trainers M/s. Praveen Jeseu and Rajesh Narredu to deputize on behalf of trainers M/s. Prasanna Kumar.P and S. Narredu who were unable to attend the races.
