TWENTYFOURTH DAY, FRIDAY , 2ND AUGUST, 2019
RACING INCIDENTS
(164 – 170)

GOING : Good

PENETROMETER READING: 3.0 Cms

RAILING POSITION: Railing fixed at average width of 8.5 Meters from 1600 Meters to winning post from its original position.

1st Race: 164. The Track Lightning Stakes - (About) 1200 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible). (8 Runners).

FLAMBOYANT (M. Mark) was slowly away, lost many lengths, did not raise a fluent gallop and ran detached thereafter. In view of its behaviour, Trainer Mr. Rajesh Narredu (deputizing on behalf of Trainer Mr. S. Narredu) was informed that he must not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least two Mock Races.

SKY MOON (V.R.Jagadeesh) was slowly away, lost many lengths and ran detached. In view of its behaviour, Trainer Mr. S. Inayathulla was informed that he must not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

JAN ZIZKA (A. Sandesh) jumped out awkwardly.

Jockey Vinod Shinde, the rider of SUN SPLASH was reprimanded for shifting out and inconveniencing the horses on his outside viz; DESERT COMBAT (Naveen M.) and BOSTONIA (P. Trevor) passing the 600 Metres.

Jockey S. Zervan, the rider of SILVER SWIFT reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. S. Dominic was informed to take appropriate corrective measures before accepting with it again.

Routine Sample was taken for analysis from the winner dk b f PALM READER.

2nd Race: 165. The Bold Gesture Plate - (About) 1100 metres. Horses rated 00 to 20 (Whips not allowed) (8 Runners).

ODYSSEY (M. Kumar) jumped awkwardly outwards, bumped KRUGER PARK (Shamaz Shareef) soon after the start and dislodged its rider.

It was observed that ADMIRABLE (Irvan Singh) accidentally brushed the running rails passing the 900 Metres.

HIMACHALI (P. Trevor) was impounded for veterinary examination. On examination, it was found to have burst its blood vessels (Endoscopy Grade - III). Trainer Mr. Neil B Devaney was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Surprise sample was taken for analysis from gr f HIMACHALI.

Routine Sample was taken for analysis from the winner b m AEROSPEED.

3rd Race: 166. The Treasure Girl Plate - (About) 1200 metres. Horses rated 15 to 35, 4 years old and over (12 Runners).

Jockey Antony Raj .S, the rider of FICTIONEER was fined Rs.3,000/- for the excessive use of whip on his mount during the race (1st infringement).

Jockey Antony Raj .S, the rider of FICTIONEER was fined Rs.2,000/- for the improper use of whip on his mount during the race.

An enquiry is being held into the running and riding of TIGER RETURNS, trained by Mr. Prithviraj. B and ridden by Jockey Manish. R in the above race.

It was reported after the race that CHARMAINE (P. Trevor) burst its blood vessels. Trainer Mr. Nityanand G. was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

PRIME STAR (Prashant P.Dhebe) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner dk b g FICTIONEER.

4th Race: 167. The Karnataka Mile Championship Cup(Grade II) - (About) 1600 metres. 4 years old and over. (4 Runners).

Compulsory samples were taken for analysis from the following I,II & III placed horses viz:

b g BIG SUR I

b c PSYCHIC FORCE II

gr f SAKURA III

5th Race: 168. The Jayant Shah Memorial Trophy - (About) 1800 metres. Horses rated 45 to 65 (6 Runners).

HERE AND NOW (Arshad Alam) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.Neil Darashah was informed that he must not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race and also two jump outs on a starting gate practice day.

Routine Sample was taken for analysis from the winner b g COSMOS.

6th Race: 169. The Southern Regent Plate - (About) 1400 metres. Horses rated 30 to 50 (8 Runners).

Jockey Suraj Narredu replaced the indisposed Jockey A. Imran Khan on EXCLUSIVE MANDATE.

REFERENCE (Arshad Alam) jumped out awkwardly, unbalancing the rider and lost many lengths at the start. In view of its behaviour, Trainer Mr. R. V. Manohar was informed that he must not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Antony Raj S., the rider of WINALL was reprimanded for shifting 'in' and inconveniencing CUBAN (P. Trevor) on his inside soon after the start.

Jockey Suraj Narredu, the rider of EXCLUSIVE MANDATE reported that his mount was hanging out very badly as such he could not ride out his mount in the final 200 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey Chethan Gowda, the rider of ORENDA was reprimanded for dropping hands before passing the winning post.

REFERENCE (Arshad Alam) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f AKITA PRO.

7th Race: 170. The Epsom Plate - (About) 1200 metres. Horses rated 15 to 35 (8 Runners).

Jockey Manish R replaced the indisposed Jockey Nazerul Alam on RED INDIAN.

SIR PIGGOT (S. Zervan) jumped awkwardly outwards and inconvenienced PAPADOKIA (K. Sai Kiran) soon after the start.

It was observed that SILENT GUARDIAN (Chethan Gowda) pulled up approaching the 700 Metres, as a result NO OPINION (Raghu K) and SLOVENIA (Prashant P.Dhebe) travelling directly behind had to be checked by their respective riders and shift out. On immediate examination by the Club's Veterinary Officer, it was found to have pulled up lame on left fore. Trainer Mr. Neil Darashah was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner ch g RED INDIAN.

Permission was granted to trainers M/s. Praveen Jesu and Rajesh Narredu to deputize on behalf of trainers M/s. Prasanna Kumar. P and S. Narredu who were unable to attend the races.

ADDITIONAL REPORTS

BANGALORE SUMMER MEETING 2019 **TENTH DAY , SUNDAY , 16TH JUNE ,2019**

Race: 65. The Aboline Plate - (About) 1100 metres. Horses rated 15 to 35.

An enquiry was held into the running and riding of ANDRA KING, trained by Mr. Pradeep Annaiah and ridden by Jockey Surya. P in the above race. The Stipendiary Stewards held an enquiry and interviewed trainer Mr. Pradeep Annaiah and Jockey Surya. P. After deliberations, the Stipendiary Stewards decided to fine Jockey Surya. P a sum of Rs.3,000/- for not sufficiently persevering with his mount in the final 300 Metres.

THIRTEENTH DAY , SATURDAY , 29TH JUNE ,2019

(A)

Race: 89. The Chief Justice's Cup (Grade III) - (About) 1800 metres. 4 years old and over.

An enquiry was held on 2nd July, 2019 by the Stipendiary Stewards for the above race into the interference caused by Jockey Suraj Narredu on his mount ADJUDICATE in that he shifted 'in' and caused interference to DESERT GOD (A. Sandesh), which in turn passed it onto ROBERTA (N. S. Parmar) and NEW CREATION (Neeraj Rawal) along the rails rounding the final bend.

Jockey Suraj Narredu was interviewed by the Stipendiary Stewards. The Stipendiary Stewards after considering the submissions made by Jockey Suraj Narredu and after viewing the CCTV decided to charge Jockey Suraj Narredu for careless riding Rule No. 161 (i) of the BTC Rules of Racing.

The Stipendiary Stewards thereafter suspended Jockey Suraj Narredu on 13th July, 2019 and fined him a sum of Rs.25,000/- as he had pleaded guilty of the charge under Rule No. 161 (i) of the BTC Rules of Racing for Careless Riding on his mount ADJUDICATE (he is permitted to ride work and was informed of his right to appeal).

(B)

Race: 92. The Young Rajput Plate - (About) 1400 metres. Horses rated 15 to 35, 4 years old and over.

An enquiry was held into the running and riding of DUXTON, trained by Mr. V. Lokanath and ridden by Jockey Darshan R.N in the above race. The Stipendiary Stewards held an enquiry and interviewed trainer Mr. V. Lokanath and Jockey Darshan R.N. After deliberations, the Stipendiary Stewards decided to fine Jockey Darshan R.N a sum of Rs.5,000/- for not making sufficient effort on his mount during the race.

FOURTEENTH DAY , SUNDAY , 30TH JUNE ,2019

Race: 99. The Racing Patrons Trophy - (About) 1600 metres. Horses rated 75 and above.

An enquiry was held into the reversal of form of AUTOMATIC in the above race as compared its previous run in Race No.67 i.e., The Mayor's Cup (about) 1600 Metres, Horses rated 60 and above trained by Mr. Irfan Ghatala. The Stipendiary Stewards held an enquiry on Friday, 2nd August, 2019 and interviewed trainer Mr. Irfan Ghatala. After due enquiry, the Stipendiary Stewards fined trainer Mr. Irfan Ghatala a sum of Rs.10,000/- for the reversal of form of AUTOMATIC in the above race as compared its previous run in Race No.67 i.e., The Mayor's Cup (about) 1600 Metres, Horses rated 60 and above run on Sunday, 16th June, 2019.

NINETEENTH DAY , SATURDAY , 20TH JULY, 2019

Race: 127. The Delhi Cup - Div. II - (About) 1400 metres. Horses rated 00 to 20.

An enquiry was held into the running and riding of JERSEY STORM, trained by Mr. Azhar Ali and ridden by Jockey Chetan Kalay .S in the above race. The Stipendiary Stewards held an enquiry on Saturday, 3rd August, 2019 and interviewed trainer Mr. Azhar Ali and Jockey Chetan Kalay.S. The trainer stated that:

(a) His charge was a very difficult horse to train because of its erratic behaviour during the morning track work as it refuses to canter or do a fast work but had settled very well with Jockey Chetan Kalay.S;

(b) His charge has a tendency to run out in the race particularly between the 1000 Metres till the 500 Metres as such he had used the Cross Nose Band to correct it;

(c) He had instructed the rider to ride from 4th / 5th position and do his best in the straight. However his charge did not jump level as such the rider could not obtain the desired position and;

(d) He also added that he would change the training pattern of his charge and his explanations were noted for future reference.

The Jockey corroborated the statement of the Trainer, while noting the explanations of the Jockey, the Stipendiary Stewards fined Jockey Chetan Kalay.S a sum of Rs.3,000/- for not persevering with his mount from 500 Metres till about 300 Metres and also for not reporting the matter of his mount hanging out during the race immediately after the race to the Stipendiary Stewards.

TWENTIETH DAY , SUNDAY , 21ST JULY, 2019

Race: 143. The Hyderabad Cup - Div. II - (About) 1400 metres. Horses rated 15 to 35.

An enquiry was held into the running and riding of STROKE OF GENIUS, trained by Mr. Neil B Devaney and ridden by Jockey Naveen .M in the above race. The Stipendiary Stewards held an enquiry on Saturday, 3rd August, 2019 and interviewed trainer Mr. Neil B Devaney. The trainer stated that:

(a) He had taken over this horse from trainer Mr. Prithviraj.B and it was only its second run with him after it placed 3rd in Race No. 94 of BSM-2019;

(b) He had instructed the Jockey to ride from a 2nd /3rd position (well up) as it was a 1400 Metres race and do his best in the straight;

(c) He had fancied his charge to win the race as it had run 3rd in its previous outing;

(d) He also added that when it ran a 3rd it was a firm going and on this particular day, it had rained heavily and the underfoot conditions did not suit his charge and;

(e) His Jockey was riding out from the start but his charge did not gallop and he also added that he would use a pair of blinkers on the starting gate practice day, if he would be totally satisfied he would use it in the race.

His explanations were noted for future reference.
