Race: 176. The Bangalore Summer Million (Grade III) - (About) 1600 metres. 3-year-old horses (foaled in 2016). (6 Runners).

The above race was postponed from Thursday, 8th August, 2019 to Friday, 9th August, 2019 at 1:00 P.M.

Compulsory samples were taken for analysis from the following I,II & III placed horses viz:

ch f ICE FLOE	III

GLORIOUS DANCER (V.R.Jagadeesh) ran detached after rounding the final bend. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. V. Lokanath was informed to ensure better performance of his charge in future.

1st Race: 180. The Leading Tipster Cup - (About) 1600 metres. Horses rated 00 to 20 (12 Runners).

GREY CHANNEL (Chethan Gowda) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.S. Inayathulla was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey A.R.Pradeep, the rider of JERSEY STORM was reprimanded for travelling wide from 700 Metres till rounding the final bend for no apparent reason.

Jockey Manish .R, the rider of NATALIE reported that his mount was not galloping fluently after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey A.R.Pradeep, the rider of JERSEY STORM was fined Rs.5,000/- for the excessive use of whip on his mount during the race (2nd infringement).

Routine Sample was taken for analysis from the winner b g GREAT CELEBRATION.

2nd Race: 181. The Champion Trainer Cup - (About) 1200 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible). (11 Runners).

Permission was granted to Trainer Mr. Neil B Devaney to withdraw DEFINITIVE (Naveen M.) on veterinary grounds as it was found to be trotting short on both fore due to tendon problem. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

CAESARS PALACE (M. Mark) jumped out awkwardly.

It was observed that AKASI (Shelar R.) was inclined to run out between 800 Metres and 600 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

It was observed that HEAVENLY ANGEL (Darshan R.N) was inclined to run out between 800 Metres and 600 Metres.

DARING PRINCE (P. Trevor) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g JERSEY LEGEND.

3rd Race: 182. The Champion Jockey Cup - Div. I - (About) 1200 metres. Horses rated 15 to 35 (10 Runners).

Permission was granted to Trainer Mr. Dheeraj.V to withdraw GOLD MIST (Chethan Gowda) on veterinary grounds as it was found to be lame on right hind due to swelling of tendon on back of cannon. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Permission was granted to Trainer Mr. Rajesh Narredu to withdraw SLOVENIA (Manish R) on veterinary grounds as it was found to be lame on right fore due to capped elbow with regional and tendon swelling. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Md.Akram, the rider of MISCHIEF FLYER was reprimanded for riding an indifferent race.

AQABA (IndraJeet Singh) ran detached from the field. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Neil B. Devaney (deputizing on behalf of Trainer Mr. S.S. Attaollahi) was informed to ensure better performance of his charge in future.

Routine Sample was taken for analysis from the winner b g ULTIMATE SPEED.

4th Race: 183. The Governor's Cup (Grade III) - (About) 2400 metres. 4 years old and over. (7 Runners).

ROBERTA (P. Trevor) was subjected to veterinary examination. On examination, it was found to have pulled up lame on right fore. Trainer Mr. P. Shroff was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that ISN'T SHE LOVELY (A. Sandesh) burst its blood vessels. Trainer Mr. S. Padmanabhan was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Compulsory samples were taken for analysis from the following I,II & III placed horses viz:

5th Race: 184. The Leading Owner Cup - (About) 1400 metres. Horses rated 45 to 65 (12 Runners).

It was observed that COMMODUS (P. Trevor) was inconvenienced soon after the start by ATTORNEY GENERAL (Abyn Merchant).

Jockey A. Sandesh, the rider of CADILLAC was reprimanded for shifting out and inconveniencing TREASURE DELIGHT (Suraj Narredu) on his outside passing the 750 Metres.

It was observed that COMMODUS (P. Trevor) could not get a clear run between the 550 Metres and 500 Metres due to closely packed field.

Jockey P. Trevor, the rider of COMMODUS was fined Rs.5,000/- for the excessive use of whip on his mount during the race (2nd infringement).

It was reported after the race that TEODORO (Shamaz Shareef) burst its blood vessels (Endoscopy - Grade IV). Trainer Mr.Irfan Ghatala was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g TREASURE DELIGHT.

6th Race: 185. The Leading Stud Cup - (About) 1400 metres. Horses rated 75 and above (10 Runners).

TOROSSO (Shamaz Shareef) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Irfan Ghatala was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey S. Zervan, the rider of AEOLUS reported that his mount was lugging 'in' under pressure in the final 200 Metres.

It was reported after the race that THE CHAMP (Chethan Gowda) burst its blood vessels. Trainer Mr.Faraz Arshad was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

PELUCHE (P. Trevor) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g AEOLUS.

7th Race: 186. The Leading Bookmaker Cup - (About) 1600 metres. Horses rated 30 to 50, 4 years old and over (12 Runners).

Jockey Akshay Kumar, the rider of CHARMED LIFE reported that his mount was not striding out after rounding the final bend. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey A. Sandesh, the rider of FOI ET AMOUR was fined Rs.2,000/- for coming 'in' and causing interference to PRINCE CHARMO (Chethan Gowda) on his inside in the final 250 Metres.

BACK OF BEYOND (Tauseef Ahmed) was subjected to veterinary examination. On examination, it was found to have pulled up lame on right fore. Trainer Mr. Praveen Jesu was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g BERNARDINI.

8th Race: 187. The Independence Plate - (About) 1400 metres. Horses rated 15 to 35, 5 years old and over (12 Runners).

Jockey G Sai Vamshi, the rider of AFTER HOURS was fined Rs.2,000/- for shifting 'in' and causing interference to the horses on his inside viz; HALFSIES (Naveen M.), FIORENZO (Vinod Shinde) and FIND (Antony Raj S.) soon after the start.

FIORENZO (Vinod Shinde) ran detached from the field. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Irfan Ghatala was informed to ensure better performance of his charge in future.

Routine Sample was taken for analysis from the winner b m AFTER HOURS.

9th Race: 188. The Champion Jockey Cup - Div. II - (About) 1200 metres. Horses rated 15 to 35 (10 Runners).

Permission was granted to Trainer Mr.Kishan Thomas to withdraw CAPSTONE (Kiran Rai P) on veterinary grounds as it was found to be lame on right hind. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

LIGHTNING ATTACK (Chethan Gowda) was extremely fractious, reared up and sat down. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

Jockey Darshan R.N, the rider of SUN POWER was fined Rs.3,000/- for the excessive use of whip on his mount during the race (1st infringement).

Jockey Darshan R.N, the rider of SUN POWER was fined Rs.2,000/- for the improper use of whip on his mount during the race.

Jockey Raghu K, the rider of ARECA ANGEL was fined Rs.2,000/- for not sufficiently persevering with his mount in the final 200 Metres of the race.

It was reported after the race that PERFECT KING (Irvan Singh) pulled up lame on right fore. Trainer Mr. Sharat Kumar was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner ch g SUN POWER.

Permission was granted to trainers M/s. Neil B Devaney, S. Narredu and Aravind. G to deputize on behalf of trainers M/s. S.S. Attaollahi, Rajesh Narredu and S. Ganapathy who were unable to attend the races.
