# **RAILING POSITION : Railing fixed at average width of 4.0 Meters from 1600 Meters to winning post from its original position.**

# <u>1<sup>st</sup> Race: 1. The Accueillir Plate - (About) 1200 metres. Horses rated</u> <u>00 to 20 (12 Runners).</u>

CAPABLE (Naveen M) after jumping out swerved towards the left inconvenienced SIZZLER (Bhawani Singh) on his outside and then went onto the sand track, therefore did not take any practical part in the race. In view of its behaviour, Trainer Mr. Sharat Kumar was informed not accept with it again until its behaviour has improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

BAHURUPAH (Chethan Gowda) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Warren Singh was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey P. Ramesh, the rider of DREAM CHASER was reprimanded for shifting out and taking out MARVELLOUS MAGGI (Darshan R.N) on his outside passing the 1000 Metres.

Jockey IndraJeet Singh, the rider of ICONIC PRINCESS was reprimanded for shifting 'in' and tightening INDIAN STAR (A.Imran Khan), which in turn passed it onto CHALLENGING STAR (Nazerul Alam) on his inside approaching 900 Metres.

Jockey IndraJeet Singh, the rider of ICONIC PRINCESS reported that he lost his left stirrup passing the 150 Metres, which he regained in the final 50 Metres.

An enquiry was held by the Stipendiary Stewards on 8<sup>th</sup> August, 2021 into the running and riding of DREAM CHASER, trained by Mr.Prithviraj. B and ridden by Jockey P. Ramesh in the above race. After due enquiry and watching the previous races of the horse and keeping all circumstances in mind, Trainer Mr.Prithviraj. B and Jockey P. Ramesh were fined Rs.10,000/respectively for the unsatisfactory running and riding of DREAM CHASER.

SONG AND DANCE (M. Mark) sustained puncture wound on left side cannon.

Routine Sample was taken for analysis from the winner b g INDIAN STAR.

# 2<sup>nd</sup> Race: 2. The Always A Rainbow Plate - Div. II - (About) 1200 metres. Horses rated 15 to 35 (12 Runners).

ORLEANS (IndraJeet Singh) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. S.S. Attaollahi was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey IndraJeet Singh, the rider of ORLEANS was reprimanded for travelling wide after entering the straight.

Jockey IndraJeet Singh, the rider of ORLEANS reported that he accidently lost his whip passing the 300 Meters.

Jockey Arvind Kumar. N, the rider of EXTRAORDINARY was reprimanded for riding an indifferent race.

Jockey D. Patel, the rider of THE OMEGA MAN was reprimanded for riding an indifferent race.

DYNAMICAL (Kiran Rai P) sustained abrasion on left fore cannon.

Routine Sample was taken for analysis from the winner b f IN A BREEZE.

# <u>3<sup>rd</sup> Race: 3. The K. N. Guruswamy Memorial Trophy - Div. II - (About)</u> <u>1200 metres. Maiden Horses 3 years old only (Horses who have run</u> <u>at least thrice but not placed second, third or fourth even once</u> <u>ineligible). (12 Runners).</u>

PRINCETON (Rayan Ahmed R) after jumping out swerved towards the left & did not raise a fluent gallop, ran detached thereafter. In view of its behaviour, Trainer Mr. S. Dominic was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race and also ensure better performance of his charge in future.

STAR OF THE HILLS (D. Patel) jumped out awkwardly.

Jockey V.R.Jagadeesh, the rider of DEMETER reported that his mount was hanging 'in' in the final 300 Metres. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Prasanna Kumar was informed to take appropriate corrective measures before accepting with it again.

It was reported after the race that ORIENTAL LILY (Nazerul Alam) pulled up lame on right fore. Trainer Mr.Neil Darashah was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b c ANGELICO.

# 4<sup>th</sup> Race: 4. The Dharmaprakash L. S. Venkaji Rao Memorial Trophy -(About) 1400 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible). (12 Runners).

DEFINING POWER (D'nuSingh Deora) jumped awkwardly inwards and inconvenienced ETOSHA (A. Sandesh) & SECRET OF LIFE (Akshay Kumar) on its inside soon after the start.

Jockey S. Zervan, the rider of TERESITA was reprimanded for shifting 'in' and inconveniencing ETOSHA (A. Sandesh) on his inside passing the 1200 Metres.

Jockey Ashok Kumar A, the rider of RULE OF LAW was reprimanded for not fastening his chin strap properly.

It was observed that A STAR IS BORN (Yash Narredu) was running green after entering the straight.

Jockey A. Sandesh, the rider of ETOSHA was reprimanded for dropping hands before passing the winning post.

Routine Sample was taken for analysis from the winner b c STOCKBRIDGE.

# 5<sup>th</sup> Race: 5. The K. N. Guruswamy Memorial Trophy - Div. I - (About) 1200 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible). (12 Runners).

LAUTERBRUNNEN (Md.Akram) jumped awkwardly outwards and inconvenienced MAGELLAN (Darshan R.N) soon after the start.

Routine Sample was taken for analysis from the winner dk b g ALL ATTRACTIVE.

# 6<sup>th</sup> Race: 6. The Monsoon Cup - (About) 1400 metres. Horses rated 85 and above, 4 years old and over. (6 Runners).

Routine Sample was taken for analysis from the winner b g MULTIFACETED.

# 7<sup>th</sup> Race: 7. The Paddiwick Plate - (About) 1400 metres. Horses rated 45 to 65 (12 Runners).

ELECTRA (Shreyas Singh S) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.S.S. Attaollahi was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Shamaz Shareef, the rider of SPEEDSTER reported that he accidently lost his whip passing the 400 Meters.

Jockey K.G. Likith Appu, the rider of SEA OF CORTEZ was reprimanded in presence of his Master Trainer Mr. Neil Darashah that he has to make every effort to improve his riding skills in future, failing which he shall be reported to the Stewards for severe action. Thereafter, the Stipendiary Stewards directed Apprentice Jockey K.G. Likith Appu to report to his (Principal Mr. Aslam Khader) to improve his riding skills and to build his stamina.

Routine Sample was taken for analysis from the winner b f LAKE TAHOE.

## 8<sup>th</sup> Race: 8. The Always A Rainbow Plate - Div. I - (About) 1200 metres. Horses rated 15 to 35 (11 Runners).

Permission was granted to Trainer Mr.S. Ganapathy to withdraw OWN LEGACY (Bhawani Singh) on veterinary grounds as it was found to be lame on left fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

EXALTATION (Arshad Alam) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.S. Narredu was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Arul J.H, the rider of FLAMINGO ROAD was fined Rs.1,000/- for shifting 'in' and causing interference to EMBOSOM (D'nuSingh Deora) on his inside approaching 100 Metres.

Routine Sample was taken for analysis from the winner b f DRUSILLA.

# ORDER OF THE BOARD OF APPEAL BANGALORE WINTER MEETING 2020-21 TWELVETH DAY, SATURDAY, 16<sup>TH</sup> JANUARY, 2021

# Race: 95. The Chamundi Hill Plate - (About) 1600 Metres. Horses rated 15 to 35

The Board of Appeal of Bangalore Turf Club Ltd., at its meeting held on 6<sup>th</sup> July 2021 considered the appeal e-mail dated 17<sup>th</sup> March 2021 addressed by Jockey P. Trevor as against the decision of the Stewards at their meeting held on 15<sup>th</sup> March 2021.

The Board considered the evidence produced by the Stipendiary Stewards, the oral submission made by Jockey P. Trevor and Trainer Mr. Prasanna Kumar.P during the hearing of the Appeal.

#### The Board unanimously decided as follows:

- a) Reject the appeal filed by Jockey P. Trevor.
- b) To confirm the Order of Stewards of the Bangalore Turf Club Ltd., at its meeting held on 15th March 2021, where in it was decided to suspend the Jockey's Licence granted to him for the first four race days during the commencement of the Bangalore Summer Meeting 2021 and fine him a sum of Rs.25,000/- for Injudicious Riding [Rule No. 161 (ii) of the BTC Rules of Racing] on his mount REDOUBTABLE (Permitted to ride work).
- c) Trainer Mr. Prasanna Kumar.P was severely reprimanded and cautioned to give specific instructions to all his riders in future.
- d) To forfeit Rs.11,800/- (inclusive GST) paid by Jockey P. Trevor towards the Appeal fee.

# **BANGALORE WINTER MEETING 2020-21**

# FIFTEENTH DAY, FRIDAY, 5TH FEBRUARY, 2021

# Race: 118. The Stayers Trial Stakes - (About) 2400 Metres (4 years old and over at the time of starting).

The Board of Appeal of Bangalore Turf Club Ltd., at its meeting held on 6th July 2021 considered the appeal dated 22<sup>nd</sup> February 2021 addressed by Jockey Suraj Narredu against the decisions of the Stewards at their meeting held on 19<sup>th</sup> February 2021.

The Board considered the evidence produced by the Stipendiary Stewards, the concerned Trainer, the Veterinary Officer and Jockey Suraj Narredu.

After repeated viewing of the video recording of the race, detailed deliberation and using their wisdom, experience and in their opinion, the Board members arrived at a unanimous decision and held Jockey Suraj Narredu "guilty as charged" in this matter.

#### The Board decided:

(i) Reject the appeal filed by Jockey Suraj Narredu.

(ii) The period of withdrawal of his Jockey's Licence to be enhanced from four months to six months (In accordance with Rule No. 49 (e) of the BTC Rules of Racing) and the revised withdrawal period of his Jockey's Licence shall be with effect from 7<sup>th</sup> July, 2021 to 6<sup>th</sup> January, 2022 (Both days inclusive) and fine him a sum of Rs.50,000/- for Contravention of Rule No. 159 (a) & (b) of the BTC Rules of Racing on his mount SALAZAAR.

(iii) To forfeit Rs.11,800/- (Inclusive GST) paid by Jockey Suraj Narredu towards the Appeal fee
