

BANGALORE SUMMER MEETING 2022
EIGHTH DAY, SUNDAY, 12TH JUNE, 2022
RACING INCIDENTS
(38-44)

GOING : Good

PENETROMETER READING: 3.4 Cms.

RAILING POSITION: Railing fixed at average width of 8.0 Meters from 1600 Meters to winning post from its original position.

1st Race: 38. The Ich Dien Plate - Div. II - (About) 1200 metres. Horses rated 20 to 45, 4 years old and over (10 Runners).

Jockey Vishal N Bunde replaced the indisposed Jockey P. Ajeet Kumar on THE INTRUDER.

Trainer Mr. M. Rajendra Singh was fined Rs.1,000/- for failing to produce the declared colors at the scales in respect of his charge PORT OF BEAUTY (Shamaz Shareef). Subsequently, All Black emergency colors were permitted to be used.

BARONESS (Rajesh Kumar M) after jumping out did not raise a fluent gallop for the first 25 Metres. In view of its behaviour, Trainer Mr. Narayana Gowda V. was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

It was observed that Jockey Hindu Singh, the rider of ANSALDO had to steady his mount to avoid striking the front runner DIVINE BLESSINGS (S. John) passing the 900 Metres.

Jockey Rayan Ahmed R., the rider of FAVORITO reported that his mount was hanging out throughout the race. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. V. Lokanath (deputizing on behalf of Trainer Mr. Imtiaz Khan) was informed to take appropriate corrective measures before accepting with it again.

Jockey Vishal N Bunde, the rider of THE INTRUDER was fined Rs.1,000/- for shifting 'in' and causing interference to TORONERO (Salman Khan) on his inside approaching 300 Metres.

It was reported after the race that THE INTRUDER (Vishal N Bunde) had apparently lost its right hind shoe during the race and found to have sustained deep clip injury on right hock.

AMAZONITE (B. Nayak) sustained bleeding cut injury on left hind inner bulb.

Routine Sample was taken for analysis from the winner b f DIVINE BLESSINGS.

2nd Race: 39. The Kranji Plate - (About) 1800 metres. Horses rated 00 to 25 (7 Runners).

Trainer Mr. Warren Singh was questioned regarding relative performance of his charge SHUBANKAR (Akshay Kumar) in the above race as compared to its previous run in Race No. 10 i.e., The Meydan Plate - Div. II, (About) 1200 Metres, Horses rated 20 to 45, 4 years old and over run on 29/5/2022 wherein it unplaced. While noting his explanations, he was severely cautioned for the future running of his charges.

Routine Sample was taken for analysis from the winner gr c SHUBANKAR.

3rd Race: 40. The Mayor's Cup - (About) 1400 metres. Horses rated 60 to 85 (9 Runners).

ETERNAL BLAZE (C. S. Jodha) after jumping out swerved towards the left and did not take any practical part in the race. In view of its behaviour, Trainer Mr. S.

Ganapathy was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey K.G. Likith Appu, the rider of MOUNTAIN LION reported that his saddle shifted forward approaching 1200 Metres as such passing the 800 Metres he had to steady his mount shift out and thereafter he could not offer any assistance to his mount . After due examination of the equipment, Trainer Mr.Neil Darashah was fined Rs.3,000/- for faulty saddling of his charge.

Jockey K.G. Likith Appu, the rider of MOUNTAIN LION was fined Rs. 3,000/- for coming 'in' and tightening the horses on inside viz; SEA OF CORTEZ (Dashrat Singh), PRESIDENTIAL (P. S. Chouhan) and WATCHMYSTARS (P. Trevor) before passing the red marker post and for again shifting 'in' and inconveniencing WHIZZO (A.Ashhad Asbar) approaching 1200 Metres.

Jockey A.Ashhad Asbar, the rider of WHIZZO was fined Rs.2,000/- for not maintaining a straight course and slowing down the pace before passing the red marker post.

Routine Sample was taken for analysis from the winner dk b g ALL ATTRACTIVE.

4th Race: 41. The Krishnaraja Wadiyar Cup - (About) 1600 metres. 4 years old and over. (5 Runners).

Jockey A. Sandesh, the rider of FOREST FLAME was fined Rs.3,000/- for coming 'in' and tightening MIRACLE (P. S. Chouhan) on his inside passing the 1500 Metres.

CHOPIN (P. Trevor) ran detached from 250 Metres. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. P. Shroff was informed to ensure better performance of his charge in future.

MIRACLE (P. S. Chouhan) was subjected to veterinary examination. On examination, it was found to be lame on right fore. Trainer Mr. P. Shroff was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

A STAR IS BORN (Suraj Narredu) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b m FOREST FLAME.

5th Race: 42. The Prince Khartoum Plate - (About) 1200 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (11 Runners).

Jockey Shamaz Shareef, the rider of LADY GODIVA reported that his mount was hesitant to gallop from 1100 Metres till about 600 Metres. In view of its behaviour, Trainer Mr. Prasanna Kumar was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey P. Trevor, the rider of ROYAL GLORY reported that he could not get a clear run between the 800 Metres to 600 Metres due to a closely packed field.

Routine Sample was taken for analysis from the winner b f ARTEMIS IGNACIA.

6th Race: 43. The Royal Command Plate - (About) 1600 metres. Horses rated 20 to 45, 4 years old and over (8 Runners).

AIRCRAFT (Dashrat Singh) sustained superficial clip injury on right hock.

An enquiry is being held into the running and riding of ANOTHER RAINBOW, trained by Mr. M. Rajendra Singh and ridden by Jockey Raghuveer Singh in the above race.

Routine Sample was taken for analysis from the winner dk b r SCRIBBLING HOPPER.

7th Race: 44. The Ich Dien Plate - Div. I - (About) 1200 metres. Horses rated 20 to 45, 4 years old and over (11 Runners).

Jockey B. Nayak, the rider of SILVER SWIFT was fined Rs.3,000/- for continuously intimidating CLASSIC CHARM (Bhawani Singh) and not exercising sufficient control over his mount between the 800 Metres till about 500 Metres.

Jockey Akshay Kumar, the rider of CLEVER HANS was reprimanded for shifting out and inconveniencing OSIRIS (Ajeet Kumar) on his outside soon after the start.

Jockey Akshay Kumar, the rider of CLEVER HANS was fined Rs.1,000/- for shifting out and bumping IMPECCABLE (Nikhil Naidu) on his outside approaching 250 Metres.

Routine Sample was taken for analysis from the winner b f MILLBROOK.

Permission was granted to trainer Mr. V. Lokanath to deputize on behalf of trainer Mr. Imtiaz Khan who was unable to attend the races.

Race: 184. The Kallathigiri Falls Plate - (About) 1400 metres. Horses rated 20 to 45.

Trainer Mr. Imtiaz Khan and Jockey A.Ashhad Asbar were questioned regarding the running and riding of AHERNE. After due enquiry, their explanations were noted for future reference.

TWENTYSEVENTH DAY , FRIDAY , 11th MARCH 2022

(A)

Race: 195. The Damodar Plate - (About) 1400 metres. Horses rated 00 to 25 (Whips not allowed).

An enquiry was held into the incident with regard to the start of the race (KARACHI). The following were questioned Mrs. Parvati Byramji, Jockey Antony Raj. S and the Starter. After due enquiry, their explanations were noted, a grave benefit of doubt was given at this instance and all the concerned were cautioned for future.

(B)

Race: 198. The Shivaganga Falls Plate - Div. II - (About) 1200 metres. Horses rated 20 to 45.

An enquiry was held into the inconsistent pattern of running and reversal of form of OCEAN DUNES, trained by Mr. Arjun Mangalorkar and ridden by Jockey Antony Raj S. in the above race as compared to its previous in Race No. 188 i.e.,The Hiranyakeshi Plate, (about) 1200 Metres, Horses rated 20 to 45, 5 years old and over run on 25/2/2022 wherein it ran unplaced. After due enquiry, his explanations was noted for future reference.

ORDER OF THE STEWARDS

Inventory report (From Trainer Mr. B. Prithviraj stables)

The Stewards of the Bangalore Turf Club Ltd. at their meeting held on Saturday, 4th June, 2022 considered the Charge Sheet No.786 dated 2/6/2022 issued to Trainer Mr. B. Prithviraj reading as follows:

“Charge Sheet No. 786

[Allegation of a breach of the B.T.C. Rules of Racing]

Venue: Bangalore

Inventory Report

Date: 27/1/2022

Defendant: Mr. B. Prithviraj

Designation: Trainer

The B.T.C. Stipendiary Stewards allege that the above named Defendant committed a breach of:

B.T.C. Rule/s : 19 and 25 of the B.T.C. Medication Rules

(Outline description of allegation of breach)

1. In that for not complying to maintain a medical log book in accordance with the said rule.
2. You have failed to explain the possession of medication found at your stables during the inventory.
3. Evading the enquiry in spite of being called by the Stipendiary Stewards.

Thus, you have contravened Rule Nos. 19 and 25 of the Medication Rules reading as under:

“RULE No. 19.

A trainer must record in his log book (hand written) any medication or treatment administered to any horse in the trainer’s care by midnight on the day on which the administration was given.”

“ RULE No. 25.

A person must not have in his or her possession or on his or her premises any medication, substance or preparation which has not been registered, labelled, prescribed, dispensed or obtained.”

The Stewards considered the following:

- (a) Charge sheet issued by the Stipendiary Stewards;
- (b) The Submissions made by the Chief Veterinary Officer during the enquiry;
- (c) The Submissions made by Trainer Mr. B. Prithviraj during the enquiry they also noted, that he had pleaded guilty of alleged breach of Rule Nos. 19 and 25 as charged by the Stipendiary Stewards with regards to B.T.C Medication Rules.

The Stewards, thereafter using their wisdom and experience, arrived at a unanimous decision that trainer Mr. B. Prithviraj was **"Guilty"** as charged in the matter.

In the light of above, they decided as under:

- (i) Fine trainer B. Prithviraj a sum of Rs. 1,00,000/- (One Lakh only) for contravention Rule Nos. 19 and 25 of the B.T.C Medication Rules.
- (ii) He was informed of his right to appeal.
