RACING INCIDENTS
(45- 52)

GOING : Soft

PENETROMETER READING: 5.5 Cms.

RAILING POSITION: Railing fixed at average width of 3.0 Meters from 1600 Meters to winning post from its original position.

1st Race: 45. The Treasure Girl Plate - Div. II - (About) 1200 metres. Horses rated 20 to 45, 5 years old and over (11 Runners).

It was observed that MORRANE GABRIELLA (S.Mubarak) was pulled up by its rider approaching 150 Metres and did not complete the course. On immediate examination by the Club's Veterinary Officer, it was found to be lame on left fore. Trainer Mr. Pradeep Annaiah was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that TIFANNY (A. Sandesh) pulled up lame on left hind and sustained abrasion on left hind fetlock. Trainer Mr.S. Padmanabhan was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner dk b m UNYIELDING.

2nd Race: 46. The Royal Challenge Plate - (About) 1400 metres. Horses rated 00 to 25 (Whips not allowed) (8 Runners).

Jockey Salman Khan, the rider of KLOCKNER reported that his mount was hanging out after entering the straight. Trainer Mr.Pradeep Annaiah was informed to take appropriate corrective measures before accepting with it again.

Jockey K.G. Likith Appu, the rider of RED LUCIFER reported that his mount lost its footings passing the 900 Metres.

It was observed that Jockey Angad, the rider of ELITE AGENT had to steady his mount to avoid striking the front runner RED LUCIFER (K.G. Likith Appu) passing the 200 Metres.

RUSSIAN ROMANCE (Arul J.H) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g KLOCKNER.

3rd Race: 47. The Dupont Plate - (About) 1600 metres. Horses rated 00 to 25 (8 Runners).

LIGHTNING FLAME (Dashrat Singh) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.S. Ganapathy was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey A. Sandesh, the rider of TURKOMAN reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. S. Padmanabhan was informed to take appropriate corrective measures before accepting with it again.

Jockey Ajeet Kumar, the rider of OSIBISA was reprimanded for suddenly changing course towards the outside approaching 500 Metres.

Jockey Vivek.G, the rider of EXALTED DREAM was reprimanded for shifting 'in' and inconveniencing TURKOMAN (A. Sandesh) on his inside approaching 200 Metres.

It was reported after the race that CHIRAAG (B. Nayak) burst its blood vessels. Trainer Mr.Dheeraj.V was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner ch g NOBLE RULER.

4th Race: 48. The Sir Cecil Cup - (About) 1400 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (6 Runners).

Permission was granted to Trainer Mr.S. Padmanabhan to withdraw ADJUSTMENT on veterinary grounds as it was found to have sore shin on both fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Permission was granted to Trainer Mr.Irfan Ghatala to withdraw VICTORIA PUNCH on veterinary grounds as it was found to be lame on left fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

KONABOS (Suraj Narredu) jumped awkwardly outwards.

AGUILA (C. S. Jodha) was slightly slowly away.

Jockey Ranjeet Singh, the rider of SPLENDIDO reported that his mount was hanging out throughout the race and ran detached from about 700 Metres. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. S. Padmanabhan was informed to take appropriate corrective measures before accepting with it again.

Jockey Akshay Kumar, the rider of ARROWETTE was fined Rs.1,000/- for coming 'in' and tightening RIPPLE N STORM (R. Ajinkya) on his inside in the final 100 Metres of the race.

Jockey Suraj Narredu, the rider of KONABOS was fined Rs.3,000/- for the excessive use of whip on his mount during the race (1st infringement).

Routine Sample was taken for analysis from the winner b f KONABOS.

5th Race: 49. The D. Kumar Siddanna Memorial Trophy - (About) 1200 metres. Horses rated 40 to 65, 5 years old and over (10 Runners).

Permission was granted to Trainer Mr. Sriram Komandur to withdraw SUPER GLADIATOR (A.Ashhad Asbar) on veterinary grounds as it was found to have sustained injury and cellulitis on right hind fetlock. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was observed that GRIFFIN (Salman Khan) shifted 'in' and inconvenienced POWERFUL LADY (K. Nazil) soon after the start.

Routine Sample was taken for analysis from the winner dk b m MICHIGAN MELODY.

6th Race: 50. The Noble Prince Plate - (About) 2000 metres. Horses rated 20 to 45 (5 Runners).

ELITE CROWN (Vishal N Bunde) ran detached from the field. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Aravind G. was informed to ensure better performance of his charge in future.

Jockey Darshan R.N, the rider of WINDSTORM was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

SERDAR (C. S. Jodha) sustained superficial clip injury on right hind medial bulb.

Routine Sample was taken for analysis from the winner b g WINDSTORM.

7th Race: 51. The Borsalino Plate - (About) 1600 metres. Horses rated 20 to 45, 4 years old and over (8 Runners).

Permission was granted to Trainer Mr. Arjun Mangalorkar to withdraw HOPE ISLAND (S. John) on veterinary grounds as it was found to have cellulitis on right fore cannon and fetlock. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was observed by the Club's Veterinary Officer that TYTO ALBA (Angad) was trotting lame on right fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr.Narayana Gowda V. was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Kiran Naidu, the rider of STAR DOMINATION reported that his saddle shifted back passing the 600 Metres. After due examination of the equipment, Trainer Mr. S. Narredu was fined Rs.3,000/- for faulty saddling of his charge.

Jockey Bhawani Singh, the rider of QUEEN REGNANT was fined Rs.5,000/- for the excessive use of whip on his mount during the race (2nd infringement).

Jockey Kiran Naidu, the rider of STAR DOMINATION was fined Rs.3,000/- for the excessive use of whip on his mount during the race (1st infringement).

Jockey B. Nayak, the rider of JE NE SAIS QUOI was severely reprimanded for taking an unduly long lead during the race.

Jockey Arvind Kumar. N, the rider of LYCURGUS reported that he could not get a clear run in the final 50 Metres due to a closely packed field.

MARCO POLO (P. S. Chouhan) sustained abrasion on left hind cannon.

Routine Sample was taken for analysis from the winner b r STAR DOMINATION.

8th Race: 52. The Treasure Girl Plate - Div. I - (About) 1200 metres. Horses rated 20 to 45, 5 years old and over (9 Runners).

BENEDICTION (Akshay Kumar) was examined at the starting gate by the Club's Veterinary Officer and was found to be trotting lame on right fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr.M. Rajendra Singh was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

REALIA (A.Ashhad Asbar) reared up and flipped over inside the starting gates. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order. On examination by the Club's Veterinary Officer after the race, it was found to be lame on right hind and sustained puncture wound on left ear base. Trainer Mr. Azhar Ali was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

PERFECT RENDITION (Arul J.H) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.Neil B Devaney was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

It was observed that Jockey Ajeet Kumar, the rider of THE RESPONSE had to steady his mount to avoid striking the front runner SEE MY HEELS (Suraj Narredu) approaching 500 Metres.

Jockey S. John, the rider of BALTIMORE was fined Rs.2,000/- for shifting 'in' and tightening SEE MY HEELS (Suraj Narredu) on his inside approaching 500 Metres.

Trainer Mr. S. Narredu and Jockey Suraj Narredu were questioned regarding running and riding of SEE MY HEELS in the above race. The Jockey stated that his horse was hanging very badly in spite of him using the whip in the right, he also added that if he had not stop riding and pulled out the horse it would have gone into the rail. The trainer stated that he would have won the race if he is would not have received an interference when asked about the horse hanging 'in', he stated that it was because of the soft going. Under the circumstances, Trainer Mr. S. Narredu was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

At behest of the Stewards the Club's Veterinary Officer examined SEE MY HEELS at 7:30 P.M and was found to have sustained abrasion on right hind fetlock inside and left hind cannon, hock outside. However, the horse was trotting sound.

An enquiry is being held into the running and riding of SEE MY HEELS, trained by Mr. S. Narredu and ridden by Jockey Suraj Narredu in the above race.

Routine Sample was taken for analysis from the winner b g FERNET BRANCA.
