RACING INCIDENTS
(53-60)

GOING : Soft

PENETROMETER READING: 4.8 Cms.

RAILING POSITION: Railing fixed at its original position.

1st Race: 53. The Ramkirpal Plate - Div. II - (About) 1200 metres. Horses rated 00 to 25 (11 Runners).

Trainer Mr. Mahmood Khan was fined Rs.2,000/- for using Tongue Strap on his charge DARING SWEETHEART (S.Mubarak) for which prior permission was not obtained. Subsequently, Tongue Strap was removed before the horse left the paddock.

BRAMASTRAM (Shamaz Shareef) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.M. Rajendra Singh was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

DARING SWEETHEART (S.Mubarak) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Mahmood Khan was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

SKY PRINCESS (A.Ashhad Asbar) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Azhar Ali was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

AKASI (Vivek) took a fly jump.

Jockey Vivek, the rider of AKASI reported that his mount was inclined to run out between the 850 Metres till about 600 Metres. The horse was subjected to veterinary examination. On examination, it was found to have sustained abrasion over right hind cannon and also Sharp Molars. Trainer Mr. S. Inayathulla was fined Rs.3,000/- for his negligence (1st infringement).

Jockey Shamaz Shareef, the rider of BRAMASTRAM reported that he accidentally lost his whip passing the 150 Meters.

It was reported after the race that ARECA ANGEL (Rajesh Kumar M) burst its blood vessels. Trainer Mr. Narayana Gowda V. was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

DARING SWEETHEART (S.Mubarak) was subjected to veterinary examination. On examination, it was found to have sustained abrasion over right hock.

Trainer Mr. Sharat Kumar was fined Rs.10,000/- for inconsistent pattern of running of ALTAIR in the above race where it won as compared to its previous run in Race No. 31 of Bangalore Summer Meeting 2022 i.e.,The Guindy Plate – Div. II, (about) 1200 Metres, Horses rated 00 to 25, 5 years old and over, run on 11/6/2022 where it ran unplaced.

Routine Sample was taken for analysis from the winner dk b r ALTAIR.

2nd Race: 54. The Star Contender Plate - (About) 1400 metres. Horses rated 20 to 45 (11 Runners).

Permission was granted to Trainer Mr.Prasanna Kumar to withdraw NIKOLINA (Akshay Kumar) on veterinary grounds as it was found to be lame on left fore due to capped elbow. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Richard Oliver, the rider of ELECTRIC BLUE placed 2nd by the judge objected against Jockey Suraj Narredu, the rider of ASHWA MAGADHEERA placed 1st for "In the last 150 Metres my filly was full of running and gaining on the winner, when he shifted out and caused my filly to lose momentum which cost me a certain race". The Stewards held an enquiry immediately after the race and afforded an opportunity to the concerned Jockeys to represent their case. After deliberations, they decided to overrule the objection.

Jockey Suraj Narredu, the rider of ASHWA MAGADHEERA was fined Rs.5,000/- for persisting to use the whip with the right hand due to which his horse drifted out further and inconvenienced ELECTRIC BLUE (Richard Oliver) on his outside in the passing the 150 Metres.

Routine Sample was taken for analysis from the winner b c ASHWA MAGADHEERA.

3rd Race: 55. The Rare Gem Plate - (About) 1200 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (Outstation horses eligible) (13 Runners).

TYCOONIST (Suraj Narredu) was extremely fractious, reared up and was stuck for a considerable period of time. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

It was observed that ARDAKAN (Ranjeet Singh) jumped awkwardly onto OASIS CLASS (A. Prakash), after a few strides the ARDAKAN was erratic while galloping, and suddenly swerved towards the right whereby the Jockey was totally unbalanced on his mount and was dislodged, thereafter the horse ran ride less. In view of its behaviour, Trainer Mr. S. Padmanabhan was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Shamaz Shareef, the rider of SECRET LADY reported that the mouth of his mount was very soft, as such it took an unduly long lead during the race. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Prasanna Kumar was informed to take appropriate corrective measures before accepting with it again.

Jockey A.Ashhad Asbar, the rider of THE SENSATION reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination. On examination, it was found to be lame on left hind and sustained abrasion on left hind cannon. Trainer Mr. M Srinivas Reddy was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

ROMERO (L. Alex Rozario) sustained superficial cut injury on right hind coronet.

Routine Sample was taken for analysis from the winner ch c PINNACLE POINT.

4th Race: 56. The Stewards Cup - (About) 1200 metres. Horses rated 60 to 85 (6 Runners).

CAVALLINI (Akshay Kumar) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Irfan Ghatala was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey D'nuSingh Deora was questioned regarding the poor performance of OBSIDIAN in the above race. The Jockey stated that he was asked to go to the front or to ride from the second position. He followed the instructions of the trainer but his horse stopped galloping in the final 150 Metres. The horse was impounded for veterinary examination. On examination, it was found to have burst its blood vessels (On endoscopy Grade - IV & Epiglottic Entrapment). Trainer Mr. Prasanna Kumar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Surprise sample was taken for analysis from dk b g OBSIDIAN.

Routine Sample was taken for analysis from the winner b g LUCKY CHANCE.

5th Race: 57. The Fillies Championship Stakes (Grade I) - (About) 1600 metres. 3-year-old Indian Fillies (foaled in 2019) (13 Runners).

Jockey A. Sandesh, the rider of PHILOSOPHY was reprimanded for shifting 'in' and inconveniencing FAITH (P. Trevor) on his inside approaching 1500 Metres.

Jockey Yash Narredu, the rider of ETERNAL PRINCESS was fined Rs.1,000/- for shifting out and taking out QUEEN SPIRIT (S. Zervan) on his outside approaching 1200 Metres.

Jockey A. Sandesh, the rider of PHILOSOPHY was fined Rs.2,000/- for exulting before passing the winning post.

When asked Jockey P. S. Chouhan, the rider of KING'S RANSOM reported that his saddle shifted back gradually in the straight. After a report by the paddock incharge. Trainer Mr. P. Shroff was fined Rs.3,000/- for faulty saddling of his charge. Jockey P. S. Chouhan was further cautioned for removing the saddle in haste.

FAITH (P. Trevor) had apparently lost its left fore shoe during the race.

Compulsory urine and blood samples were taken for analysis from the following I,II & III placed horses viz:

6th Race: 58. The K. S. Prasad Memorial Trophy - (About) 1400 metres. Horses rated 40 to 65 (13 Runners).

REGAL COMMAND (Bhawani Singh) took a fly jump and lost few lengths at the start. In view of its behaviour, Trainer Mr. Aravind. G (deputizing on behalf of Trainer Mr. Karthik Ganapathy) was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

SONATA (K.G. Likith Appu) jumped awkwardly onto RULING GODDESS (Shreyas Singh S) soon after the start.

Jockey Arul J.H, the rider of THE INHERITOR was fined Rs.2,000/- for shifting 'in' and causing interference to IMPERIAL BLUE (Akshay Kumar) on his inside passing the 200 Metres.

Jockey T. S. Jodha, the rider of PELUCHE reported that he had a poor vision in the straight due to the kick back, as such he had to pull off his goggles in the final 100 Metres. His explanations were noted.

MYSTIC EYE (Prashant P.Dhebe) was subjected to veterinary examination but no abnormality was reported.

SONATA (K.G. Likith Appu) sustained abrasion on right hind pastern.

PEYO (Yash Narredu) sustained clip injury on left hock and cannon.

Routine Sample was taken for analysis from the winner dk b g PROMISE KEPT.

7th Race: 59. The Bergamo Plate - (About) 1600 metres. Horses rated 40 to 65, 4 years old and over (10 Runners).

Jockey T. S. Jodha replaced the indisposed Jockey A. Ashhad Asbar on JACK RYAN.

Jockey Prashant P.Dhebe, the rider of STARRY WIND reported that his mount was hanging out throughout the race. Trainer Mr. Mahmood Khan was informed to take appropriate corrective measures before accepting with it again.

SIEGE PERILOUS (Akshay Kumar) was impounded for veterinary examination but no abnormality was reported.

Surprise sample was taken for analysis from b c SIEGE PERILOUS.

Routine Sample was taken for analysis from the winner b g MULTISTARRER.

8th Race: 60. The Ramkirpal Plate - Div. I - (About) 1200 metres. Horses rated 00 to 25 (10 Runners).

CINCO DE MAYO (M. Mark) ducked down and broke the front barriers, whereby the saddle shifted back and it ran rider less, thereafter broke the running rails at the 1000 Metres. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

It was observed that Jockey A. Prakash, the rider of FIRST ROYALIST lost his right rein between the 350 Metres till about 250 Metres.

MATERA (Richard Oliver) was impounded for veterinary examination. On examination, it was found to have burst it blood vessels (On Endoscopy Grade – III). Trainer Mrs. Parvati Byramji was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Surprise sample was taken for analysis from b g MATERA.

Routine Sample was taken for analysis from the winner gr g GOLD GRAY.

Permission was granted to trainers M/s. Aravind .G and Neil B. Devaney to deputize on behalf of trainers M/s. Karthik Ganapathy and Kishan Thomas who were unable to attend the races.

Race: 9. The Ascot Plate - Div. II - (About) 1200 metres. Horses rated 00 to 25.

The Stipendiary Stewards reported Jockey S. John to the Stewards for Contravention of Rule No. 159 (a) & (b) of the B.T.C. Rules of Racing on his mount MOUNT VIEW.

The Stewards held an enquiry on 18th June, 2022, the Stewards after considering the Charge Sheet No.787 issued to Jockey S. John, viewing the CCTV replay of the race, submissions made by Mr. P.S. Chouhan – Spokesperson for Jockey S. John, Trainer Mr. Neil Darashah and deputizing Trainer Mr. S. Dominic.

After deliberations, they decided to change the charges levied against Jockey S. John by the Stipendiary Stewards for Contravention of Rule No. 159 (a) & (b) of the B.T.C Rules of Racing to Unsatisfactory Riding 161 (ii) of the B.T.C. Rules of Racing and thereafter decided as under:-

- (a) Suspend the Jockey's Licence granted to S. John with effect from **28-6-2022 to 3-7-2022** (both days inclusive) and fine him a sum of Rs. 10,000/- for Unsatisfactory Riding [Rule No. 161 (ii) of the BTC Rules of Racing] on his mount MOUNT VIEW (Permitted to ride work).
- (b) Fine Trainer Mr. Neil Darashah Rs.5,000/- for improper behaviour during the enquiry.
- (c) Jockey S. John and Trainer Mr. Neil Darashah were informed of their right to appeal to the Board of Appeal.
