BANGALORE SUMMER MEETING 2022 ELEVENTH DAY, SATURDAY, 25TH JUNE, 2022 RACING INCIDENTS (61-67)

GOING: Good

PENETROMETER READING: 3.5 Cms (It rained heavily in the first and second race of the day & after the third race the penetrometer reading was 4.6 Cms and going was soft).

RAILING POSITION: Railing fixed at average width of 2.0 Meters from 1600 Meters to winning post from its original position.

1st Race: 61. The Xisca Plate - Div. II - (About) 1400 metres. Horses rated 00 to 25 (8 Runners).

Jockey Darshan R.N, the rider of ALTAMONTE was fined Rs.5,000/- for the excessive use of the whip on his mount during the race (2nd infringement).

Jockey Rajesh Kumar M, the rider of HANDSOME ROCKY was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

Routine Sample was taken for analysis from the winner b m ALTAMONTE.

2nd Race: 62. The Adler Plate - Div. II - (About) 1400 metres. Horses rated 20 to 45, 4 years old and over (10 Runners).

DEFINING POWER (Rajesh Kumar M) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.Narayana Gowda V was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Rayan Ahmed R., the rider of WONDER WENCH was fined Rs.2,000/for coming 'in' and causing interference to CAPRI GIRL (Akshay Kumar), which in turn passed it onto AIR DISPLAY (Siddaraju.P) on his inside before passing the red marker post.

Jockey Rayan Ahmed R., the rider of WONDER WENCH was fined Rs.1,000/-for shifting 'in' and tightening BROOKLYN SUPREME (A.Ashhad Asbar), whereby ALEXIS ZORBA (K.G. Likith Appu) which was travelling directly behind had to be checked by its rider passing the 900 Metres.

Jockey Vishal N Bunde, the rider of CHRISTOPHER WREN reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination. On examination, it was found to have profuse bleeding due to cut injury on right knee. Trainer Mr. V. Lokanath was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Rayan Ahmed R., the rider of WONDER WENCH reported that his saddle shifted back approaching 300 Metres. After due examination of the equipment, Trainer Mr. S. Narredu was fined Rs. 3,000/- for faulty saddling of his charge.

Routine Sample was taken for analysis from the winner dk b m ELUSIVE GIRL.

3rd Race: 63. The V. T. Velu Memorial Trophy - (About) 1600 metres. Horses rated 40 to 65 (8 Runners).

GREY CHANNEL (Arshad Alam) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Azhar Ali was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Siddaraju.P, the rider of CAPABLE was fined Rs.2,000/- for not wearing goggles during the race.

It was observed that ETOSHA (S. Zervan) burst its blood vessels during the race and passing the 700 Metres, it was pulled up by its rider and it did not complete the course. Trainer Mr.Neil Darashah was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Urine and blood sample were taken for analysis from b g ETOSHA. Subsequently, taking into consideration the fact that emergent veterinary treatment was meted out to ETOSHA involving the injection of drugs, it was decided to retain the samples for record purpose only and not to send the same for testing.

Routine Sample was taken for analysis from the winner b c ASHWA YUDHVIR.

4th Race: 64. The Chief Justice's Cup (Grade III) - (About) 1800 metres. 4 years old and over. (6 Runners).

It was observed that Jockey Richard Oliver, the rider of CHOPIN had to ride in check between the 1500 Metres till about 1300 Metres.

Jockey P. Trevor, the rider of ZUCCARELLI was fined Rs.1,000/- for shifting out and taking out the horses on his inside viz; FAITH OF SUCCESS (C. S. Jodha) and GIANT STAR (Yash Narredu) passing the 500 Metres.

It was observed that Jockey P. S. Chouhan, the rider of THEON had lost his whip passing the 150 Metres at a crucial part of the race and the verdict being a short head. An enquiry is being held into the matter.

THEON (P. S. Chouhan) sustained superficial injury on left hind pastern.

Compulsory urine and blood samples were taken for analysis from the following I,II & III placed horses viz:

5th Race: 65. The Everynsky Plate - (About) 1400 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (Outstation horses eligible) (9 Runners).

QUEEN ENVIED (Anjar Alam) was impounded for veterinary examination. On examination, it was found to have bit sore on right buccal mucosa.

An enquiry is being held into the running and riding of QUEEN ENVIED, trained by Mr. Irfan Ghatala and ridden by Jockey Anjar Alam in the above race.

Surprise sample was taken for analysis from b f QUEEN ENVIED.

Routine Sample was taken for analysis from the winner b c FORTUNATUS.

6th Race: 66. The Adler Plate - Div. I - (About) 1400 metres. Horses rated 20 to 45, 4 years old and over (10 Runners).

OWN LEGACY (P. Trevor) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.S. Ganapathy was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

SENSATIONAL GREY (S. Saqlain) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. V. Lokanath was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

SILVERITA (S. John) jumped awkwardly inwards and inconvenienced AFERPI (Rajesh Kumar M) soon after the start.

DIVINE RAY (Richard Oliver) jumped awkwardly inwards and the inconvenienced the horses on its inside viz; IN A BREEZE (K.G. Likith Appu) and CAMELEONS IMAGE (Chethan Gowda) soon after the start.

Jockey Rajesh Kumar M, the rider of AFERPI was fined Rs.1,000/- for shifting 'in' and causing interference to ALMANACH (Surya P.) on his inside approaching 600 Metres.

Jockey S. Saqlain, the rider of SENSATIONAL GREY reported that his mount was hanging out after entering the straight. The horse was subjected to veterinary examination. On examination, it was found to have burst its blood vessels. Trainer Mr. V. Lokanath was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

AFERPI (Rajesh Kumar M) was subjected to veterinary examination but no abnormality was reported.

An enquiry is being held into the poor performance of SILVERITA, trained by Mr. Arjun Mangalorkar and ridden by Jockey S. John in the above race as compared to its previous run in Race No. 36 i.e., The Pendragon Plate (about) 1400 Metres, Horses rated 20 to 45 run on 11th June, 2022 wherein it won.

An enquiry is being held into the relative improved performance and reversal of form of IN A BREEZE, trained by Mr. Irfan Ghatala and ridden by Jockey K.G. Likith Appu in the above race as compared to its previous run in Race No. 25 i.e., The Richelieu Plate - Div. II, (about) 1400 Metres, Horses rated 20 to 45, 4 years old and over run on 5th June, 2022 wherein it unplaced.

Routine Sample was taken for analysis from the winner b m IN A BREEZE.

7th Race: 67. The Xisca Plate - Div. I - (About) 1400 metres. Horses rated 00 to 25 (9 Runners).

Jockey Vishal N Bunde, the rider of REGAL MELODY was fined Rs.1,000/- for shifting out and causing interference to ELITE AGENT (Rajesh Kumar M) on his outside before passing the red marker post.

Jockey Arshad Alam, the rider of ABLE ONE was fined Rs.1,000/- for coming 'in' and causing interference to the horses viz; MARK ONE (R.Ajinkya) and REGAL MELODY (Vishal N Bunde) on his inside approaching 1100 Metres.

Jockey Arvind Kumar. N, the rider of EXTRAORDINARY reported that he accidently lost his whip passing the 100 Meters.

Routine Sample was taken for analysis from the winner dk b g EXTRAORDINARY.

Permission was granted to trainer Mr. Mahmood Khan to deputize on behalf of trainer Mr. S. Inayathulla who was unable to attend the races.
