RACING INCIDENTS
(18-23)

GOING : Soft

PENETROMETER READING: 4.8 Cms.

RAILING POSITION: Railing fixed at average width of 6.0 Meters from 1600 Meters to winning post from its original position.

1st Race: 18. The Udhagamandalam Plate - Div. II - (About) 1100 metres. Horses rated 00 to 25 (7 Runners).

Permission was granted to Trainer Mr.Sharat Kumar to withdraw GOLD GRAY (Arul J.H) on veterinary grounds as it was found to have sustained superficial injury on tongue. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Rajesh Kumar M, the rider of PERFECT HALO was reprimanded for shifting 'in' and inconveniencing ZHU ZHU ZEST (Vishal N Bunde) on his inside soon after the start.

Jockey S. Saqlain, the rider of MAX MUELLER was fined Rs.1,000/- for coming 'in' and causing interference to JAI VIKRAM (Vivek.G) on his inside passing the 800 Metres.

Jockey Vivek.G, the rider of JAI VIKRAM was reprimanded for not exercising sufficient control on his mount, whereby he shifted 'in' and bumped the hind quarters of LADY SUPREMOS (Yash Narredu) on his inside passing the 400 Metres,

Jockey Rajesh Kumar M, the rider of PERFECT HALO was fined Rs.5,000/- for riding in a careless manner, in that he shifted out and repeatedly bumped and bored JAI VIKRAM (Vivek.G) between the 250 Metres till about passing the final 75 Metres.

Jockey Vivek.G, the rider of JAI VIKRAM was fined Rs.5,000/- for riding in a careless manner, in that he shifting 'in' and repeatedly bumped and bored PERFECT HALO (Rajesh Kumar M) between the 250 Metres till about the final 75 Metres.

LADY SUPREMOS (Yash Narredu) sustained superficial injury on left achilles region.

MAX MUELLER (S. Saqlain) sustained superficial injury on left hind fetlock.

Routine Sample was taken for analysis from the winner dk b f LADY SUPREMOS.

2nd Race: 19. The Civil Service Trophy - Div. II - (About) 1100 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (9 Runners).

It was observed that Jockey Shamaz Shareef, the rider of MY SOLITAIRE had to steady his mount to avoid striking the front runner KODAVA STREAK (K. Nazil) passing the 800 Metres.

Jockey Yash Narredu, the rider of EXCELLENT RAY was fined Rs.2,000/- for not persevering with his mount in the final 200 Metres.

MY SOLITAIRE (Shamaz Shareef) sustained superficial injury on right fore fetlock.

Routine Sample was taken for analysis from the winner b f POLISHED GIRL.

3rd Race: 20. The Raja of Bobbili Memorial Trophy - (About) 1400 metres. Horses rated 40 to 65, 5 years old and over (9 Runners).

SOUTHERN RULER (R. Rupesh) jumped out awkwardly and lost few lengths at the start. In view of its behaviour, Trainer Mr. Aravind. G (deputizing on behalf of Trainer Mr. S. Ganapathy) was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Routine Sample was taken for analysis from the winner b r FOREVER TOGETHER.

4th Race: 21. The Civil Service Trophy - Div. I - (About) 1100 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (9 Runners).

Jockey Rayan Ahmed R., the rider of FORTY NINER reported that his mount was hanging out after entering the straight. The horse was subjected to veterinary examination. On examination, it was found to have bit sore on both commissure. Trainer Mr. S. Dominic was informed to take appropriate remedial measures before accepting with it again.

Routine Sample was taken for analysis from the winner ch f LA REINA.

5th Race: 22. The Usha Stud Plate - (About) 1200 metres. Horses rated 40 to 65, 4 years old and over (12 Runners).

Trainer Mr. Pradeep Annaiah was fined Rs.2,000/- for not presenting his charge DEL MAR for acceptance weighing.

Trainer Mr. Pradeep Annaiah was fined Rs.2,000/- for not presenting his charge ASCOVAL for acceptance weighing.

Jockey Vinod Shinde replaced the indisposed Jockey Mudassar Nazar on POWERFUL LADY.

BENEDICTION (Vishal N Bunde) after jumping out, swerved towards the left and did not take any practical part in the race. In view of its behaviour, Trainer Mr. M. Rajendra Singh was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

SCHAFENBERG (IndraJeet Singh) reared up as the gates opened, dislodged the rider and did not take any practical part in the race. In view of its behaviour, Trainer Mr.S.S. Attaollahi was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Mohammed Aliyar, the rider of HARMONIA was fined Rs.2,000/- for not wearing his goggles during the race till about passing the 1000 Metres.

Jockey Bhawani Singh, the rider of LORD VADER was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

GRIFFIN (Salman Khan) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b c ASCOVAL.

6th Race: 23. The Udhagamandalam Plate - Div. I - (About) 1100 metres. Horses rated 00 to 25 (7 Runners).

It was observed by the Club's Veterinary Officer that SOUTHERNARISTOCRAT (B. Nayak) was led into the paddock walking lame on hard ground and was also observed to be lame from winning post to starting gates. On further examination at the starting gates it was found to be trotting lame on right fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. M. Rajendra Singh was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again. After due enquiry into the above incident, Trainer Mr. M. Rajendra Singh was fined Rs.10,000/- for negligence in discharge of his duties as a trainer in that he produced an unfit horse (SOUTHERNARISTOCRAT) to run in the above race, thereby Contravening Rule No. 114 (b) (i) of the BTC Rules of Racing.

It was observed that ULTIMATE SPEED (Darshan R.N) stopped galloping and fell, dislodging its rider passing the 150 Metres. On immediate examination, by the Club's Veterinary Officer, it was reported to have died due to shock as it is blood from both nostrils.

Routine Sample was taken for analysis from the winner b m BARONESS.

Permission was granted to trainer Mr. Aravind. G to deputize on behalf of trainer Mr. S. Ganapathy who was unable to attend the races.
