RACING INCIDENTS
(75 - 81)

GOING : Good

PENETROMETER READING: 4.0 Cms.

RAILING POSITION: Railing fixed at average width of 9.5 Meters from 1600 Meters to winning post from its original position.

1st Race: 75. The Supervite Plate - Div. II - (About) 1200 metres. Horses rated 00 to 25 (9 Runners).

Permission was granted to Trainer Mr.Narayana Gowda V. to withdraw BARONESS (Rajesh Kumar M) on veterinary grounds as it was found to be trotting lame on left fore and cellulitis on left fore fetlock. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

JERSEY LEGEND (Salman Khan) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Mahmood Khan was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Arvind Kumar. N, the rider of BELDONA was fined Rs. 1,000/- for shifting out and causing interference to APOLLO LIGHT (S. Saqlain) on his outside approaching 300 Metres.

An enquiry is being held into the running and riding of BELDONA, trained by Mr.Kishan Thomas and ridden by Jockey Arvind Kumar. N in the above race. A written complaint with regard to the riding of Jockey Arvind Kumar. N by Owner Mr. Nanda Kumar and Trainer Mr. Kishan Thomas has also been received by the Club.

DON'S DEN (Vivek.G) sustained superficial injury on both hind fetlock.

STAR CITIZEN (Kirtish Bhagat) sustained superficial injury on both hind fetlock.

Routine Sample was taken for analysis from the winner b g OZARK.

2nd Race: 76. The Fantabulous King Plate - (About) 1200 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (Outstation horses eligible) (12 Runners).

SILVER CANYON (Akshay Kumar) walked out of the gates and lost few lengths at the start. In view of its behaviour, Trainer Mr. S.S. Attaollahi was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

THE SOUND OF MUSIC (Arvind Kumar. N) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Sharat Kumar was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey K. Nazil, the rider of SWEET TALK reported that he accidentally lost his whip passing the 300 Meters.

Routine Sample was taken for analysis from the winner b f INYOUWEBELIEVE.

3rd Race: 77. The Nawab M Arshad Ali Khan Memorial Cup - (About) 1600 metres. Horses rated 80 and above (6 Runners).

Trainer Mr. P. Shroff was fined Rs.2,000/- for not presenting his charge THE BAWAJI (N. S. Parmar) for acceptance weighing.

Trainer Mr. P. Shroff was fined Rs.5,000/- for discrepancy in shoeing in respect of his charge THE BAWAJI (1st infringement).

THE BAWAJI (N. S. Parmar) planted and did not raise a fluent gallop till the 1500 Metres. In view of its behaviour, Trainer Mr.P. Shroff was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

AUTOMATIC (P. S. Chouhan) jumped out awkwardly.

It was observed that SEA OF CORTEZ (Prashant P.Dhebe) was lugging out under pressure in the final 100 Metres of the race.

Routine Sample was taken for analysis from the winner b g TAIMUR.

4th Race: 78. The Juvenile Sprinters' Million (Grade III) - (About) 1200 metres. 3-year-old horses (foaled in 2019). (6 Runners).

Trainer Mr. Rakesh was fined Rs.2,000/- for not presenting his charge O HANSINI for acceptance weighing.

Trainer Dr. Anil Kumar was fined Rs.2,000/- for not presenting his charge KAY STAR for acceptance weighing.

Jockey A.Ashhad Asbar, the rider of KAY STAR was fined RS.1,000/- for coming 'in' and tightening the horses on his inside viz; AMRELI (A. Sandesh) and O HANSINI (P. Trevor) before passing the red marker post.

Jockey A. Sandesh, the rider of AMRELI was fined Rs.1,000/- for coming 'in' and tightening O HANSINI (P. Trevor) on his inside approaching 900 Metres.

Jockey N. S. Parmar, the rider of AYR reported that his saddle shifted back passing the 1100 Metres. After due examination of the equipment, Trainer Mr. L. D'silva was fined Rs.3,000/- for faulty saddling of his charge.

Compulsory urine and blood samples were taken for analysis from the following I,II & III placed horses viz:

5th Race: 79. The Akhal-Teke Plate - (About) 2000 metres. Horses rated 40 to 65 (8 Runners).

It was observed that PISSARRO (P. Trevor) was squeezed between PELUCHE (T. S. Jodha) and TOWERING PRESENCE (Prashant P.Dhebe) at the start.

Jockey Prashant P.Dhebe, the rider of TOWERING PRESENCE reported that he could not get a clear run passing the 500 Metres due to a closely packed field.

Jockey Arul J.H, the rider of GREEN CHANNEL reported that he accidentally lost his whip approaching 200 Metres.

It was reported after the race that TOWERING PRESENCE (Prashant P.Dhebe) pulled up lame on right fore. Trainer Mr.S.S. Attaollahi was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

STARRY WIND (Shreyas Singh S) sustained abrasion on left hind cannon.

PISSARRO (P. Trevor) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f SUCCESS.

6th Race: 80. The Lady Gibraltar Plate - (About) 1400 metres. Horses rated 20 to 45 (8 Runners).

POLISHED GIRL (Suraj Narredu) jumped out awkwardly.

Jockey T. S. Jodha, the rider of WILD EMPEROR reported that his mount was not galloping fluently from about 600 Metres. The horse was subjected to veterinary examination. On examination, it was found to have sustained superficial injury on right stifle.

Jockey Kirtish Bhagat, the rider of SINGHSAAB reported that he could not get a clear run approaching 200 Metres due to a closely packed field.

Routine Sample was taken for analysis from the winner b f POLISHED GIRL.

7th Race: 81. The Supervite Plate - Div. I - (About) 1200 metres. Horses rated 00 to 25 (9 Runners).

Permission was granted to Trainer Mr. V. Lokanath to withdraw EMERALDO on veterinary grounds as it was found to have sustained injury on withers with subcutaneous oedema and pain on palpation. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

SPEAKING OF SKIES (Rayan Ahmed R.) after jumping out swerved towards the left and did not take any practical part in the race. In view of its behaviour, Trainer Mr.Imtiaz Khan was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least two Mock Races.

CINCO DE MAYO (M. Mark) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Dheeraj.V was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Rajesh Kumar M, the rider of ELITE AGENT was fined Rs.2,000/- for coming 'in' and causing interference to THE INTRUDER (Chethan Kalay S.),whereby the rider had to check and shift out. In the process, he shifted out and bumped CINCO DE MAYO (M. Mark) approaching 900 Metres.

Jockey Salman Khan, the rider of RED LUCIFER was fined Rs.1,000/- for coming 'in' and causing interference to PORT OF BEAUTY (Shamaz Shareef) on his inside passing the 300 Metres.

It was reported after the race that ELITE AGENT (Rajesh Kumar M) pulled up lame on right hind and sustained bleeding cut injury on right hind coronet. Trainer Mr. Narayana Gowda V. was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

COMEONSON (S. Saqlain) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner ch g DEBONAIR.

Permission was granted to trainer Mr. S.S. Attaollahi to deputize on behalf of trainer Mr. K.S.V. Prasad Raju who was unable to attend the races.
