RACING INCIDENTS
(128 - 135)

GOING : Good

PENETROMETER READING: 3.6 Cms.

RAILING POSITION: Railing fixed at average width of 5.0 Metres from 1600 Metres to winning post from its original position.

1st Race: 128. The Camino Plate - Div. II - (About) 1400 metres. Horses rated 00 to 25, 5 years old and over (12 Runners).

GALLIC (Rajesh Kumar M) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Narayana Gowda V. was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Nazerul Alam, the rider of BRAMASTRAM was fined Rs.3,000/- for not making sufficient effort on his mount during the race.

AKASI (Vivek) was subjected to veterinary examination but no abnormality was reported.

An enquiry is being held into the running and riding of AKASI, trained by Mr.S. Inayathulla and ridden by Jockey Vivek in the above race.

Routine Sample was taken for analysis from the winner b m BELDONA.

2nd Race: 129. The Bishma Plate - Div. II - (About) 1400 metres. Horses rated 20 to 45, 4 years old and over (13 Runners).

LIMITED EDITION (Salman Khan) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. M. Rajendra Singh was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

JOHNNIE BLACK (V.R.Jagadeesh) took a fly jump.

Jockey Darshan R.N, the rider of PASTICHE was fined Rs.1,000/ for coming 'in' and causing interference to SUPER RUFFIAN (Hindu Singh) on his inside soon after the start.

Jockey Akshay Kumar, the rider of ELECTRIC BLUE was reprimanded for shifting 'in' and inconveniencing MARCO POLO (Shreyas Singh S) on his inside passing the 750 Metres.

JOHNNIE BLACK (V.R.Jagadeesh) ran detached from the field. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Mahmood Khan was informed to ensure better performance of his charge in future.

It was reported after the race that ELECTRIC BLUE (Akshay Kumar) burst its blood vessels. Trainer Mrs. Parvati Byramji was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g ANSALDO.

3rd Race: 130. The D. M. Kumaraswamy Memorial Trophy - (About) 1600 metres. Horses rated 40 to 65, 5 years old and over (7 Runners).

EXTRAORDINARY (Arvind Kumar. N) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.Sharat Kumar was informed not accept with it again

until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

SILVERITA (Hindu Singh) jumped out awkwardly and lost few lengths at the start. In view of its behaviour, Trainer Mr.Arjun Mangalorkar was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Angad, the rider of FOREVER TOGETHER was reprimanded for shifting 'in' and inconveniencing OMBUDSMAN (Vivek.G) on his inside passing the 1500 Metres.

Jockey Shreyas Singh S, the rider of STARRY WIND was reprimanded for shifting 'in' and inconveniencing OMBUDSMAN (Vivek.G) on his inside rounding the final bend.

Jockey Angad, the rider of FOREVER TOGETHER was fined Rs.3,000/- for the excessive use of whip on his mount during the race (1st infringement).

Routine Sample was taken for analysis from the winner b r FOREVER TOGETHER.

4th Race: 131. The Baraloy Plate - Div. II - (About) 1200 metres. Horses rated 20 to 45, 4 years old and over (9 Runners).

It was observed that THE ADVISER (Arvind Kumar. N) finished the race on the sand track work in the final 100 Metres. In view of its behaviour, Trainer Mr.Sharat Kumar was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least two Mock Races. *An enquiry is being held into the incident.*

ARTESIAN (S. Hussain) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.S. Narredu was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

It was reported after the race that ARTESIAN (S. Hussain) pulled up lame on left fore approaching 800 Metres. Trainer Mr. S. Narredu was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

JAVA PENINSULA (Rajesh Kumar M) sustained injury on head after the fall during the race and died due to shock.

SAINTHOOD (Chethan Kalay S.) was unable to bear weight on both hind after the fall during the race possibly due to spinal cord injury. Hence, it was euthanized.

It was observed that JAVA PENINSULA (Rajesh Kumar. M) slipped from its hind, lost its footings, dislodging the rider and DOMINA (S. John) shifted out, took an evasive action and caused interference to SAINTHOOD (Chethan Kalay.S) who was also dislodged from his mount, while he collided with the prostrated horse, further DOMINA (S. John) took out RULE OF LAW (Vishal N Bunde) and DON'S DEN (V.R. Jagadeesh) on his outside. Subsequently, ARTESIAN (S. Hussain) stuck one of the prostrated horse passing the 1000 Metres. *A detailed enquiry is being held into this incident.*

Routine Sample was taken for analysis from the winner ch g THE ADVISER.

5th Race: 132. The Bangalore St.Leger (Grade II) - (About) 2800 metres. Indian Horses 4 years old and over (Foaled in 2018 or before). (4 Runners).

Trainer Mr. Pratap Kamath M was fined Rs.10,000/- for not declaring his charge FLASH BOND to start after having accepted to run with it in the above race.

Jockey Suraj Narredu, the rider of SPEEDSTER was fined Rs.1,000/- for coming 'in' and causing interference to PISSARRO (P. Trevor) on his inside soon after the start.

Compulsory urine and blood samples were taken for analysis from the following I,II & III placed horses viz:

6th Race: 133. The Bhishma Plate - Div. I - (About) 1400 metres. Horses rated 20 to 45, 4 years old and over (11 Runners).

Permission was granted to Trainer Mr.Pradeep Annaiah to withdraw LAGOPUS (A.R.Pradeep) on veterinary grounds as it was found to be trotting lame on left fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Nazerul Alam replaced the indisposed Jockey Rajesh Kumar.M on AFERPI.

THREE ACES (S. Saqlain) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. V. Lokanath was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Suraj Narredu, the rider of DRAGON'S GOLD reported that his saddle shifted back soon after the start. After due examination of the equipment, Trainer Mrs. Parvati Byramji was fined Rs.3,000/- for faulty saddling of her charge.

ACASTER (Y. S. Srinath) sustained superficial injury on tongue.

Routine Sample was taken for analysis from the winner dk b g ACASTER.

7th Race: 134. The Baraloy Plate - Div. I - (About) 1200 metres. Horses rated 20 to 45, 4 years old and over (10 Runners).

Jockey Angad, the rider of TWILIGHT FAME was severely reprimanded for not exercising sufficient control over his mount, whereby he struck the front runner CLASSIC CHARM (P. Trevor) passing the 1000 Metres.

Jockey Arvind Kumar. N, the rider of THE RESPONSE was fined Rs.3,000/- for travelling wide from 900 Metres till about 400 Metres for no apparent reason.

Jockey Mudassar Nazar, the rider of OCEAN DUNES reported that he accidentally lost his whip passing the 350 Meters.

Jockey Rayan Ahmed R., the rider of LADY SUPREMOS was fined Rs.1,000/- for coming 'in' and tightening DIVINE BLESSINGS (S. John) on his inside passing the 150 Metres.

Jockey S. John, the rider of DIVINE BLESSINGS reported that he could not get a clear run in the final 100 Metres.

It was reported after the race that UNIQUE STYLE (V.R.Jagadeesh) burst its blood vessels. Trainer Mr. V. Lokanath was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

TENALI (Akshay Kumar) sustained superficial injury on left hind pastern.

CLASSIC CHARM (P. Trevor) sustained superficial cut injury on left hind gaskin.

Routine Sample was taken for analysis from the winner b g TENALI.

8th Race: 135. The Camino Plate - Div. I - (About) 1400 metres. Horses rated 00 to 25, 5 years old and over (12 Runners).

Jockey Nazerul Alam replaced the indisposed Jockey Chethan Kalay.S on SHE'S INNOCENT.

CHARMAINE (Vishal N Bunde) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.V. Lokanath was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

DARING SWEETHEART (S.Mubarak) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Mahmood Khan was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Darshan R.N, the rider of ALTAMONTE reported that his mount was not galloping fluently from the 600 Metres, as such he could offer much assistance thereafter. The horse was subjected to veterinary examination. On endoscopy it was found to have sand particles throughout the trachea due to kick back.

It was reported after the race that DARING SWEETHEART (S.Mubarak) pulled up lame on right fore. Trainer Mr.Mahmood Khan was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

CHARMAINE (Vishal N Bunde) was subjected to veterinary examination. On examination, it was found to have bit sore on left oral commissure.

HE'S THE ONE (Vinod Shinde) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b r ANOTHER RAINBOW.

Permission was granted to trainer Mr. B. Prithviraj to deputize on behalf of trainer Mr. Irfan Ghatala who was unable to attend the races.

ADDITIONAL REPORTS
BANGALORE SUMMER MEETING 2022
ELEVENTH DAY, SATURDAY , 25TH JUNE, 2022

(A)

Race: 64. The Chief Justice's Cup (Grade III) - (About) 1800 metres. 4 years old and over.

The Stipendiary Stewards reported Jockey P.S. Chouhan to the Stewards for Contravention of Rule No. 159 (b) of the B.T.C. Rules of Racing on his mount THEON in the above race.

The Stewards held an enquiry on 22nd July, 2022 and examined Jockey P.S.Chouhan.

The Stewards considered the following:

- (a) Charge sheet issued to Jockey P.S. Chouhan by the Stipendiary Stewards;
- (b) The Submissions made by the Jockey P.S. Chouhan during the enquiry with regards to loss of his whip;
- (c) Stewards viewed various angels of the race with specific reference to the loss of whip by Jockey P.S. Chouhan at a very crucial stage of the race;

The Stewards after considering all of the above decided to give a grave benefit of doubt to Jockey P.S. Chouhan on his mount THEON at this instance and note his explanations for future.

(B)

Race: 65. The Everynsky Plate - (About) 1400 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (Outstation horses eligible).

The Stipendiary Stewards reported Jockey Anjar Alam to the Stewards for Contravention of Rule No. 159 (b) of the B.T.C. Rules of Racing on his mount QUEEN ENVIED.

The Stewards held an enquiry on 22nd July, 2022 and examined Jockey Anjar Alam and Trainer Mr. Irfan Ghatala.

The Stewards considered the following:

- (a) Charge sheet issued to Jockey Anjar Alam by the Stipendiary Stewards;
- (b) The Submissions made by Jockey Anjar Alam and Trainer Mr. Irfan Ghatala during the enquiry;
- (c) Stewards viewed the various angels of the race with specific reference to the riding of Jockey Anjar Alam;

- (d) The Stewards noted that Jockey Anjar Alam had pleaded guilty of alleged breach for Contravention of Rule No. 159 (b) under BTC Rules of Racing as charged by the Stipendiary Stewards;

The Stewards, thereafter using their wisdom and experience, arrived at a unanimous decision that Jockey Anjar Alam was "**Guilty**" as charged in the matter.

In the light of above, the Stewards decided as under:

- (a) To treat Jockey Anjar Alam as a disqualified person from **2-8-2022 to 1-2-2023 (Both days inclusive)** for contravention of Rule No. 159 (b) of the BTC Rules of Racing on his mount QUEEN ENVIED (he is not permitted to ride work).
- (b) To fine Trainer Mr. Irfan Ghatala a sum of Rs. 25,000/- for the unsatisfactory explanations tendered by trainer during the enquiry in respect of his charge QUEEN ENVIED;
- (c) Trainer and Jockey were informed of their right to appeal.

ORDER OF THE STEWARDS
THIRD DAY, SATURDAY , 28TH MAY, 2022

Race: 8. The Diablo Plate - Div. I - (About) 1200 metres. Horses rated 20 to 45.

Detection of prohibited substances in the urine sample of b.g FLYING QUEST.

The Stewards of the Bangalore Turf Club Ltd. at their meeting held on Friday, 22nd July, 2022 considered the Charge Sheet No: 793 dated 20/7/2022 submitted by Stipendiary Steward pertaining to the positive finding of PHENYLBUTAZONE & OXYPHENBUTAZONE – (Class IV) AND INDOMETHACIN - (Class III) (prohibited substances) in the urine sample taken from b.g FLYING QUEST winner of Race No.8 of the Bangalore Summer Meeting 2022 i.e. THE DIABLO PLATE DIV. I (about) 1200 Metres, Horses rated 20 to 45, run on Saturday, 28th May, 2022. The horse trained and owned by Mr. Mahmood Khan.

The Stewards examined trainer Mr. Mahmood Khan and after deliberations decided to suspend the trainer's licence granted to him from **2nd August, 2022 to 16th September, 2022** (both days inclusive) and fine him a sum of Rs.30,000/- as contained in BTC Calendar Notification under the heading "Medication and treatment of horses in Training and Racing and Anti-Doping Control of Medication Rules" in respect of his charge **b.g FLYING QUEST** reading as follows:

"RULE No. 23.

The Trainer shall always be responsible and accountable at all times for:-

- (a) The management, administration, supervision, security and control of horses and of stable employees under his/her charge;

(b) The feeding, feed supplements, treatment, stable routine, management, protection and security of the horses in his/her stable;

(c) For ensuring that only Veterinarians approved by the Stewards inject or otherwise treat horses in his/her care;

(d) For ensuring that no person is employed as a stable employee in connection with any horse in his/her care unless such person holds a license from the appropriate Authority.

He was further fined a sum of Rs.50,000/- for the Contravention of Rule No. 19 under the heading "Medication and treatment of horses in Training and Racing and Anti-Doping Control of Medication Rules" reading as follows:

"RULE No. 19.

A trainer must record in his log book (hand written) any medication or treatment administered to any horse in the trainer's care by midnight on the day on which the administration was given."

In that he failed to maintain a medical log book in accordance with the said rule.

He was informed of his right to appeal.
