**RACING INCIDENTS**  
**(165 - 172)**

**GOING : Soft**

**PENETROMETER READING: 4.8 Cms.**

**RAILING POSITION: Railing fixed at average width of 3.0 Metres from 1600 Metres to winning post from its original position.**

**1<sup>st</sup> Race: 165. The Mughal Garden Stakes - Div. II - (About) 1200 metres. Horses rated 00 to 25 (12 Runners).**

AIR DISPLAY (Salman Khan) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.S. Inayathulla was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

ULTIMATE CHOICE (Shreyas Singh S) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Prithviraj B. was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

GALLIC (Harish B.) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Narayana Gowda V. was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey A.R.Pradeep, the rider of BELLI DEEPA reported that he momentarily lost its left rein passing the 1100 Metres which he regained within a few strides.

Jockey Darshan R.N, the rider of SOUTHERN CHROME reported that his mount was not galloping fluently throughout the race and it ran detached from the field. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Aravind G. was informed to ensure better performance of his charge in future.

Jockey B. Nayak, the rider of CHANDRA KANTA was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

Jockey R. Vaibhav, the rider of OSIBISA was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

Routine Sample was taken for analysis from the winner ch g TIGER RETURNS.

**2<sup>nd</sup> Race: 166. The Winslow Stakes - Div. II - (About) 1200 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (Outstation horses eligible) (10 Runners).**

Permission was granted to Trainer Mr. S. Ganapathy to withdraw QUICK WITTED (Vivek.G) on veterinary grounds as it was found to be suffering from fever and diarrhoea. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Permission was granted to trainer Mr. Sharat Kumar to withdraw THE STRIKINGLY (Arvind Kumar. N) from the above race.

Jockey S. Hussain, the rider of GOLDEN RING was fined Rs.3,000/- for coming 'in' and causing interference to the horses on his inside viz; THE PIRATE (A.R.Pradeep) and FIREFINCH (Salman Khan) passing the 1000 Metres.

Jockey A.R.Pradeep, the rider of THE PIRATE was fined Rs.1,000/- for shifting out and taking out SOUTHERN FORCE (Rayan Ahmed R.) and MASTEROFTHE SKIES (P. Sai Kumar) on his outside approaching 800 Metres.

Jockey Vinod Shinde, the rider of STARS ABOVE reported that his mount was running green throughout the race.

FIREFINCH (Salman Khan) sustained bleeding cut injury on right hind pastern.

Routine Sample was taken for analysis from the winner ch f MY SOLITAIRE.

**3<sup>rd</sup> Race: 167. The Mussoorie Stakes - (About) 1600 metres. Horses rated 40 to 65, 4 years old and over (8 Runners).**

Trainer Mr. S.S. Attaollahi and Jockey P.Trevor were questioned regarding the poor performance of PINK JASMINE. The Jockey stated that his instructions were to ride his own race and do his best in the straight. However, his mount travelled keenly till about 400 meters, but when asked for an effort his mount did not quicken and he attributed the same to the sticky ground. The trainer while corroborating the statements of the jockey also felt that the ground did not suit the running of his charge. Their explanations were noted for future reference.

TOWERING PRESENCE (S. Saqlain) was subjected to veterinary examination but no abnormality was reported.

Trainer Mr. Arjun Mangalorkar was fined Rs.10,000/- for having accepted his charge SILVERITA to run in the above race when he was specifically told not to accept with it (after its run in Race No. 130 of the Bangalore Summer Meeting 2022) until its behavior improved to the satisfaction of the Stipendiary Stewards in at least one jump out of the starting gate practice day.

Routine Sample was taken for analysis from the winner b g IMPERIAL BLUE.

**4<sup>th</sup> Race: 168. The Winslow Stakes - Div. I - (About) 1200 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (Outstation horses eligible) (12 Runners).**

It was reported after the race that AGERA (A.R.Pradeep) had apparently lost its left fore shoe during the race.

Routine Sample was taken for analysis from the winner b g STAR ADMIRAL.

**5<sup>th</sup> Race: 169. The Kimberley Stakes - (About) 1200 metres. Horses rated 60 to 85 (5 Runners).**

Permission was granted to Trainer Mr.Faraz Arshad to withdraw HUKUM (Mohammed Aliyar) on veterinary grounds as it was found to be walking lame on right hind. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

GRIFFIN (L. Alex Rozario) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Irfan Ghatala was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Arul J.H, the rider of LUCKY CHANCE was fined Rs.1,000/- for shifting 'in' and tightening TACTICAL COMMAND (S. John) on his inside passing the 450 Metres.

Trainer Mr. S.S. Attaollahi and Jockey P. Trevor were questioned regarding the poor performance of DE VILLIERS. The Jockey stated that he was asked to ride his own race and do his best in the straight. However, his mount stopped galloping in the last 250 Metres of the race and he also thought that his mount may have burst its blood vessels. The trainer stated that his charge was running after a very long layoff, carrying top weight in the above class for the first time and he could not attribute any other specific reason for its poor performance. Their explanations were noted for future reference and the horse was impounded for veterinary examination but no abnormality was reported.

Surprise sample was taken for analysis from b g DE VILLIERS.

Routine Sample was taken for analysis from the winner b g THOUSAND WORDS.

**6<sup>th</sup> Race: 154. The Bangalore Summer Million (Grade III) - (About) 1600 metres. 3-year-old horses (foaled in 2019). (8 Runners).**

Jockey A. Sandesh, the rider of SHABELLE reported that he could not get a clear vision between the 1100 Metres till about 500 Metres due to the kick back of the track. His explanations were noted for future reference.

Jockey Vinod Shinde, the rider of ARDAKAN reported that his mount stopped galloping in the last 200 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

TRIPLE WISH (Hindu Singh) sustained superficial injury on right hind pastern.

Compulsory urine and blood samples were taken for analysis from the following I,II & III placed horses viz:

**7<sup>th</sup> Race: 170. The Kanva Stakes - (About) 1200 metres. Horses rated 40 to 65 (11 Runners).**

POWERFUL LADY (S. Saqlain) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Arjun Mangalorkar was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey A.R.Pradeep, the rider of DEL MAR was reprimanded for travelling wide between the 900 Metres till about 500 Metres for no apparent reason.

THE INHERITOR (Suraj Narredu) was impounded for veterinary examination but no abnormality was reported.

Surprise sample was taken for analysis from dk b g THE INHERITOR.

Routine Sample was taken for analysis from the winner b m AZTEC QUEEN.

**8<sup>th</sup> Race: 171. The Himalaya Stakes - (About) 1200 metres. Horses rated 20 to 45 (12 Runners).**

Jockey P. Sai Kumar replaced the indisposed Jockey R. Vaibhav on GOLD GRAY.

LIMITED EDITION (Salman Khan) after jumping out refused to raise a fluent gallop and ran detached thereafter. In view of its behaviour, Trainer Mr.M. Rajendra Singh was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Harish B., the rider of TWILIGHT FAME was fined Rs.1,000/- for shifting 'in' and causing interference to GOLD GRAY (P. Sai Kumar) on his inside passing the 1000 Metres.

Jockey S. Hussain, the rider of DEBONAIR was fined Rs.10,000/- for riding in a careless manner in that for coming 'in' and causing severe interference to the horses on his inside viz; SINGHSAAB (IndraJeet Singh) and DOMINA (S. John) approaching 900 Metres and for further shifting 'in' and causing interference to INEXHAUSTIBLE (Nazerul Alam) on his inside passing the 750 Metres.

Jockey P. Sai Kumar, the rider of GOLD GRAY reported that he could not get a clear run between the 350 Metres to 300 Metres.

Jockey Arvind Kumar. N, the rider of ALTAIR reported that his mount was hanging 'in' in the last 300 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

An enquiry is being held into the running and riding of DOMINA, trained by Mr. Arjun Mangalorkar and ridden by Jockey S. John in the above race.

Routine Sample was taken for analysis from the winner dk b f LADY SUPREMOS.

**9<sup>th</sup> Race: 172. The Mughal Garden Stakes - Div. I - (About) 1200 metres. Horses rated 00 to 25 (11 Runners).**

Trainer Mr. Faraz Arshad was fined Rs.10,000/- for not declaring his charge FIERCE FIGHTER to start after having accepted to run with it in the above race.

ALTAMONTE (IndraJeet Singh) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.S. Inayathulla was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Darshan R.N, the rider of PASTICHE reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey Adarsh G., the rider of INFINITE SPIRIT reported that his mount was hanging out after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey Vivek.G, the rider of SOLO PRINCE reported that he momentarily lost his left rein passing the 200 Metres.

Routine Sample was taken for analysis from the winner b g FOVEAL VISION.
