RACING INCIDENTS

(180-187)

GOING : Good

PENETROMETER READING: 3.1 Cms.

RAILING POSITION: Railing fixed at average width of 7.0 Meters from 1600 Meters to winning post from its original position.

1st Race: 180. The Bold Gesture Stakes - Div. II - (About) 1400 metres. Horses rated 00 to 25 (10 Runners).

SLING SHOT (Vivek.G) was extremely fractious, ducked down from the front gate after being stalled in the starting gates, in the process the saddle had completely shifted back. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

Jockey Ravi R., the rider of IMMORTAL GUEST was reprimanded for shifting out and inconveniencing SAND CASTLES (Vivek) on his outside approaching 1100 Metres.

Jockey Vinod Shinde, the rider of HE'S THE ONE reported that the saddle shifted back at about 800 Meters. After due examination of the equipment, Trainer Mr.V. Lokanath was fined Rs.3,000/- for faulty saddling of his charge.

Jockey L. Alex Rozario, the rider of RED LUCIFER reported that his mount shied from the rails passing the 800 Metres.

ARECA ANGEL (Harish B.) sustained abrasion on right hind cannon.

IMMORTAL GUEST (Ravi R.) sustained abrasion on left hind pastern and right hind coronet.

Routine Sample was taken for analysis from the winner b g THE OMEGA MAN.

2nd Race: 181. The Basque Stakes - Div. II - (About) 1200 metres. Horses rated 20 to 45, 4 years old and over (8 Runners).

Jockey Rayan Ahmed R., the rider of BELVEDERE reported that he had to steady his mount passing the 1000 Metres due to a closely packed field.

It was observed that Jockey Nazerul Alam, the rider of SKY PRINCESS had to steady his mount to avoid striking the front runner ALTAIR (Arvind Kumar. N) passing the 800 Metres.

Jockey S. Saqlain, the rider of STRIKING POINT reported that his mount was drifting out under pressure in the final 200 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey Vivek.G, the rider of BENEDICTION was reprimanded for shifting 'in' and inconveniencing BELVEDERE (Rayan Ahmed R.) on his inside passing the 150 Metres.

It was reported after the race that BELVEDERE (Rayan Ahmed R.) pulled up lame on left fore and burst its blood vessels. Trainer Mr. Faraz Arshad was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner dk b g BENEDICTION.

3rd Race: 182. The Justice P. Medapa Memorial Cup - Div. II - (About) 1400 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (Outstation horses eligible) (7 Runners).

Jockey P. Trevor replaced the indisposed Jockey Y.S. Srinath on SIEGE COURAGEOUS.

XIOMARA (Rayan Ahmed R.) was extremely fractious, reared up while being loaded into the starting gates, dislodge the rider and in the process was hit hard over the left knee and right fore pastern of the rear gate adjacent stall. On immediate examination by the Club's Veterinary Officer and was found to have sustained injury on right fore pastern. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr.Dheeraj. V (is deputizing on behalf of Trainer Mr. S. Dominic) was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

SPLENDIDO (A. Sandesh) jumped awkwardly outwards and inconvenienced BELLISSIMO (Vivek.G) and GOLDEN STARLET (Harish B.) on its outside soon after the start.

SIEGE COURAGEOUS (P. Trevor) sustained superficial clip injury on left hock and right hind fetlock.

Routine Sample was taken for analysis from the winner ch c SPLENDIDO.

4th Race: 183. The Kunigal Stud Stakes - (About) 1400 metres. Horses rated 40 to 65, 4 years old and over (7 Runners).

Permission was granted to Trainer Mr. S.S. Attaollahi to withdraw RULING GODDESS on veterinary grounds as it was found to be suffering from fever. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Arvind Kumar. N, the rider of EXTRAORDINARY reported that he momentarily lost his right rein passing the 150 Metres which he regained within a few strides, in the process shifted out and inconvenienced DOUGLAS (P. Trevor) and IN A BREEZE (L. Alex Rozario).

It was reported after the race that IN A BREEZE (L. Alex Rozario) had apparently lost its left fore shoe during the race.

DOUGLAS (P. Trevor) was impounded for veterinary examination but no abnormality was reported.

Surprise sample was taken for analysis from b g DOUGLAS.

Routine Sample was taken for analysis from the winner b g PEYO.

5th Race: 184. The Justice P. Medapa Memorial Cup - Div. I - (About) 1400 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (Outstation horses eligible) (7 Runners).

Permission was granted to Trainer Mr. James Mckeown to withdraw RUBIROSA (Hindu Singh) on veterinary grounds as it was found to be lame on left fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Suraj Narredu replaced the indisposed Jockey Y.S. Srinath on SERDAR.

Jockey Nazerul Alam, the rider of SUPER VELOCE reported that he lost his left rein passing the 200 Metres, which he regained within a few strides.

It was reported after the race that DOMINGO (S. Zervan) pulled up lame on left hind. Trainer Mr. Neil Darashah was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner ch f KULSUM.

6th Race: 185. The Quasar Stakes - (About) 1600 metres. Horses rated 20 to 45 (8 Runners).

Jockey P. Trevor replaced the indisposed Jockey Y.S. Srinath on STAR COMET.

Jockey Nazerul Alam, the rider of MOVING AHEAD reported that his mount was not galloping fluently throughout the race. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey Hindu Singh, the rider of PERIDOT reported that his mount was running green throughout the race.

Jockey Md. Akram, the rider of STARRY WIND reported that he accidentally lost his whip passing the 100 Meters.

Urine and blood sample were taken for analysis from b r ANOTHER RAINBOW.

Routine Sample was taken for analysis from the winner ch c TRANQUILO.

7th Race: 186. The Basque Stakes - Div. I - (About) 1200 metres. Horses rated 20 to 45, 4 years old and over (8 Runners).

Jockey M. Prabhakaran, the rider of FLYING QUEST reported that his mount was making a roaring noise during the race. The horse was subjected to veterinary examination. On examination, it was found to have burst its blood vessels. Trainer Mr. S. Inayathulla was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b f MARK ONE.

8th Race: 187. The Bold Gesture Stakes - Div. I - (About) 1400 metres. Horses rated 00 to 25 (11 Runners).

Jockey Salman Khan, the rider of TURKOMAN reported that his mount was hanging 'in' after entering the straight. Trainer Mr. S. Padmanabhan was informed to take appropriate corrective measures before accepting with it again.

RUDRAM (Nazerul Alam) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f SUPER RUFFIAN.

Permission was granted to trainer Mr. Dheeraj. V to deputize on behalf of trainer Mr. S. Dominic who was unable to attend the races.
