1st Race: 188. The Happy Valley Plate - (About) 1600 metres. Horses rated 00 to 25 (11 Runners).

Permission was granted to Trainer Mr.Pradeep Annaiah to withdraw BELLI DEEPA (Nazerul Alam) on veterinary grounds as it was found to have phlebitis of left Jugular Vein. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again. *An enquiry is being held into the matter.*

It was reported after the race that DRUMS OF WAR (S. Saqlain) burst its blood vessels and sustained clip injury on right hock and right hind cannon. Trainer Mr. S. Padmanabhan was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Arvind Kumar. N, the rider of ECO FRIENDLY was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

Compulsory urine and blood samples were taken from b m BELLI DEEPA.

Routine Sample was taken for analysis from the winner b c SUNSHINE PRINCE.

2nd Race: 189. The World Photography Day Cup - Div. II - (About) 1400 metres. Horses rated 20 to 45, 4 years old and over (12 Runners).

NOBLE RULER (Vivek.G) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. S. Ganapathy was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

FICTIONEER (Rayan Ahmed R.) reared up as the gates opened, did not raise a fluent gallop, whereby the rider lost his left stirrup at the start, which he regained within a few strides. In view of its behaviour, Trainer Mr. Sriram Komandur was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

It was reported after the race that MEASURE OF TIME (T. S. Jodha) burst its blood vessels. Trainer Mr. Faraz Arshad was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

An enquiry is being held into the running and riding of KINGS SPEECH, trained by Mr. Dheeraj. V and ridden by Jockey S. Hussain in the above race.

ELITE AGENT (Angad) was subjected to veterinary examination but no abnormality was reported.

Compulsory urine and blood sample were taken for analysis dk b g KINGS SPEECH.

Routine Sample was taken for analysis from the winner b g OSIRIS.

3rd Race: 190. The Champion Jockey Stakes - (About) 1200 metres. Horses rated 20 to 45 (8 Runners).

WAY OF LIFE (Tousif Khan) jumped out awkwardly.

Jockey Arvind Kumar. N, the rider of THE GOLDEN DREAM was fined Rs.2,000/- for not wearing goggles during the race.

Jockey Arvind Kumar. N, the rider of THE GOLDEN DREAM was fined Rs.5,000/- for the excessive use of the whip on his mount during the race (2nd infringement).

Routine Sample was taken for analysis from the winner b f PRIME ABBESS.

4th Race: 191. The Champion Trainer Stakes - (About) 1600 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (Outstation horses eligible) (12 Runners).

Jockey T. S. Jodha replaced the indisposed Jockey Y.S. Srinath on TREVALIUS.

KING POMPOUS (Vinod Shinde) jumped awkwardly inwards onto STORMY OCEAN (A. Sandesh) soon after the start.

Jockey Suraj Narredu, the rider of SHAMROCK reported that his mount was lugging 'in' under pressure in the final 150 Metres of the race.

SALENTO (Akshay Kumar) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b c SHAMROCK.

5th Race: 192. The Leading Stud Stakes - (About) 1400 metres. Horses rated 80 and above (7 Runners).

Jockey T. S. Jodha replaced the indisposed Jockey Y.S. Srinath on AUTOMATIC.

TRAFALGAR (S. Saglain) sustained superficial injury on right hind tendon.

Routine Sample was taken for analysis from the winner b r TRAFALGAR.

6th Race: 193. The Leading Owner Stakes - (About) 1200 metres. Horses rated 40 to 65 (9 Runners).

Jockey L. Alex Rozario, the rider of GARAMOND was fined Rs.3,000/- for coming 'in' and causing interference to ELUSIVE GIRL (Arul J.H), which in turn passed it onto STAR GLORY (Suraj Narredu) on his inside passing the 1000 Metres.

It was observed that GENERAL PATTON (Hasib Alam) accidentally struck the front runner DONNA BELLA (Salman Khan) passing the 800 Metres.

It was reported after the race that GARAMOND (L. Alex Rozario) burst its blood vessels. Trainer Mr. Irfan Ghatala was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

MYSTIC EYE (Akshay Kumar) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g YUKAN.

7th Race: 194. The World Photography Day Cup - Div. I - (About) 1400 metres. Horses rated 20 to 45, 4 years old and over (11 Runners).

Permission was granted to Trainer Mr. Faraz Arshad to withdraw SOUTHERN POWER (T. S. Jodha) on veterinary grounds as it was found to have capped elbow. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Hindu Singh, the rider of ALEEF reported that his mount was not galloping fluently throughout the race. The horse was subjected to veterinary examination. On examination, it was found to have sharp molars. Hence, Trainer Mr. S. Inayathulla was fined Rs.3,000/- for his negligence.

Jockey Surya.P, the rider of ALMANACH was fined Rs.1,000/- for shifting 'in' and causing interference to WINMYLOVE (S. John) on his inside soon after the start.

Jockey Arul J.H, the rider of AHERNE was fined Rs.2,000/- for not exercising sufficient control on his mount, thereby causing interference to STRIKING MEMORY (S. Saglain) passing the 200 Metres.

Routine Sample was taken for analysis from the winner b g MEMORITER.

ADDITIONAL REPORTS BANGALORE SUMMER MEETING 2022 SIXTH DAY, SUNDAY, 5TH JUNE, 2022

Race: 28. The DT Racing & Breeding LLP Juvenile Million (Grade III) - (About) 1400 metres. 3-year-old horses (foaled in 2019).

An enquiry was held into the running and riding of ARCANA, trained by Mr. Deshmukh L. V. R. and ridden by Jockey Suraj Narredu in the above race. The trainer stated that he had instructed to Jockey Suraj Narredu to ride from a forward position and do his best in the straight since he had won on it in Hyderabad. The Jockey corroborated the statement of the trainer, however added that the horse was hanging 'in' very badly in the final 250 Metres of the race, as such the horse was subjected to veterinary examination on 6-6-2022. After due examination, the Club's Veterinary Officer reported that it was found to have sore shin on left fore and (on Endoscopy – it was found to have dorsal displacement of soft palate). Trainer Mr.Deshmukh L. V. R. was informed to produce Fitness Certificate from the Club's Veterinary Officer before accepting with it again. As such no further action was taken beyond noting the incident.

NINTH DAY, SATURDAY, 18TH JUNE, 2022

Race: 52. The Treasure Girl Plate - Div. I - (About) 1200 metres. Horses rated 20 to 45, 5 years old and over.

An enquiry was held into the running and riding of SEE MY HEELS, trained Mr. S. Narredu and ridden by Jockey Suraj Narredu in the above race. The Jockey stated that his mount was hanging very badly in spite of him using the whip in the right, he also added that if he had not stop riding and pulled out the mount it would have gone into the rail. The trainer stated that he would have won the race if his charge would not have received an interference when asked about the horse hanging 'in', he stated that it was because of the soft going. Their explanations were noted for future reference. At the behest of the Stewards the Club's Veterinary Officer examined SEE MY HEELS at 7:30 P.M and was found to have sustained abrasion on right hind fetlock inside and left hind cannon, hock outside. However, the horse was trotting sound.

FOURTEENTH DAY, SUNDAY, 3rd JULY, 2022

(A)

Race: 82. The Brave Dancer Plate - (About) 1400 metres. Horses rated 00 to 25.

An enquiry was held into the poor performance of OSIBISA, trained by Mr.Sharat Kumar and ridden by Jockey Arul J.H in the above race as compared to its previous run in Race No. 47 i.e., The Dupont Plate, (about) 1600 Metres, Horses rated 00 to 25, run on Saturday, 18th June, 2022 wherein it placed 2nd. The trainer stated that the horse was a very nervous which was evident before the start of the above race his charge was sweating too much and was not concentrative in the race. The Jockey while corroborating the statement of the trainer stated that the horse was not galloping fluently in the last 300 Metres of the race. Their explanations were noted for future reference. However, the horse was impounded for veterinary examination. On examination, it was found to have sustained superficial injury on right hock.

Race: 87. The July Plate - (About) 1600 metres. Horses rated 20 to 45, 5 years old and over.

An enquiry was held into the relatively improved performance of JOHNNY BRAVO, trained by Mr. Neil Darashah and ridden by Jockey Nikhil Naidu in the above race as compared to its previous run in Race No. 43 i.e., The Royal Command Plate, (about) 1600 Metres, Horses rated 20 to 45, 4 years old and over run on 12/6/2022 wherein it unplaced. The trainer stated that after its poor performance in Race No. 43 he gave his charge enough time and prepared it in that three weeks gap. However, it was also to note that he had run in an age group race with a weaker company where he won and his charge had clocked a better timing in the open class when it ran unplaced. He also added that he had not fancied the horse to win. His explanations were noted for future reference.

SIXTEENTH DAY, SUNDAY, 10th JULY, 2022

Race: 101. The Prabalo Plate - (About) 1200 metres. Horses rated 20 to 45.

An enquiry was held into the running and riding of THE RESPONSE, trained by Mr.Sharat Kumar and ridden by Jockey Arvind Kumar. N in the above race. The trainer stated that he had instructed the jockey to ride from the mid bunch and do his best in the straight. The Jockey had ridden as per the instructions of the trainer. However, could only finish a far away third despite his best efforts. The Jockey while corroborating the statements of the trainer added that his mount was exhausted in the final 100 Metres. Their explanations were noted for future reference.

SEVENTEENTH DAY, SATURDAY, 16th JULY, 2022

Race: 103. The Sports Authority of India Trophy - Div. I - (About) 1400 metres. Horses rated 20 to 45, 4 years old and over.

An enquiry was held into the running and riding of MOVING AHEAD, trained by Mr. Kishan Thomas and ridden by Jockey A.Ashhad Asbar in the above race. The trainer stated that take a good jump, sit in the mid bunch, come into the straight and do his best in the straight. His charge was running after a long time the horse had a back problem earlier, the owner was in BAN as such he could not run it for a long time. The Jockey while corroborating the statement of the trainer added that the horse was lethargic, as such he had to niggle it all the way and he did his best in the straight. However, he could only finish a far away fourth. Their explanations were noted for future reference.

TWENTIETH DAY, SUNDAY, 24th JULY, 2022

Race: 131. The Baraloy Plate - Div. II - (About) 1200 metres. Horses rated 20 to 45, 4 years old and over.

An enquiry was held on Wednesday, 17th August, 2022 with regard to the fall of horse JAVA PENINSULA whereby Jockey Rajesh Kumar was also dislodged from his mount and also the incident pertaining to the fall of SAINTHOOD (Chethan Kalay.S). After due enquiry, it was noted after watching the CCTV

replay of the race, it is clearly established that JAVA PENINSULA slips from behind, i.e., both hind slipping on the ground and fell down as results of which the fore legs also got unbalanced and the horse fell flat on the track dislodging its rider. As the incident was accidental no action was taken beyond noting the incident.

TWENTYFIRST DAY, SATURDAY, 30th JULY, 2022

Race: 137. The Smart Chieftan Plate - (About) 1400 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (Outstation horses eligible).

An enquiry was held into the running and riding of DOMINGO, trained by Mr. Neil Darashah and ridden by Jockey A. Sandesh in the above race. The trainer stated that he had instructed the jockey to ride from a box seat position gradually improve and do his best in the straight. The Jockey while corroborating the statement of the trainer added that in the last 150 Metres his mount was hesitant to pass the winner despite his best efforts in riding his mount with the aid of whip he could only finish a close second. Their explanations were noted for future reference.

ORDER OF THE STEWARDS BANGALORE SUMMER MEETING 2022 THIRTEENTH DAY, SATURDAY, 2nd JULY, 2022

Race: 75. The Supervite Plate - Div. II - (About) 1200 metres. Horses rated 00 to 25.

Detection of prohibited substances in the urine sample of b g OZARK.

The Stewards of the Bangalore Turf Club Ltd. at their meeting held on Wednesday, 17th August, 2022 considered the Charge Sheet No: 794 dated 14/8/2022 submitted by Stipendiary Steward pertaining to the positive finding of PHENYLBUTAZONE & OXYPHENBUTAZONE – (Class IV) (prohibited substances) in the urine sample taken from b.g OZARK winner of Race No.75 of the Bangalore Summer Meeting 2022 i.e. The Supervite Plate – Div. II – (About) 1200 metres. Horses rated 00 to 25, run on Saturday, 2nd July, 2022. The horse trained by Mr. M. Rajendra Singh and owned by Mr. Syed Muheeb.

The Stewards after duly considering the Charge Sheet and examined trainer Mr. M. Rajendra Singh noted the oral submissions made by him during the enquiry as regards this matter concluded as under:

- (a) Noted that he had pleaded guilty of alleged breach of Rule Nos. 19 and 25 as charged by the Stipendiary Steward with regards to Medication Rules.
- (b) To fine him a sum of Rs. 40,000/- (1st infringement) for the positive finding of PHENYLBUTAZONE & OXYPHENBUTAZONE (Class IV) (prohibited substances) in the urine sample taken from b.g OZARK as contained in BTC Calendar Notification under the heading "Medication and treatment of horses in Training and Racing and Anti-Doping Control of Medication Rules".
- (c) Thereafter, the Stewards decided to fine trainer Mr. M. Rajendra Singh a sum of Rs. 1,00,000/- for contravening Rule Nos. 19 and 25 of the Medication Rules.

(d) He was informed of his right to appeal.

"RULE No. 23.

The Trainer shall always be responsible and accountable at all times for:-

- (a) The management, administration, supervision, security and control of horses and of stable employees under his/her charge;
- (b) The feeding, feed supplements, treatment, stable routine, management, protection and security of the horses in his/her stable;
- (c) For ensuring that only Veterinarians approved by the Stewards inject or otherwise treat horses in his/her care;

- (d) The Stewards noted that Jockey Vivek had not pleaded guilty of alleged breach of Contravening Rule No. 159 (b) of the BTC Rules of Racing as charged by the Stipendiary Stewards;

The Stewards, thereafter using their wisdom and experience, arrived at a unanimous decision that Jockey Vivek was "Guilty" as charged in the matter.

In the light of above, the Stewards decided as under:

- (a) To suspend the Jockey's Licence granted to Vivek with effect from **27-8-2022 to 26-11-2022 (Both days inclusive)** and fine him a sum of Rs.25,000/- for Contravening Rule No. 159 (b) of the BTC Rules of Racing on his mount AKASI (he is permitted to ride work).
- (b) He was informed of his right to appeal to the Board of Appeal.

(B)

The Stipendiary Stewards reported Trainer Mr. S. Inayathulla to the Stewards for Contravening Rule No. 114 (b) (i) of the B.T.C. Rules of Racing in respect of his charge AKASI.

The Stewards held an enquiry on 17th August, 2022 and examined Trainer Mr. S. Inayathulla and Jockey Vivek.

The Stewards considered the following:

- (a) Charge sheet issued to Trainer Mr. S. Inayathulla by the Stipendiary Stewards;
- (b) The Submissions made by Jockey Vivek and Trainer Mr. S. Inayathulla during the enquiry;
- (c) Stewards viewed the various angles of the race with specific reference to the riding of Jockey Vivek;
- (d) The Stewards noted that Trainer Mr. S. Inayathulla had not pleaded guilty of alleged breach for Contravening Rule No. 114 (b) (i) under BTC Rules of Racing as charged by the Stipendiary Stewards;
- (e) The Stewards were not satisfied with the explanations tendered by Trainer Mr. S. Inayathulla during the enquiry with specific reference to unsatisfactory running of his charge AKASI.

The Stewards, thereafter using their wisdom and experience, arrived at a unanimous decision that Trainer Mr. S. Inayathulla was "Guilty" as charged in the matter.

In the light of above, the Stewards decided as under:

- (a) To suspend the trainer's licence granted to Mr. S. Inayathulla with effect from 27-8-2022 to 26-09-2022 (Both days inclusive) and fine him a sum of Rs.25,000/- for Contravening Rule No. 114 (b) (i) of the BTC Rules of Racing read with Calendar Notification under the heading "PUNISHMENT TO TRAINERS BY STIPENDIARY STEARDS / STEWARDS" (Unsatisfactory Running) in respect of his charge AKASI.
- (b) He was informed of his right to appeal to the Board of Appeal.

Race: 131. The Baraloy Plate - Div. II - (About) 1200 metres. Horses rated 20 to 45, 4 years old and over.

The Stipendiary Stewards reported Jockey Arvind Kumar. N to the Stewards for Improper riding on his mount THE ADVISER, thereby Contravening Rule No. 161 (i) of the B.T.C. Rules of Racing.

The Stewards held an enquiry on 17th August, 2022, considered the Charge Sheet No.797 issued to Jockey Arvind Kumar. N by the Stipendiary Stewards. After viewing the CCTV replay of the race, submissions made by Jockey Arvind Kumar. N and Trainer Mr. Sharat Kumar.

After deliberations, they decided to:-

- (a) Suspend the Jockey's Licence granted to Arvind Kumar. N with effect from **11-11-2022 to 17-12-2022** (both days inclusive) for Improper Riding [Rule No. 161 (i) of the BTC Rules of Racing] on his mount THE ADVISER (Permitted to ride work).
- (b) Note the explanations tendered by Trainer Mr. Sharat Kumar during the enquiry.
- (c) Jockey Arvind Kumar. N was informed of his right to appeal to the Board of Appeal.

- (f) They also noted that Trainer Mr. Narayana Gowda. V. had violated the Stewards instructions in specific reference to use of Mobile phones in the saddling enclosure.

The Stewards, thereafter using their wisdom and experience, arrived at a unanimous decision that Trainer Mr. Narayana Gowda. V. was "Guilty" as charged in the matter.

In the light of above, the Stewards decided as under:

- (a) To suspend the trainer's licence granted to Mr. Narayana Gowda. V. with effect from **27-8-2022 to 26-10-2022 (Both days inclusive)** and fine him a sum of Rs.25,000/- for Contravening Rule No. 114 (b) (i) read with 202 (i) of the BTC Rules of Racing in respect of his charge TYTO ALBA;
- (b) To fine him a sum of Rs.10,000/- for using Mobile phone in the saddling enclosure.
- (c) He was informed of his right to appeal to the Board of Appeal.
