

BANGALORE SUMMER MEETING 2023
THIRD DAY, SATURDAY , 27TH MAY, 2023

RACING INCIDENTS

(15 - 21)

GOING : Good

PENETROMETER READING: 3.4 Cms.

RAILING POSITION: Railing fixed at average width of 5.0 Meters from 1600 Meters to winning post from its original position.

1st Race: 15. The Royal Tern Plate - (About) 1200 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (12 Runners).

AMAZING ATTRACTION (P. Trevor) jumped awkwardly inwards and inconvenienced BOURBON BAY (Bhawani Singh) soon after the start.

Jockey Vinod Shinde, the rider of LONE RANGER was fined Rs.1,000/- for shifting out and taking out the horses on his outside viz; BURMESE (Yash Narredu) and THE BLISSFULELYSEE (K. Sai Kiran) passing the 1000 Metres.

It was observed that CROSSWATER (S. Saqlain) suddenly shied from the rails and bumped BOURBON BAY (Bhawani Singh) passing the 700 Metres.

Jockey Kiran Naidu, the rider of SMASH SHOT reported that his mount was running green and ran detached from the field. Trainer Mr. Anil Kumar was informed to ensure better performance of his charge in future.

FORT NELSON (S. Zervan) sustained clip injury on left hind coronet and right hind inside bulb.

Routine Sample was taken for analysis from the winner b f ENABLING.

2nd Race: 16. The Supervite Plate - Div. II - (About) 1400 metres. Horses rated 20 to 45, 4 years old and over (9 Runners).

Permission was granted to Trainer Mrs. Parvati Byramji to withdraw SPIRIT OF LOVE (S. Saqlain) on veterinary grounds as it was found to be lame on right hind. She was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

As Jockey Arul J.H. was certified medically unfit. Permission was granted to trainer Mr. Darius R. Byramji to declare Jockey S. Saqlain to ride RING MASTER in place of the declared rider.

HIGH OPINION (Hindu Singh) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Warren Singh was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

An enquiry was held on 29th May, 2023 by the Stipendiary Steward into the interference caused by Jockey Rajesh Kumar.M, the rider of DEFINING POWER in the above race. In that he shifted 'in' sharply and caused severe interference to the horses on his inside viz; SOLID POWER (Arvind Kumar. N), RING MASTER (S. Saqlain) and MY VISIONARY (Chethan Kalay S.), whereby MASTEROFTHESKIES (Siddaraju.P) which was travelling directly behind stumbled, totally unbalancing its rider before passing the red marker post.

Jockey Rajesh Kumar.M was interviewed by the Stipendiary Steward. The Stipendiary Steward after considering the submissions made by Jockey Rajesh Kumar.M and after viewing the CCTV replay decided to charge Jockey Rajesh Kumar.M for Careless Riding.

The Stipendiary Steward thereafter suspended the Jockey's Licence granted to Rajesh Kumar.M **on 10th June, 2023** as he had pleaded guilty of the charge under Rule No. 161 (i) of the BTC Rules of Racing for Careless Riding on his mount DEFINING POWER (he was permitted to ride work) and was informed of his right to appeal.

Jockey Vinod Shinde, the rider of STRIKING POINT reported that his mount was not galloping fluently throughout the race. The horse was subjected to veterinary examination. On examination, it was found to have sustained superficial injury on right hind cannon.

Jockey Girish R., the rider of GLOW IN THE DARK was severely reprimanded in presence of Trainer Mr. Prasanna Kumar for riding in an incompetent manner. He was further cautioned to improve his riding and Trainer was cautioned as to the selection of his riders for his charge in the future.

Routine Sample was taken for analysis from the winner b g DEFINING POWER.

3rd Race: 17. The Usha Stud Plate - (About) 1200 metres. Horses rated 40 to 65, 4 years old and over (12 Runners).

NIKOLINA (Vivek.G) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Prasanna Kumar was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Sonu Kumar, the rider of WIN MY LUV was fined Rs.1,000/- for shifting out and taking out RIGHTLY NOBLE (Surya P.) on his outside soon after the start.

It was observed that Jockey Bhawani Singh, the rider of QUEEN REGNANT had to steady his mount to avoid striking the front runner HUMANITARIAN (Deepak Singh) passing the 850 Metres.

Jockey A.R.Pradeep, the rider of CASH OUT was severely reprimanded for repeatedly checking his mount between the 800 Metres and 500 Metres for no apparent reason.

RIGHTLY NOBLE (Surya P.) ran detached from the field. Trainer Mr. Prithviraj B. was informed to ensure better performance of his charge in future.

WIN MY LUV (Sonu Kumar) sustained clip injury on left fore cannon and right fore pastern.

CASH OUT (A.R.Pradeep) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g RAPIDUS.

4th Race: 18. The K.N. Guruswamy Memorial Trophy - (About) 1400 metres. Horses rated 40 to 65 (9 Runners).

Jockey Akshay Kumar, the rider of IN THY LIGHT reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Prasanna Kumar was informed to take appropriate corrective measures before accepting with it again.

It was reported after the race by Trainer Aravind G. to the Club's Veterinary Officer of the club that SERDAR (Bhawani Singh), on the way to the stable had bled from its nostrils. The same was confirmed on endoscopy in the hospital at 4:10 P.M. that it had burst its blood vessels (On Endoscopy Grade - III). Trainer Mr. Aravind G. was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g IN THY LIGHT.

5th Race: 19. The Col. Desraj Urs Trophy - (About) 1200 metres. Horses rated 60 to 85 (12 Runners).

As Jockey Arul J.H. was certified medically unfit. Permission was granted to trainer Mr. Neil Darashah to declare Jockey S. Saqlain to ride ARTEMIS IGNACIA in place of the declared rider.

It was observed that CARLISLE (Afroz Khan) stumbled soon after jumping out of the starting gates, whereby the rider was dislodged.

MISS LITTLE ANGEL (Sonu Kumar) jumped awkwardly outwards onto PRINCE ABIR (Shreyas Singh S) soon after the start.

Jockey Shreyas Singh S, the rider of PRINCE ABIR reported that he accidentally lost his whip passing the 100 Meters.

Routine Sample was taken for analysis from the winner b f ARTEMIS IGNACIA.

6th Race: 12. The War Hammer Million - (About) 1400 metres. 3-year-old horses(foaled in 2020). (12 Runners).

As Jockey Arul J.H. was certified medically unfit to ride and as there was no suitable substitute rider available. Permission was granted to trainer Mr. Anil kumar to withdraw DIAMOND GOLD from the above race.

BORN TO BE SPOILT (Afroz Khan) during the parade in the paddock, reared up, flipped over and was recumbent for a considerable period of time. Under the circumstances, it was permitted to be withdrawn on veterinary grounds. Trainer Mr. Anil Kumar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey P. S. Chouhan, the rider of N R I DOUBLEPOWER reported that his saddle shifted towards the right in the final 200 Metres, as such he had to stop riding in the last 150 Metres. After due examination of the equipment, Trainer Mr. G. Shashikanth was fined Rs.3,000/- for faulty saddling of his charge.

Jockey Abhay Singh, the rider of BRILLIANT STAR reported his mount was inclined to run out between the 600 Metres and 500 Metres.

Routine Sample was taken for analysis from the winner b f FAST PACE.

7th Race: 20. The Ministerial Plate - (About) 1600 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (8 Runners).

PHARAZON (A.Ramu) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Irfan Ghatala was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Routine Sample was taken for analysis from the winner b c THE GODFATHER.

8th Race: 21. The Supervite Plate - Div. I - (About) 1400 metres. Horses rated 20 to 45, 4 years old and over (10 Runners).

CAESARS PALACE (Shreyas Singh S) was extremely fractious while being loaded into the starting gates and was found to have sustained laceration on right barrel when examined by the Club's Veterinary Officer. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. M. Rajendra Singh was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

FORTUNATUS (S. Saqlain) after jumping out slightly swerved towards the left.

Jockey S. Saqlain, the rider of FORTUNATUS reported that his mount was hanging out from the 1000 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

DRAGON'S GOLD (Akshay Kumar) sustained clip injury on left hind cannon.

SILVER CANYON (P. Trevor) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner ch m MEASURE OF TIME.
