BANGALORE SUMMER MEETING 2023 NINTH DAY, SATURDAY, 17TH JUNE, 2023 RACING INCIDENTS

<u>(58 - 64)</u>

GOING: Good

PENETROMETER READING: 4.0 Cms.

RAILING POSITION: Railing fixed at average width of 3.0 Meters from 1600 Meters to winning post from its original position.

1st Race: 58. The June Plate - Div. II - (About) 1200 metres. Horses rated 20 to 45, 4 years old and over (9 Runners).

RIVETING (Vivek) planted and did not take any practical part in the race. In view of its behaviour, Trainer Mr.Warren Singh was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

MAYBACH (D. Patel) took a fly jump and inconvenienced BREEZE BLUSTER (S. Saglain) on its outside soon after the start.

Jockey S. Saqlain, the rider of BREEZE BLUSTER was reprimanded for shifting 'in' and inconveniencing THE GOLDEN DREAM (Naveen M.) on his inside passing the 1100 Metres.

Jockey Angad, the rider of SACRED CREATOR was reprimanded for travelling wide rounding the final bend for no apparent reason.

It was reported after the race that BELVEDERE (Akshay Kumar) pulled up lame on left fore. Trainer Mr.Faraz Arshad was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

MAYBACH (D. Patel) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b r BELVEDERE.

2nd Race: 59. The Kranji Plate - (About) 2000 metres. Horses rated 20 to 45 (4 Runners).

Trainer Mr.R.H.Sequeira was fined Rs.1,000/- for failing to produce the declared colors at the scales in respect of his charge ORIGINAL SIN (P. Trevor). Subsequently, All Black emergency colors were permitted to be used.

Jockey Akshay Kumar, the rider of RULING DYNASTY was severely reprimanded for an undesirable practice of easing his mount in the final 100 Metres of the race.

RULING DYNASTY (Akshay Kumar) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g RULING DYNASTY.

3rd Race: 60. The Maddur Stakes - (About) 1400 metres. Horses rated 00 to 25 (9 Runners).

MEGA SUCCESS (Vivek) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. S. Inayathulla was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

EASTERN SEA (Arul J.H) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Neil Darashah was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Naveen M., the rider of BELLISSIMO was fined Rs.1,000/- for shifting 'in' and causing interference to ELITE AGENT (Rajesh Kumar M) on his inside approaching 1200 Metres.

EASTERN SEA (Arul J.H) was subjected to veterinary examination. On examination, it was found to have sustained superficial clip injury on right hind fetlock.

Trainer Mr. Neil Darashah and Jockey Arul J.H. were questioned regarding the running and riding of EASTERN SEA in the above race.

The trainer stated that:

- a) His charge had raced for the first time as a 4 year old and had finished 6th in its first start in Race No. 22 of BSM 2023;
- b) He had instructed the jockey to ride his own race and do his best in the straight as he was riding this horse every day during the morning track work;
- c) His charge had lost about 18 kilos from its previous start;
- d) He felt that his charge needs more ground;
- e) He also felt that the top weight was disadvantageous and added that he will claim allowance in its next starts.

Jockey while corroborating the statements of the trainer, added that his mount jumped out slowly, as such he gave his mount a chance and after coming into the straight he rode out but he could only finish 7^{th} .

Surprise sample was taken for analysis from b f EASTERN SEA,

Routine Sample was taken for analysis from the winner b f MAROON.

4th Race: 61. The Royal Command Plate - (About) 1200 metres. Horses rated 20 to 45 (Outstation horses eligible)(9 Runners).

GREENWICH (K. Nazil) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Arjun Mangalorkar was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

BLUES BALLAD (K. Sai Kiran) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Warren Singh was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Routine Sample was taken for analysis from the winner b f FONDNESS OF YOU.

5th Race: 62. The Sir Cecil Cup - (About) 1600 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (10 Runners).

AUSTRALIA (Akshay Kumar) was extremely fractious and refused to be remain the stalls. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

MARIANA (Kirtish Bhagat) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. P. Shroff was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

GRACE (Hindu Singh) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Vijay Singh was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey S. Saqlain, the rider of LONE RANGER was fined Rs.2,000/- for not maintaining a proper course, thereby causing interference to VYASA (P. S. Chouhan) between the 1500 Metres and 1400 Metres.

Jockey P. S. Chouhan, the rider of VYASA was fined Rs.1,000/- for coming 'in' and causing interference to LONE RANGER (S. Saqlain), which in turn passed it onto GRACE (Hindu Singh) on his inside approaching 900 Metres.

FELICIA (Antony Raj S.) sustained superficial clip injury on left hind cannon.

Routine Sample was taken for analysis from the winner b f SNOWPIERCER.

6th Race: 63. The Justice P. Medapa Memorial Trophy - (About) 1200 metres. Horses rated 40 to 65 (12 Runners).

Jockey Akshay Kumar, the rider of DEVILS MAGIC was fined Rs.1,000/- for shifting out and bumping the horses on his outside viz; SLAINTE (S. Saba), KENSINGTON COURT (A.Ramu) and MONTELENA (S. Saqlain) at the start.

Jockey Abhay Singh, the rider of BRILLIANT STAR reported that his mount was inclined to run out from 900 Metres till about 600 Metres.

Jockey Hindu Singh, the rider of DEDICATE was fined Rs.2,000/- for coming 'in' and causing interference to LAUTERBRUNNEN (Angad) on his inside passing the 700 Metres.

SLAINTE (S. Saba) sustained superficial injury on inside and outside of left hind cannon.

An enquiry was held on 18th June, 2023 by the Stipendiary Steward into the interference caused by Jockey N.R.Santosh Raj, the rider of RIVAL in the above race. In that he shifted 'in' sharply and caused severe interference to KENSINGTON COURT (A.Ramu), which in turn passed it onto DEVILS MAGIC (Akshay Kumar) on his inside approaching 900 Metres.

Jockey N.R.Santosh Raj was interviewed by the Stipendiary Steward. The Stipendiary Steward after considering the submissions made by Jockey N.R.Santosh Raj and after viewing the CCTV replay decided to charge Jockey N.R.Santosh Raj for Careless Riding.

The Stipendiary Steward thereafter suspended the Jockey's Licence granted to N.R.Santosh Raj **from 1**st **July, 2023 to 2**nd **July, 2023 (Both days inclusive)** as he had pleaded guilty of the charge under Rule No. 161 (i) of the BTC Rules of Racing for Careless Riding on his mount RIVAL (he was permitted to ride work) and was informed of his right to appeal.

Routine Sample was taken for analysis from the winner b c DEDICATE.

7th Race: 64. The June Plate - Div. I - (About) 1200 metres. Horses rated 20 to 45, 4 years old and over (8 Runners).

FORTUNATUS (Hindu Singh) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Imtiaz Khan was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Inayat, the rider of TWILIGHT TORNADO was reprimanded for shifting out and inconveniencing FORTUNATUS (Hindu Singh) on his outside passing the 600 Metres.

An enquiry was held on 18th June, 2023 by the Stipendiary Steward into the interference caused by Jockey Rajesh Kumar M, the rider of DEFINING POWER in the above race. In that he shifted 'in' sharply and caused severe interference to OPUS ONE (S. Saqlain) on his inside approaching 600 Metres.

Jockey Rajesh Kumar M was interviewed by the Stipendiary Steward. The Stipendiary Steward after considering the submissions made by Jockey Rajesh Kumar M and after viewing the CCTV replay decided to charge Jockey Rajesh Kumar M for Careless Riding.

The Stipendiary Steward thereafter suspended the Jockey's Licence granted to Rajesh Kumar .M **from 1**st **July, 2023 to 2**nd **July, 2023 (Both days inclusive)** as he had pleaded guilty of the charge under Rule No. 161 (i) of the BTC Rules of Racing for Careless Riding on his mount DEFINING POWER (he was permitted to ride work) and was informed of his right to appeal.

Routine Sample was taken for analysis from the winner b g ARCHWAY.
