**RACING INCIDENTS**

**(65 - 72)**

**GOING : Good**

**PENETROMETER READING: 3.6 Cms.**

**RAILING POSITION: Railing fixed at its original position.**

**1<sup>st</sup> Race: 65. The Meydan Plate - (About) 1200 metres. Horses rated 00 to 25, 6 years old and over (9 Runners).**

Jockey Arvind Kumar. N, the rider of JERSEY LEGEND was reprimanded for shifting out and inconveniencing PARADISE BECKONS (Rayan Ahmed R.) on his outside at the start.

Jockey S. Saqlain, the rider of MAX MUELLER reported that his mount was not galloping fluently throughout the race. The horse was subjected to veterinary examination but no abnormality was reported.

DEBONAIR (A.Ramu) sustained punctured wound on right hind cannon.

Routine Sample was taken for analysis from the winner b g JERSEY LEGEND.

**2<sup>nd</sup> Race: 66. The Mandya Stakes - (About) 1400 metres. Horses rated 20 to 45 (10 Runners).**

FEARLESS JOEY (P. Ajeeth Kumar) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.S. Narredu was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

THE BLISSFULELYSEE (K. Sai Kiran) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Sharat Kumar was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

It was observed that DOUBLE SCOTCH (Akshay Kumar) accidentally stumbled passing the 1300 Metres.

Jockey Siddaraju.P, the rider of WAR TRAIL reported that he had to steady his mount passing the 800 Metres due to a closely packed field.

IMPIANA (C.Umesh) sustained superficial clip injury on right hind cannon.

WAR TRAIL (Siddaraju.P) sustained bleeding cut injury on left hock and left fore pastern.

At the request of Trainer Mr. S.S. Attaollahi, endoscopy was performed on DOUBLE SCOTCH and no abnormality was found.

Routine Sample was taken for analysis from the winner ch f IMPIANA.

**3<sup>rd</sup> Race: 67. The Treasure Girl Plate - Div. II - (About) 1100 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (10 Runners).**

Jockey Rayan Ahmed R., the rider of ASAGIRI was fined Rs.1,000/- for shifting out and taking out HIGH TRIBUTE (Hasib Alam) on his outside approaching 300 Metres.

Jockey Hasib Alam, the rider of HIGH TRIBUTE was fined Rs.1,000/- for coming 'in' and causing interference to ASAGIRI (Rayan Ahmed R.) on his inside in the final 75 Metres of the race.

ROCHELLE (K. Nazil) sustained superficial clip injury on right hind pastern.

At the behest of the Stipendiary Stewards, the Stewards held an enquiry immediately after the race and enquired into the interference caused by Jockey S. Zervan, the rider of SEA EAGLE to Jockey Hasib Alam, the rider of HIGH TRIBUTE in the final 100 Metres, whereby Jockey Hasib Alam was dislodged from his mount. The Stewards examined Jockeys S. Zervan and Hasib Alam the respective riders. After detailed deliberations, they decide not to alter the placings as declared by the judge.

The Stipendiary Stewards reported Jockey S. Zervan, the rider of SEA EAGLE to the Stewards for Dangerous Riding [Rule No. 161 (i) of the B.T.C. Rules of Racing] in the above race. In that he had not maintained a proper course, allowed his mount to shift 'in' in the final 100 Metres, whereby HIGH TRIBUTE (Hasib Alam) stuck his mount dislodging its rider. The Stewards held an enquiry after the last race and examined Jockey S. Zervan, viewed CCTV replay of the race in question from various angles. Thereafter, they decided to change the charge to Careless Riding [Rule No. 161 (i)] of the B.T.C Rules of Racing and hence, they decided to suspend the Jockey's licence granted to S. Zervan from **1<sup>st</sup> July, 2023 to 2<sup>nd</sup> July, 2023 (Both days inclusive)** and fine him a sum of Rs.25,000/- for Careless Riding [Rule No. 161 (i) of the B.T.C. Rules of Racing] on his mount SEA EAGLE in the above race (He is permitted to ride work) and he was informed of his right to appeal.

Routine Sample was taken for analysis from the winner b f SEA EAGLE.

**4<sup>th</sup> Race: 68. The Stewards Cup - (About) 1400 metres. Horses rated 60 to 85 (13 Runners).**

DOUGLAS (Salman Khan) accidentally stumbled and inconvenienced LAST WISH (Bhawani Singh) soon after the start.

Jockey P. Trevor, the rider of AMRELI reported that his mount was not galloping fluently after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported.

ROYAL GRACE (Afroz Khan) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f SAVVY CHIC.

**5<sup>th</sup> Race: 69. The Star Supreme Plate - (About) 1600 metres. Horses rated 40 to 65 (9 Runners).**

NIKOLINA (Girish R.) was slowly away and lost many lengths at the start. In view of its behaviour, Trainer Mr.Prasanna Kumar was informed not accept

with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Routine Sample was taken for analysis from the winner b c HUNTINGDON.

**6<sup>th</sup> Race: 70. The Fillies Championship Stakes (Grade I) - (About) 1600 metres. 3-year-old Indian Fillies (foaled in 2020) (12 Runners).**

Jockey C.Umesh, the rider of NEZIAH was fined Rs.2,000/- for coming 'in' and causing interference to ANZAC PIPERNAL (S. Saqlain) on his inside approaching 700 Metres.

Jockey P. Sai Kumar, the rider of SOMETHING ROYAL reported that his mount was hanging 'in' throughout the race. Trainer Mr. J. Sebastian was informed to take appropriate corrective measures before accepting with it again.

Jockey P. Trevor, the rider of JAMARI was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

Jockey Akshay Kumar, the rider of MEROPI was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

MEROPI (Akshay Kumar) sustained superficial clip injury on left hind cannon.

LIVERMORE (S. Zervan) sustained superficial clip injury on right hind coronet.

NEZIAH (C.Umesh) sustained superficial clip injury on right hind fetlock.

FAST PACE (P. S. Chouhan) sustained superficial clip injury on right hind coronet.

**7<sup>th</sup> Race: 71. The Treasure Girl Plate - Div. I - (About) 1100 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (10 Runners).**

Jockey P. Tejeshwar replaced the indisposed Jockey Hasib Alam on TRUTH IN WINE.

PRECIOUS (Abhay Singh) jumped awkwardly outwards and bumped SEEKING THE STARS (P. Trevor) on its outside soon after the start.

Jockey Salman Khan, the rider of LEATHER BACK reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr.Warren Singh was informed to take appropriate corrective measures before accepting with it again.

ALACERO (Arvind Kumar. N) ran detached from the field. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Pradeep Annaiah was informed to ensure better performance of his charge in future.

PRECIOUS (Abhay Singh) sustained superficial clip injury on left hind fetlock.

Routine Sample was taken for analysis from the winner b g CLIFFORD.

**8<sup>th</sup> Race: 72. The Parsiana Plate - (About) 1400 metres. Horses rated 40 to 65, 4 years old and over (11 Runners).**

TIME (K. Nazil) sustained superficial clip injury on left fore lateral bulb.

Routine Sample was taken for analysis from the winner b c WORDSMITH.

**Race: 30. The Prince Khartoum Plate - Div. II - (About) 1400 metres. Horses rated 20 to 45, 4 years old and over.**

The Stipendiary Stewards reported Trainer Mr. Sharat Kumar to the Stewards for Contravention of Rule nos. 114 (b) (i) & 202 (xvi) of the B.T.C Rules of Racing in respect of his charge THE PERFECT CHOICE. In that his charge THE PERFECT CHOICE ran in a inconsistent manner and exhibiting reversal of form wherein, it won in Race No.30 of the BSM 2023 i.e., The Prince Khartoum Plate – Div. II (About) 1400 metres for Horses rated 20 to 45, 4 years old and over, run on 3<sup>rd</sup> June, 2023 as compared to its previous run in Race No. 9 i.e., The Manitou Plate Div - II, (about) 1200 Metres, Horses rated 20 to 45, 4 years old and over run on 21<sup>st</sup> May, 2023 trained by you and when ridden by Jockey Khurshad Alam, it ran unplaced.

The Stewards held an enquiry on 17<sup>th</sup> June, 2023 and examined Trainer Mr. Sharat Kumar.

**After due deliberations, the Stewards decided as under:**

- (a) To fine Trainer Mr. Sharat Kumar a sum of Rs.25,000/- for Contravening Rule Nos. 114 (b) (i) & 202 (xvi) of the BTC Rules of Racing in respect of his charge THE PERFECT CHOICE.
- (b) He was informed of his right to appeal to the Board of Appeal.

Rishi against the decisions of the Stewards at their meetings held on 28<sup>th</sup> April, 2023 and 11<sup>th</sup> May, 2023.

Out of the enquiry it is very clear that, he is fully aware of the stable management and also various medicines and equipments kept in the stables.

As regards to the syringe and needles he claimed that it had been kept in the stables (according to the Jamedar by Dr.Kalamegam). When confronted him in presence of Dr.Kalamegam, Dr.Kalamegam totally refuted the allegations.

Therefore he was guilty of tendering false and misleading evidence apart from dereliction of duty as an Assistant to Trainer of Trainer Mr.S.Padmanabhan in terms of Rule 202 (vi) & (vii) of B.T.C Rules of Racing.

**Rule No. 202.** *The Stewards and/or the Stewards of the Club shall fine and/or punish and/or warn off and/or exclude and/or eject and/or disqualify and/or suspend or withdraw Licences, for any reason or reasons, from any race course or place where these Rules are in force, any of the following persons viz.:*

**(vi)** *Any owner, nominator, trainer, jockey, lessee, apprentice, stable hand, bookmaker or bookmakers assistant or any person who either wilfully refuses to attend and give evidence at an enquiry when requested by the Stewards/Stewards of the Club/Stipendiary Stewards to do so, or knowingly gives evidence which is false or misleading in any particular.*

2. The Stewards noted and approved the request made by Mr. Rishi, Assistant to Trainer wherein he had requested for Spokesperson i.e., Trainer Mr. James Mckeown to represent him with respect to Chargesheet No. 811 issued to him.
3. The submissions made by Spokesperson Trainer Mr. James Mckeown on 11/5/2023 and by Mr. Rishi himself on 28/4/23 during the enquiry held by the Stewards.
4. They also examined Dr. Kalamegam, Dr. Hasneyn Mirza virtually and Dr. Syed Naveed Ahmed along with Mr. Rishi, Asst. to Trainer to Mr.S. Padmanabhan in person on 28/4/2023.
5. The opinion of the enquiry officers on this issue.
6. The Spokesperson himself was satisfied as to the misdemeanour by the assistant to trainer.
7. The spokesperson himself had determined the assistant to trainer as a person without basic knowledge.

After considering all of the above, giving full opportunity to Mr. James Mckeown (Spokesperson for Mr. Rishi, Assistant to trainer to Trainer Mr. S. Padmanabhan) and Mr. Rishi himself to make detailed submissions and after fully applying their mind to the whole issue, the Stewards unanimously concluded that Assistant to Trainer Mr. Rishi [had changed his statements throughout as such he was "Guilty" as charged in the matter of violating Rule No. 202 (vi) & (vii) of the B.T.C. Rules of Racing thereafter they decided as under:

- To suspend the assistant to trainer licence granted to Mr. Rishi w.e.f 25<sup>th</sup> May, 2023 to 24<sup>th</sup> August, 2023 (both days inclusive) for violating Rule No. 202 (vi) & (vii) of the B.T.C. Rules of Racing.
- He was informed of his right to appeal before the BTC Board of Appeal within the frame work of BTC Rules of Racing.

Therefore, the board decided that the punishment of three months awarded by the Stewards to Assistant to Trainer Mr. S.S. Rishi was inadequate especially considering the gravity of offence the Board decided to enhance the punishment to six months, as they held Assistant to Trainer Mr. S.S. Rishi "**guilty as charged**" in this matter.

**Thereafter, the board unanimously decided as under:**

- a) **To reject the appeal filed by Assistant to Trainer Mr. S.S. Rishi;**
- b) **The revised order of suspension is with effect from 8<sup>th</sup> June, 2023 to 7<sup>th</sup> December, 2023 (Both days inclusive) for violating Rule Ns. 202 (vi) & (vii) of the B.T.C Rules of Racing;**
- c) **To forfeit Rs.11,800/- (Inclusive GST) paid by Trainer Mr. S. Padmanabhan towards the Appeal fee.**
