

**BANGALORE SUMMER MEETING 2023**

**SIXTH DAY, SUNDAY , 4<sup>TH</sup> JUNE, 2023**

**RACING INCIDENTS**

**(37 – 43)**

**GOING : Good**

**PENETROMETER READING: 3.3 Cms.**

**RAILING POSITION: Railing fixed at average width of 7.0 Meters from 1600 Meters to winning post from its original position.**

**1<sup>st</sup> Race: 37. The Aureole Time Plate - (About) 1400 metres. Horses rated 00 to 25, 5 years old and over (8 Runners).**

ALTAMONTE (Vivek) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.S. Inayathulla was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Hindu Singh, the rider of SAND CASTLES was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

Routine Sample was taken for analysis from the winner b m BY THE BOOK.

**2<sup>nd</sup> Race: 38. The Elite Force Plate - Div. II - (About) 1200 metres. Horses rated 20 to 45 (10 Runners).**

SCARLET IBIS (Vinod Shinde) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.V.Lokanath was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

JE NE SAIS QUOI (V.R.Jagadeesh) jumped awkwardly outwards onto EMPIRE OF DREAMS (S. Saba) soon after the start.

It was observed that EMPIRE OF DREAMS (S. Saba) accidentally brushed the running rails passing the 850 Metres.

Jockey A.Imran Khan, the rider of ROMAN SPIRIT was reprimanded for shifting 'in' and inconveniencing EMPIRE OF DREAMS (S. Saba) on his inside approaching 350 Metres.

Jockey S. Saba, the rider of EMPIRE OF DREAMS was fined Rs.1,000/- for shifting out and causing interference to ROMAN SPIRIT (A.Imran Khan) on his outside passing the 300 Metres.

It was reported after the race that EXCELLENT RAY (Kiran Naidu) pulled up lame on left fore. Trainer Mr. Rajesh Narredu was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b c STELLANTIS.

**3<sup>rd</sup> Race: 39. The Endorsement Plate - (About) 1600 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (7 Runners).**

Permission was granted to Trainer Mr. James Mckeown to withdraw LIONEL (Hindu Singh) on veterinary grounds as it was found to be sore on right fore due to suspensory ligament. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey S. Zervan, the rider of TIGER SHARK was reprimanded for shifting 'in' and inconveniencing GOOD TIP (Kiran Naidu) on his inside soon after the start.

Jockey S. Zervan, the rider of TIGER SHARK reported that his mount was changing its legs, whereby he shifted out and inconvenienced JULIO (P. Trevor) on his outside passing the 800 Metres.

Routine Sample was taken for analysis from the winner ch g BIG RED.

**4<sup>th</sup> Race: 40. The Udhagamandalam Plate - (About) 1200 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (11 Runners).**

Jockey N. S. Parmar, the rider of ZAZA reported that his mount was inclined to run out between the 1000 Metres till about 700 Metres.

Jockey S. Saqlain, the rider of WINDSOR reported that his mount was hanging out throughout the race. The horse was subjected to veterinary examination. On examination, it was found to have lacerated wound on right hind cannon.

An enquiry is being held into the running and riding of RICARDO, trained by Mr. Arjun Mangalorkar and ridden by Jockey Tadhg O' Shea in the above race.

RICARDO (Tadhg O' Shea) sustained superficial injury on inside right hind gaskin.

Routine Sample was taken for analysis from the winner b r MAZAL TOV.

**5<sup>th</sup> Race: 41. The S. G. Madhukar Memorial Trophy - (About) 1400 metres. Horses rated 40 to 65 (8 Runners).**

Trainer Mr. R.H.Sequeira was fined Rs.1,000/- for failing to produce the declared colors at the scales in respect of his charge ORIGINAL SIN (N. S. Parmar). Subsequently, All Black emergency colors were permitted to be used.

Jockey Tadhg O' Shea, the rider of KALAMITSI was fined Rs.3,000/- for coming 'in' and causing interference to KING OF WAR (S. Saqlain), which in turn passed it onto LAZARUS (P.S. Chouhan) on his inside approaching 900 Metres.

Jockey P. S. Chouhan, the rider of LAZARUS was fined Rs.1,000/- for coming 'in' and causing interference to ORIGINAL SIN (N. S. Parmar) on his inside passing the 400 Metres.

Jockey P. S. Chouhan, the rider of LAZARUS was reprimanded for shifting out and inconveniencing KING OF WAR (S. Saqlain) on his outside approaching 300 Metres.

LAZARUS (P. S. Chouhan) was impounded for veterinary examination. On examination, it was found to have burst its blood vessels (on Endoscopy Grade - III). Trainer Mr. P. Shroff was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Surprise sample was taken for analysis from b c LAZARUS.

Routine Sample was taken for analysis from the winner b m PINK JASMINE.

**6<sup>th</sup> Race: 42. The D. T. Racing & Breeding LLP Juvenile Million (Grade III) - (About) 1400 metres. 3-year-old horses(foaled in 2020). (12 Runners).**

It was observed that BRAVE TROOPER (Hindu Singh) accidentally stumbled at the start.

Jockey Hindu Singh, the rider of BRAVE TROOPER was reprimanded for shifting 'in' and bumping GIMMLER (P.S. Kaviraj), which in turn passed it onto FELIX (Shreyas Singh S) on his inside soon after the start.

It was reported by Trainer Mr. P. Shroff that the right fore shoe of JAMARI (P. Trevor) had come off after the race.

Compulsory urine and blood samples were taken for analysis from the following I, II & III placed horses viz:

**7<sup>th</sup> Race: 43. The Elite Force Plate - Div. I - (About) 1200 metres. Horses rated 20 to 45 (9 Runners).**

Trainer Mr. Sriram Komandur was fined Rs.2,000/- for coming in an improper attire to the paddock for the above race in respect of his charge SUPER GLADIATOR.

CAESARS PALACE (Shreyas Singh S) was extremely fractious, refused to be stalled and the bridle had come off. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

CAPRI GIRL (K. Sai Kiran) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Warren Singh was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

LIMITED EDITION (V.R.Jagadeesh) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Azhar Ali was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

TWILIGHT FAME (Rajesh Kumar M) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Narayana Gowda V. was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

An enquiry is being held into the running and riding of SUPER GLADIATOR, trained by Mr. Sriram Komandur and ridden by Jockey A.Ashhad Asbar in the above race.

SUPER GLADIATOR (A.Ashhad Asbar) was impounded for veterinary examination but no abnormality was reported.

Surprise urine and blood sample were taken for analysis from b g SUPER GLADIATOR.

Routine Sample was taken for analysis from the winner dk b f GALATICUS.
