RACING INCIDENTS
(88 - 94)

GOING : Good

PENETROMETER READING: 4.3 Cms.

RAILING POSITION: Railing fixed at average width of 7.5 Meters from 1600 Meters to winning post from its original position.

1st Race: 88. The Royal Challenge Plate - (About) 1400 metres. Horses rated 00 to 25, 5 years old and over (12 Runners).

SKY PRINCESS (Salman Khan) planted, after jumping out swerved towards the left, did not raise a fluent gallop for the first 100 Metres. In view of its behaviour, Trainer Mr. Warren Singh was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Arvind Kumar. N, the rider of SEKHMET was fined Rs.1,000/- for shifting 'in' and tightening the horses on his inside viz; SKY PRINCESS (Salman Khan) and ULTIMATE CHANCE (Inayat) approaching 900 Metres.

Jockey Inayat, the rider of ULTIMATE CHANCE was fined Rs.1,000/- for shifting out and causing interference to MARCO POLO (Syed Imran) on his outside approaching 800 Metres.

MARCO POLO (Syed Imran) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b m SAND CASTLES.

2nd Race: 89. The Malakpet Plate - Div. II - (About) 1400 metres. Horses rated 20 to 45, 5 years old and over (8 Runners).

Routine Sample was taken for analysis from the winner b g ABLE ONE.

3rd Race: 90. The Poonawalla Stud Plate - (About) 1200 metres. Horses rated 40 to 65, 4 years old and over (10 Runners).

Jockey Antony Raj S., the rider of ARCHWAY was fined Rs.2,000/- for coming 'in' and causing interference to MYSTIC EYE (Prashant P.Dhebe), which in turn passed it onto ETERNAL PRINCESS (Vinod Shinde) on his inside passing the 200 Metres.

Jockey T. S. Jodha, the rider of ENGLISH BAY was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

Routine Sample was taken for analysis from the winner b g ENGLISH BAY.

4th Race: 91. The Smart Chieftan Plate - (About) 1400 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (8 Runners).

Jockey Vishal N Bunde, the rider of ENCANTAMENTO reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Neil Darashah (deputising on behalf of Trainer Mr. Imtiaz Sait) was informed to take appropriate corrective measures before accepting with it again.

Routine Sample was taken for analysis from the winner ch g KNIGHT DEFENSOR.

5th Race: 92. The Managing Committee Gold Cup - (About) 1600 metres. Horses rated 70 and above (6 Runners).

As Jockey Y.S. Srinath was certified medically unfit to ride. Permission was granted to trainer Mr. Neil Darashah to declare Jockey K.G. Likith Appu to ride SEA LION in place of the declared rider.

Jockey K.G. Likith Appu, the rider of SEA LION was fined Rs.1,000/- for shifting out and bumping PRIDE'S ANGEL (Akshay Kumar) on his outside passing the 950 Metres.

It was observed that PRIDE'S ANGEL (Akshay Kumar) slipped from its hind approaching 900 Metres.

It was reported after the race that DE VILLIERS (Shreyas Singh S) pulled up lame on right fore. Trainer Mr.S.S. Attaollahi was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b m MOON'S BLESSING.

6th Race: 93. The Five Stars Shipping Juvenile Sprinters' Million (Grade III) - (About) 1200 metres. 3-year-old horses (foaled in 2020). (6 Runners).

Trainer Mr. J. Sebastian was fined Rs.10,000/- for not declaring his charge ELIZABETH REGINA to start after having accepted with it to run in the above race.

Permission was granted to trainer Mr.Ananta Vatsalya not to declare to start EXETER as he had sent the scratching on 6/6/2023 to concerned and the same was not scratched from the above race.

It was observed that KENAF (S. Saqlain) threw its head up soon after the start.

LONG LEASE (Yash Narredu) stumbled soon after jumping out of the starting gates.

CALL ME (Shreyas Singh S) jumped awkwardly outwards and inconvenienced BORN TO BE SPOILT (Arul J.H) at the start.

Jockey Yash Narredu, the rider of LONG LEASE reported that his mount slipped from its hind approaching 900 Metres.

BORN TO BE SPOILT (Arul J.H) ran detached from the field. Trainer Mr. Anil Kumar was informed to ensure better performance of his charge in future.

Compulsory urine and blood samples were taken for analysis from the following I,II & III placed horses viz:

b f LONG LEASE I

b g LEATHER BACK II

b c DEDICATE III

7th Race: 94. The Malakpet Plate - Div. I - (About) 1400 metres. Horses rated 20 to 45, 5 years old and over (8 Runners).

As Jockey Y.S. Srinath was certified medically unfit to ride. Permission was granted to trainer Mr. Warren Singh to declare Jockey Akshay Kumar to ride KATANA in place of the declared rider.

Jockey Kiran Rai P, the rider of ARMORY was fined Rs.3,000/- for shifting out and causing interference to TOP DANCER (P. Trevor), which in turn passed it onto KATANA (Akshay Kumar) approaching 700 Metres.

Jockey S. Saba, the rider of AIR DISPLAY was fined Rs.1,000/- for shifting out and causing interference to ARMORY (Kiran Rai P) on his outside passing the 300 Metres.

Jockey P. Trevor, the rider of TOP DANCER was fined Rs.1,000/- for shifting 'in' and tightening THE GOLDEN DREAM (Naveen M.) on his inside approaching 300 Metres.

Jockey Naveen. M, the rider of THE GOLDEN DREAM was fined Rs.3,000/- for not sufficiently persevering with his mount in the final 100 Metres of the race.

TOP DANCER (P. Trevor) was subjected to veterinary examination but no abnormality was reported.

An enquiry is being held into the running and riding of TOP DANCER, trained by Mr. Neil B. Devaney and ridden by Jockey P. Trevor in the above race.

Routine Sample was taken for analysis from the winner b g CLEVER HANS.

Permission was granted to trainers M/s. Rajesh Narredu, Neil Darashah and V. Lokanath to deputize on behalf of trainers M/s. Parvati Byramji, Imtiaz A. Sait and L.D'silva who were unable to attend the races.
