RACING INCIDENTS

(125 - 132)

GOING : Soft

PENETROMETER READING: 4.9 Cms.

RAILING POSITION: Railing fixed at its original position.

1st Race: 125. The Knotty Maiden Million - (About) 1200 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (9 Runners).

TIGERKING (T. S. Jodha) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.M. Rajendra Singh was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

It was observed that SMILE OF BEAUTY (D. Patel) was inclined to run out between the 900 Metres and 600 Metres, in the process inconvenienced KNOTTY CHALLENGER (Akshay Kumar). SMILE OF BEAUTY was subjected to veterinary examination but no abnormality was reported.

Jockey S. Saqlain, the rider of BRAVE MAJESTY reported that his mount was inclined to run out from the 600 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey K. Sai Kiran, the rider of LEATHER BACK was fined Rs.1,000/- for shifting 'in' and causing interference to SMASH SHOT (Hindu Singh) on his inside approaching 200 Metres.

Jockey Hindu Singh, the rider of SMASH SHOT reported that he did not get a clear run in the final 200 Metres.

It was observed that TRIDENT STAR (S. Zervan) was running green during the race.

Jockey S. Saqlain, the rider of BRAVE MAJESTY was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

It was reported after the race that LEATHER BACK (K. Sai Kiran) had apparently lost its left hind shoe during the race.

At the request of Trainer Mr. Prasanna Kumar, endoscopy was performed on KNOTTY CHALLENGER (Akshay Kumar) and was found to have burst its blood vessels (Grade - IV). Trainer was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

TRIDENT STAR (S. Zervan) sustained bleeding cut injury on right hock.

Routine Sample was taken for analysis from the winner b g LEATHER BACK.

2nd Race: 126. The Turf Authorities of India Trophy - (About) 1800 metres. Horses rated 40 to 65, 4 years old and over (11 Runners).

It was observed that BALOR (S. John) accidentally slipped from its hind approaching 1600 Metres.

Jockey Vishal N Bunde, the rider of STELLAR GOLD reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. S. Ganapathy was informed to take appropriate corrective measures before accepting with it again.

Jockey S. John, the rider of BALOR reported that his mount totally stopped galloping approaching 300 Metres, in the process he inconvenienced KUSHAQ (K.G. Likith Appu). BALOR was subjected to veterinary examination. On examination, it was found to have burst its blood vessels. Trainer Mr. Darius R. Byramji was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

MANDELA (Hindu Singh) sustained superficial clip injury on left knee.

Routine Sample was taken for analysis from the winner b g ALL ATTRACTION.

3rd Race: 127. The Hyderabad Salver - (About) 1400 metres. Horses rated 40 to 65 (11 Runners).

Jockey A.R.Pradeep, the rider of SUPER KIND was fined Rs.1,000/- for shifting out and causing interference to EXTRAORDINARY (Afsar Khan), which in turn passed it onto VIVALDO (Akshay Kumar) on his outside soon after the start.

Jockey Khurshad Alam, the rider of FOUR WHEEL DRIVE was fined Rs.1,000/- for shifting out and causing interference to CONTRIBUTE (Hindu Singh), which in turn passed it onto TOUCH OF GREY (Suraj Narredu) on his outside soon after the start.

Jockey Imran Chisty, the rider of AQUAMATIC was fined Rs.1,000/- for shifting 'in' and causing interference to TWINKLE FEET (A.Ramu), which in turn passed it onto DUBAI FLAME (Hasib Alam) on his inside soon after the start.

It was observed that VIVALDO (Akshay Kumar) could not get a clear run between the 400 Metres and 300 Metres due to a closely packed field.

Jockey Suraj Narredu, the rider of TOUCH OF GREY was reprimanded for not maintaining a straight course in the final 200 Metres.

Routine Sample was taken for analysis from the winner gr c TOUCH OF GREY.

4th Race: 128. The Coromandel Gromor B. T. C. Anniversary Cup (Grade II) - (About) 1400 metres. 4 years old and over. (8 Runners).

Permission was granted to Trainer Mr. Deepesh Narredu to withdraw LEOPARD ROCK (Yash Narredu) on veterinary grounds as it was found to have cellulitis on left fore pastern. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Trainer Mr. Vishesh M.P. was fined Rs.10,000/- for Contravention of General Condition 5 of the Prospectus of Bangalore Summer Meeting 2023 in accepting DUN IT AGAIN in the above race and also in Race No. 131 i.e., The Mumbai Cup (About) 1200 Meters, Horses rated 70 & above. Subsequently DUN IT AGAIN was not declared to start in the above race.

Compulsory urine and blood samples were taken for analysis from the following I,II & III placed horses viz:

5th Race: 129. The Hooves of Steel Sumangala TMT Million - (About) 1600 metres. Maiden 3-year-old Horses. (10 Runners).

Jockey T. S. Jodha, the rider of MOMENTOUS reported that his mount was hanging out from the 300 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner dk b g BOOSTER SHOT.

6th Race: 130. Betway Bangalore Summer Derby (Grade I) - (About) 2000 metres. 3-year-old Indian Horses (foaled in 2020) (11 Runners).

Permission was granted to Trainer Mr.P. Shroff to withdraw CHRISTOFLE (P. Trevor) on veterinary grounds as it was found to be lame on right fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey C.Umesh, the rider of JAMARI was fined Rs.1,000/- for coming 'in' and tightening SYNTHESIS (Suraj Narredu) on his inside soon after jumping out of the starting gates.

Jockey Yash Narredu, the rider of CHAMPIONS WAY was fined Rs.1,000/- for shifting 'in' and tightening DESTROYER (Imran Chisty), which in turn passed it onto SYNTHESIS (Suraj Narredu) on his inside approaching 1900 Metres.

Jockey Suraj Narredu, the rider of SYNTHESIS reported that his mount slipped and stumbled very badly passing the 1700 Metres, whereby he shifted out and took out THE GODFATHER (Neeraj Rawal), which in turn passed it onto RULING DYNASTY (Antony Raj S). As the incident was accidental no action was taken beyond noting the incident.

Jockey N. S. Parmar, the rider of WAIKIKI reported that his mount slipped and stumbled very badly passing the 1700 Metres.

Jockey Imran Chisty, the rider of DESTROYER was fined Rs.1,000/- for shifting out and taking out SYNTHESIS (Suraj Narredu) on his outside passing the 500 Metres.

CHAMPIONS WAY (Yash Narredu) sustained superficial clip injury on right hind cannon.

AUSPICIOUS QUEEN (Angad) sustained superficial clip injury on left hind coronet and right hind tendon.

DESTROYER (Imran Chisty) was subjected to veterinary examination but no abnormality was reported.

SYNTHESIS (Suraj Narredu) was subjected to veterinary examination. On examination, it was found to have sustained superficial injury on right fore cannon.

Compulsory urine and blood samples were taken for analysis from the following I,II & III placed horses viz:

7th Race: 131. The Mumbai Cup - (About) 1200 metres. Horses rated 70 and above (10 Runners).

It was observed that DUN IT AGAIN (S. Saba) accidentally stumbled passing the 900 Metres.

Jockey Vivek.G, the rider of SIEGE COURAGEOUS reported that his mount was hanging 'in' from the 300 Metres, whereby he inconvenienced GALACTICAL (Arvind Kumar. N). SIEGE COURAGEOUS was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b c SIEGE COURAGEOUS.

8th Race: 132. The Desert God Trophy - (About) 1400 metres. Horses rated 20 to 45, 4 years old and over (13 Runners).

Permission was granted to Trainer Mr. S.S. Attaollahi to withdraw SOFIYA (Yash Narredu) on veterinary grounds as it was found to have sustained injury on right knee and fetlock, left fore fetlock and left hock. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

LIMITED EDITION (V.R.Jagadeesh) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Azhar Ali was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

BENIGNITY (Surya P.) jumped awkwardly inwards onto DEAR LADY (S. Saba) soon after the start.

Jockey K. Nazil, the rider of TIME reported that his mount stopped galloping in the final 200 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey Angad, the rider of MYSTICAL MERKABAH reported that he accidentally lost his whip passing the 200 Meters.

Routine Sample was taken for analysis from the winner ch g KING OF WAR.

Permission was granted to trainer Mr. Neil Darashah to deputize on behalf of trainer Mr. Imtiaz A sait who was unable to attend the races.
