BANGALORE SUMMER MEETING 2023 TWENTIETH DAY, SUNDAY , 23rd JULY, 2023 RACING INCIDENTS (140 - 146)

GOING : Good PENETROMETER READING: 3.2 Cms. RAILING POSITION: Railing fixed at average width of 6.0 Meters from 1600 Meters to winning post from its original position.

1st Race: 140. The Amazing Grace Plate - (About) 1400 metres. Horses rated 00 to 25, 6 years old and over (8 Runners).

JAI VIKRAM (V.R.Jagadeesh) took a fly jump.

Jockey S. John, the rider of ALTAIR was fined Rs.1,000/- for shifting 'in' and bumping CINCO DE MAYO (IndraJeet Singh), which in turn passed it onto ELITE AGENT (Rajesh Kumar .M) on his inside soon after the start.

Jockey Shreyas Singh S, the rider of RORITO reported that his saddle shifted back approaching 850 Metres. After due examination of the equipment, Trainer Mr.S. Dominic was fined Rs.3,000/- for faulty saddling of his charge.

Jockey Abdul Fazal, the rider of KONICHIWA was fined Rs.3,000/- for shifting 'in' and causing interference to ALTAIR (S. John), which in turn passed it onto JAI VIKRAM (V.R.Jagadeesh) on his inside approaching 300 Metres.

Jockey IndraJeet Singh, the rider of CINCO DE MAYO was reprimanded for shifting out and inconveniencing ALTAMONTE (Vivek.G) on his outside passing the 300 Metres.

Jockey IndraJeet Singh, the rider of CINCO DE MAYO was fined Rs.3,000/for the excessive use of the whip on his mount during the race (1st infringement).

ALTAMONTE (Vivek.G) sustained superficial injury on right nostril.

RORITO (Shreyas Singh S) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner dk b/br g KONICHIWA.

2nd Race: 141. The Flirting Vision Plate - Div. II - (About) 1100 metres. Horses rated 20 to 45 (8 Runners).

PHOEBE (A.R.Pradeep) reared up as the gates opened, did not raise a fluent gallop for the first 100 Meters and ran detached thereafter. In view of its behaviour, Trainer Mr.Pradeep Annaiah was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey IndraJeet Singh, the rider of WISH AGAIN was reprimanded for shifting 'in' and inconveniencing FIRST ROYALIST (Arvind Kumar. N) on his inside soon after the start.

Jockey Tousif Khan, the rider of SUPERHERO was fined Rs.1,000/- for not maintaining a proper course, thereby causing interference to SEA EAGLE (S. Zervan) before passing the red marker post.

Jockey Inayat, the rider of ELIZABETH REGINA reported that his mount was hanging out after entering the straight. Trainer Mr.J. Sebastian was informed to take appropriate corrective measures before accepting with it again.

An enquiry is being held into the running and riding of SEA EAGLE, trained by Mr. Neil Darashah and ridden by Jockey S. Zervan in the above race.

FIRST ROYALIST (Arvind Kumar. N) sustained bleeding cut injury on left hind coronet.

WISH AGAIN (IndraJeet Singh) sustained injury on gums.

SEA EAGLE (S. Zervan) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g WISH AGAIN.

<u>3rd Race: 142. Betway Mamma's Mink Plate - (About) 1200 metres.</u> <u>Maiden Horses 3 years old only (Horses who have run at least thrice</u> <u>but not placed second, third or fourth even once ineligible)</u> (11 Runners).

ISABELLE (S. Saqlain) reared up and sat down for a considerable period of time. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

INSTRUCTOR (K. Sai Kiran) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Warren Singh was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

It was observed that Jockey Afsar Khan, the rider of THE WHISPERING reported that his mount was not striding out freely as such he eased his mount and dismounted approaching 1000 Metres. The horse was subjected to veterinary examination. On examination, it was found to be lame on right fore. Trainer Mr. Sharat Kumar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Suraj Narredu, the rider of QUEEN OF KYIV was fined Rs.1,000/- for shifting 'in' and causing interference to MADE IN HEAVEN (A. Ayaz Khan) on his inside soon after the start.

Jockey P. Trevor, the rider of CHILILADY reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Warren Singh was informed to take appropriate corrective measures before accepting with it again.

Jockey K. Sai Kiran, the rider of INSTRUCTOR reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Warren Singh was informed to take appropriate corrective measures before accepting with it again.

Jockey P. Trevor, the rider of CHILILADY was fined Rs.1,000/- for shifting 'in' and causing interference to QUEEN OF KYIV (Suraj Narredu) on his inside approaching 200 Metres.

DIAMOND HOOVES (Vinod Shinde) ran detached from the field. Trainer Mr. V. Lokanath was informed to ensure better performance of his charge in future.

Routine Sample was taken for analysis from the winner b g MARZGOVEL.

4th Race: 143. The Raja of Bobbili Memorial Trophy - (About) 1400 metres. Horses rated 40 to 65, 5 years old and over (7 Runners).

Permission was granted to Trainer Mr.Neil B Devaney to withdraw DOUGLAS (Salman Khan) on veterinary grounds as it was found to be lame on left fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey S. Saqlain, the rider of SMITHSONIAN was fined Rs.5,000/- for coming 'in' and tightening WIN MY LUV (Inayat), in the process he again shifted out and caused interference to LORD FRANKEL (S. John) on his outside passing the 750 Metres.

WIN MY LUV (Inayat) sustained superficial injury on left hind fetlock and punctured wound on left fore cannon.

At the request of trainer Mr. Neil B Devaney, endoscopy was performed on WIN MY LUV (Inayat) and found to have burst its blood vessels (Grade -III). Trainer was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

An enquiry is being held into the running and riding of WIN MY LUV, trained by Mr. Neil B. Devnaey and ridden by Jockey Inayat in the above race

Routine Sample was taken for analysis from the winner b g CLEVER HANS.

5th Race: 144. The Usha Stud Golden Jubilee Bangalore St. Leger (Grade II) - (About) 2800 metres. Indian Horses 4 years old and over (foaled in 2019 or before) (4 Runners).

Permission was granted to Trainer Mr. Arjun Mangalorkar to withdraw SILVARIUS (S. John) on veterinary grounds as it was found to be lame on left fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Compulsory urine and blood samples were taken for analysis from the following I,II & III placed horses viz:

6th Race: 145. The Azhar Plate - (About) 1400 metres. Horses rated 20 to 45, 4 years old and over (8 Runners).

RIVETING (Arul J.H) planted and did not take any practical part in the race. In view of its behaviour, Trainer Mr.Warren Singh was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey K.G. Likith Appu, the rider of PERIDOT reported that his mount was coughing after the race. The horse was subjected to veterinary examination. On examination, it was found to have burst its blood vessels. Trainer Mr. Irfan Ghatala was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

BORN KING (P. Tejeshwar) ran detached from the field. Trainer Mr. S. Narredu was informed to ensure better performance of his charge in future.

Routine Sample was taken for analysis from the winner dk b g THE PERFECT CHOICE.

7th Race: 146. The Flirting Vision Plate - Div. I - (About) 1100 metres. Horses rated 20 to 45 (7 Runners).

As Jockey Abdul Fazal was certified medically unfit to ride and as there was no suitable substitute rider available. Permission was granted to trainer Mr. Warren Singh to withdraw THE KING N I from the above race.

RICARDO (S. John) took a fly jump.

THE ADVISER (Naveen M.) sustained superficial injuries on left hind cannon and right hind fetlock.

RICARDO (S. John) was impounded for veterinary examination but no abnormality was reported.

An enquiry is being held into the poor performance of RICARDO, trained by Mr. Arjun Mangalorkar and ridden by Jockey S. John in the above race as compared to its previous run in Race No. 98 i.e., The Littleover Plate - Div. I - (About) 1200 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible), run on 2/7/2023 wherein it placed first.

Surprise sample was taken for analysis from b c RICARDO.

Routine Sample was taken for analysis from the winner b g CLIFFORD.

Permission was granted to trainer Mr. M. Rajendra Singh to deputize on behalf of trainer Mr. Magan Singh B. Parmar who was unable to attend the races.

ADDITIONAL REPORTS BANGALORE SUMMER MEETING 2023 SIXTH DAY, SUNDAY , 4TH JUNE, 2023

Race: 40. The Udhagamandalam Plate - (About) 1200 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible).

An enquiry was held into the running and riding of RICARDO, trained by Mr. Arjun Mangalorkar and ridden by Jockey Tadhg O' Shea in the above race. After due enquiry, Jockey Tadhg O' Shea was fined Rs.15,000/- for not sufficiently preserving with his mount during the race. Trainer Mr. Arjun Mangalorkar was cautioned as to the future running of his charges and as to the selection of his riders.

TWELFTH DAY, SUNDAY , 25TH JUNE, 2023

Race: 84. The Uppini Revanna Siddheshwarappa Memorial Cup -(About) 1600 metres. Horses rated 40 to 65.

An enquiry was held on 23/7/2023 into the running and riding of VICTORIA PUNCH, trained by Mr. Irfan Ghatala and ridden by Jockey A.Ramu in the above race. After due enquiry, Jockey A. Ramu, the rider of VICTORIA PUNCH was fined Rs.10,000/- for not making sufficient effort to improve his position till about 500 Metres. Trainer Mr. Irfan Ghatala was cautioned as to the future running of his charges and as to the selection of his riders.

SEVENTEENH DAY, SATURDAY , 15TH JULY, 2023

Race: 122. The R. R. Byramji Memorial Cup - (About) 1400 metres. 3year -old horses (foaled in 2020).

The Stipendiary Stewards reported Jockey S. Zervan to the Stewards for Dangerous Riding [Rule No. 161 (i) of the B.T.C. Rules of Racing] on his mount FAST PACE in the above race.

The Stewards held an enquiry on 23rd July, 2023 and examined Jockey S. Zervan.

The Stewards considered the following:

- (a) Charge sheet issued to Jockey S. Zervan by the Stipendiary Steward;
- (b) The Submissions made by Jockey S. Zervan during the enquiry;
- (c) Stewards viewed various angles of the race with specific reference to the interference caused by Jockey S. Zervan;
- (d) The Stewards noted that Jockey S. Zervan had not pleaded guilty to the alleged breach of Contravening Rule No. 161 (i) of the BTC Rules of Racing as charged by the Stipendiary Steward.

Thereafter, the Stewards arrived at a unanimous decision that Jockey **S. Zervan** was **"Guilty"** as charged in the matter and decided as follows:-

- (a) To suspend the Jockey's Licence granted to S. Zervan for the period from 2/8/2023 to 4/8/2023 (Both days inclusive) and further his licence shall stand suspended for the period including the first four (4) race days of Bangalore Winter Meeting 2023-24 for Dangerous Riding [Rule No. 161 (i) of the BTC Rules of Racing] on his mount FAST PACE in the above race (he is permitted to ride work).
- (b) He was informed of his right to appeal to the Board of Appeal.
