# BANGALORE SUMMER MEETING 2023 FIFTEENH DAY, SATURDAY, 8<sup>TH</sup> JULY, 2023 RACING INCIDENTS (103 - 109)

**GOING: Good** 

**PENETROMETER READING: 4.2 Cms.** 

RAILING POSITION: Railing fixed at average width of 9.0 Meters from 1600 Meters to winning post from its original position.

(It rained heavily in the first and second race of the day & after due inspection of the track the railing was fixed at its original position and going turned heavy).

### 1<sup>st</sup> Race: 103. The Bhishma Plate - (About) 1400 metres. Horses rated 20 to 45, 4 years old and over (Whips not allowed) (7 Runners).

It was reported after the race that OSIRIS (Naveen M.) burst its blood vessels. Trainer Mr.Sharat Kumar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g MUSTERION.

### 2<sup>nd</sup> Race: 104. The Basque Plate - Div. II - (About) 1200 metres. Horses rated 20 to 45 (10 Runners).

As Jockey Surya. P was certified medically unfit to ride. Permission was granted to trainer Mr. Azhar Ali to declare Jockey Mohammed Aliyar.M to ride SOUTHERNARISTOCRAT in place of the declared rider.

Jockey S. Saba, the rider of DESERTDRAGON reported that his mount was not galloping fluently after entering the straight. The horse was subjected to veterinary examination. On examination it was found to have pre-molar caps. Trainer Mr. M. Rajendra Singh was informed to take appropriate corrective measures before accepting with it again.

PHOEBE (Inayat) sustained superficial injury on left hind pastern.

Routine Sample was taken for analysis from the winner b q RIVAL.

## 3<sup>rd</sup> Race: 105. The Mauritius Pearl Plate - (About) 1400 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (10 Runners).

SPACEX (Mohammed Aliyar) jumped awkwardly outwards.

KALLANIA (A.R.Pradeep) jumped awkwardly inwards.

Jockey A. Ayaz Khan, the rider of VINAMRAO reported that he accidently lost his whip approaching 500 Meters.

Routine Sample was taken for analysis from the winner b g IRISH COFFEE.

### 4<sup>th</sup> Race: 106. The Lagarde Plate - (About) 1200 metres. Horses rated 60 to 85 (8 Runners).

Jockey Inayat, the rider of AMRELI was reprimanded for shifting out and inconveniencing ETOSHA (S. Zervan) on his outside rounding the final bend.

Jockey S. Zervan, the rider of ETOSHA reported that his mount was lugging 'in' under pressure during the race.

Jockey Arvind Kumar. N, the rider of DEL MAR reported that his mount was not galloping fluently after entering the straight. The horse was subjected to veterinary examination. On examination, it was found to have sustained bleeding cut injury on right fore coronet.

Routine Sample was taken for analysis from the winner b c ASHWA YUDHVIR.

## 5<sup>th</sup> Race: 107. The Fire Haven Plate - (About) 1600 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (10 Runners).

WOLF CREEK (Hindu Singh) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.James Mckeown was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Routine Sample was taken for analysis from the winner b f IRISH ROCKSTAR.

## 6<sup>th</sup> Race: 108. The D.M. Kumaraswamy Memorial Cup - (About) 1400 metres. Horses rated 40 to 65, 4 years old and over (8 Runners).

Jockey P. Trevor, the rider of SILVER CANYON was fined Rs.1,000/- for shifting out and taking out SCRIBBLING HOPPER (Antony Raj S.) on his outside passing the 500 Metres.

Routine Sample was taken for analysis from the winner b g PRINCE ABIR.

## 7<sup>th</sup> Race: 109. The Basque Plate - Div. I - (About) 1200 metres. Horses rated 20 to 45 (10 Runners).

Routine Sample was taken for analysis from the winner dk b c BRILLIANT STAR.

## Race: 116. The Sunday Silence Plate - Div. II - (About) 1400 metres. Horses rated 20 to 45, 5 years old and over (Whips not allowed).

The Board of Appeal of Bangalore Turf Club Ltd., at its meeting held on 5<sup>th</sup> July, 2023 considered the appeal dated 26<sup>th</sup> May, 2023 addressed by Trainer Mr. V. Narayana Gowda against the decisions of the Stewards at their meeting held on 17<sup>th</sup> May, 2023.

  - a) Letter dated 1/6/2023 issued to Trainer Mr. V. Narayana Gowda to appear before the Board of Appeal by the Secretary;
  - b) Appeal letter dated 26/5/2023 by Trainer Mr. V. Narayana Gowda;
  - c) Order of the Board of Appeal to stay the punishment imposed on Trainer Mr. V. Narayana Gowda dated 26/5/2023;
  - d) Written Grounds of Appeal dated 4/6/2023 filed by Trainer Mr. V. Narayana Gowda;
  - e) Rules of Racing of Bangalore Turf Club Limited;
  - f) Racing Calendar of Bangalore Turf Club Limited.

## BANGALORE WINTER MEETING 2022-23 FIFTEENTH DAY, FRIDAY, 17<sup>TH</sup> FEBRUARY, 2023

## Race: 116. The Sunday Silence Plate - Div. II - (About) 1400 metres. Horses rated 20 to 45, 5 years old and over (Whips not allowed).

The Stipendiary Stewards reported Trainer Mr. Naryana Gowda. V to the Stewards for contravention of B.T.C Calendar Notification under the heading "PUNISHMENT TO TRAINERS BY STIPENDIARY STEWARDS / STEWARDS (Under Clause -8)" read with of Rule No.202 (xvi) of the BTC Rules of Racing in respect of his charge TWILIGHT FAME.

In that his charge TWILIGHT FAME ran in a inconsistent manner and exhibiting reversal of form wherein, it won in the above race as compared to its previous run in Race No. 109 i.e., The Kabini Plate – Div. III – (About) 1200 metres. Horses rated 20 to 45 run on 10/2/2023 wherein it ran unplaced, when ridden by Jockey Angad.

The Stewards held an enquiry on 17<sup>th</sup> May, 2023 and examined Trainer Mr. Naryana Gowda. V.

#### The Stewards considered the following:

- 1. The Charge sheet issued to Trainer Mr. Narayana Gowda. V by the Stipendiary Steward;
- 2. The Submissions made by Trainer Mr. Narayana Gowda. V during the enquiry;
- 3. The Stewards viewed the Race No. 109 and the above race;
- 4. There has been total inconsistency into the running of his charge TWILIGHT FAME between 10/2/23 and 17/2/2023;
- 5. The Stewards noted that Trainer Mr. Narayana Gowda.V could not offer any valid explanations to the reversal of form.
- 6. The explanations tendered by Trainer Mr. Narayana Gowda.V for running of his charge in such short time when it had performed poorly was not acceptable at all.
- 7. The Stewards noted that Trainer Mr. Narayana Gowda. V had not pleaded guilty of alleged breach of Contravention of B.T.C Calendar Notification under the heading "PUNISHMENT TO TRAINERS BY STIPENDIARY STEWARDS / STEWARDS (Under Clause -8)" read with of Rule No.202 (xvi) of the BTC Rules of Racing as charged by the Stipendiary Steward.

Thereafter in their collective wisdom, they unanimously decided that Trainer Mr. Narayana Gowda. V was "Guilty" as charged in the matter.

In light of the above, the Stewards decided as under:

- (a) To suspend the trainer's licence granted to trainer Mr. Narayana Gowda.V w.e.f **27**<sup>th</sup> **May, 2023 to 11**<sup>th</sup> **June, 2023 (Both days inclusive)** and fine him a sum of **Rs. 50,000/-** for contravention of B.T.C Calendar Notification under the heading "PUNISHMENT TO TRAINERS BY STIPENDIARY STEWARDS / STEWARDS (Under Clause 8)" read with of Rule No.202 (xvi) of the BTC Rules of Racing in respect of his charge TWILIGHT FAME.
- (b) He was informed of his right to appeal before the BTC Board of Appeal within the frame work of BTC Rules of Racing.

The Board of Appeal carefully considered the above. After great deal of deliberations, considering the oral submissions made by Mr. S.S. Attaollahi (Spokesperson for Trainer Mr. V. Narayana Gowda) and applying their mind to the whole matter the board of appeal unanimously decided as follows:

That trainer Mr. V. Narayana Gowda contravened relevant Rules and Regulations of BTC Rules of Racing.

That the suspension meted out to the trainer's licence for a period of fifteen days by the Stewards to Trainer Mr. V. Narayana Gowda was inadequate especially considering the gravity of offence the Board decided to enhance the punishment to twenty eight days, as they held Trainer Mr. V. Narayana Gowda "guilty as charged" in this matter.

#### Thereafter, the board unanimously decided as under:

- a) To reject the appeal filed by Trainer Mr. V. Narayana Gowda;
- b) The revised order of suspension is with effect from 7<sup>th</sup> July, 2023 to 4<sup>th</sup> August, 2023 (Both days inclusive) for contravention of B.T.C Calendar Notification under the heading "PUNISHMENT TO TRAINERS BY STIPENDIARY STEWARDS / STEWARDS (Under Clause - 8)" read with of Rule No.202 (xvi) of the BTC Rules of Racing in respect of his charge TWILIGHT FAME.
- c) The fine of Rs.50,000/- was sustained;
- d) To forfeit Rs.11,800/- (Inclusive GST) paid by Trainer Mr. V. Narayana Gowda towards the Appeal fee.

## Race: 78. The Chief Justice's Cup (Grade III) - (About) 1800 metres. 4 years old and over.

The Stipendiary Stewards reported Jockey P. S. Chouhan, the rider of KING'S RANSOM to the Stewards for Dangerous Riding [Rule No. 161 (i) of the B.T.C. Rules of Racing] in the above race. In that he shifted 'in' sharply under the use of whip, thereby causing severe interference to MOJITO (A. Imran Khan), which in turn passed it onto JAKE (Antony Raj.S) on his inside in the final 200 Metres. Thus, riding in a Dangerous Manner. The Stewards held an enquiry after the last race and examined the Jockeys concerned P. S. Chouhan (KING'S RANSOM), A.Imran Khan (MOJITO) and Antony Raj. S (JAKE), they viewed the CCTV replay of the race in question from various angles. After deliberations, they decided to suspend the Jockey's licence granted to P. S. Chouhan from 4th July, 2023 to 16th July, 2023 (Both days inclusive) and fine him a sum of Rs.25,000/- for Dangerous Riding [Rule No. 161 (i) of the B.T.C. Rules of Racing] on his mount KING'S RANSOM in the above race (he is permitted to ride work) and he was informed of his right to appeal.

The Board of Appeal carefully considered the above. After viewing the CCTV replay of the race from various angles, considered the oral submissions of Jockey P.S. Chouhan and applying their mind to the whole matter the board of appeal unanimously decided Jockey P.S. Chouhan was "Guilty" as charged in the matter and had contravened Rule No. 161 (i) of the BTC Rules of Racing.

Thereafter, they decided as under:

- f) To sustained the suspension with effect from 4<sup>th</sup> July, 2023 to 16<sup>th</sup> July, 2023 (Both days inclusive) and;
- g) To increase the fine of Rs.25,000/- to Rs. 40,000/- for Dangerous Riding [Rule No. 161 (i) of the B.T.C. Rules of Racing] on his mount KING'S RANSOM in the above race (he is permitted to ride work).
- h) To forfeit Rs.11,800/- (Inclusive GST) paid by Jockey P.S. Chouhan towards the Appeal fee.
