# BANGALORE SUMMER MEETING 2023 FIRST EXTRA DAY, FRIDAY , 18<sup>TH</sup> AUGUST, 2023 RACING INCIDENTS (181 - 188)

# GOING : Good PENETROMETER READING: 3.2 Cms. RAILING POSITION: Railing fixed at average width of 2 Metres from 1600 Metres to winning post from its original position.

## 1<sup>st</sup> Race: 181. Betway World Photography Day Stakes - (About) 1400 metres. Horses rated 00 to 25 (10 Runners).

Jockey Vinod Shinde, the rider of INFINITE SPIRIT reported that his mount was hanging out from 600 Metres. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. V. Lokanath was informed to take appropriate corrective measures before accepting with it again.

Jockey Shreyas Singh S, the rider of RUSSIAN ROMANCE reported that his mount was not galloping fluently during the race. The horse was subjected to veterinary examination but no abnormality was reported.

At the request of Trainer Mr. Prithviraj B., endoscopy was performed on ULTIMATE CHOICE and no abnormality was found.

An enquiry is being held into the running and riding of LADY GODIVA, trained by Mr. S. Inayathulla and ridden by Jockey Chethan Kalay .S in the above race.

Routine Sample was taken for analysis from the winner b m ALTAMONTE.

#### 2<sup>nd</sup> Race: 182. The Sha Tin Stakes - Div. II - (About) 1200 metres. Horses rated 20 to 45, 4 years old and over (10 Runners).

Trainer Mr. Sharat Kumar was fined Rs.5,000/- for discrepancy in shoeing in respect of his charge OXYTOCIN (1st infringement).

OXYTOCIN (Afsar Khan) planted and lost considerable ground at the start. In view of its behaviour, Trainer Mr.Sharat Kumar was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Antony Raj S., the rider of DOMINA reported that his mount was inclined to run out between the 700 Metres till about 300 Metres.

At the request of Trainer Mr. Sharat Kumar, endoscopy was performed on OXYTOCIN and no abnormality was found.

Routine Sample was taken for analysis from the winner b m SUPER RUFFIAN.

# <u>3<sup>rd</sup> Race: 183. The Baraloy Stakes - (About) 1600 metres. Horses</u> rated 20 to 45, 6 years old and over (8 Runners).

Jockey K.G. Likith Appu, the rider of QUEEN REGNANT was fined Rs.1,000/for shifting 'in' and causing interference to OMBUDSMAN (Shreyas Singh S) on his inside passing the 1400 Metres. Trainer Mr. M. Rajendra Singh was fined Rs.10,000/- for the inconsistent pattern of running of his charge ANTILOPE (Dharshan Antony.B) resulting in reversal of form in the above race as compared to its previous run in Race No. 171 i.e., The Xisca Plate - (About) 1400 metres. Horses rated 20 to 45, 5 years old and over run on 11/8/2023 wherein it ran unplaced.

Routine Sample was taken for analysis from the winner b h ANTILOPE.

#### 4<sup>th</sup> Race: 184. The Holding Court Stakes - Div. II - (About) 1400 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible). (11 Runners).

As Jockey Yash Narredu was certified medically unfit to ride. Permission was granted to trainer Mr. S. Narredu (deputising on behalf of Trainer Mr. Rajesh Narredu) to declare Jockey P. Trevor to ride BURMESE in place of the declared rider.

EXELERO (Arul J.H) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Darius R. Byramji was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Hindu Singh, the rider of TRUTH IN WINE was fined Rs.2,000/- for shifting 'in' and causing interference to DOUBLE SCOTCH (Mohammed Aliyar) on his inside passing the 1200 Metres.

CLYDE STAR (A.Ramu) sustained superficial injury on left hind cannon, inner gaskin & hock and right gaskin.

Routine Sample was taken for analysis from the winner b f BURMESE.

#### 5<sup>th</sup> Race: 185. The August Stakes - Div. II - (About) 1200 metres. Horses rated 40 to 65, 4 years old and over (9 Runners).

OPUS ONE (S. Saqlain) jumped out awkwardly onto SUPER KIND (A.R.Pradeep) soon after the start.

Jockey S. John, the rider of ALDGATE was fined Rs.2,000/- for shifting 'in' and causing interference to STARS ABOVE (K.G. Likith Appu), which in turn passed it onto DEVILS MAGIC (Inayat) on his inside approaching 1000 Metres.

Jockey S. John, the rider of ALDGATE was fined Rs.1,000/- for shifting 'in' and causing interference to OPUS ONE (S. Saqlain) on his inside passing the 1000 Metres.

Jockey Vivek.G, the rider of AGERA reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination. On examination, it was found to have bit injury on left oral commissure.

Jockey Inayat, the rider of DEVILS MAGIC was fined Rs.5,000/- for shifting out and causing interference to the horses on his outside viz; AUGUSTO (Arvind Kumar. N) and GROOVIN (P. Trevor) approaching 200 Metres.

FORTY NINER (Akshay Kumar) sustained superficial clip injury on left hind outer cannon.

Routine Sample was taken for analysis from the winner b g ALDGATE.

# 6<sup>th</sup> Race: 186. The Holding Court Stakes - Div. I - (About) 1400 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible). (11 Runners).

Jockey Hindu Singh, the rider of SUPER STRIDE was reprimanded for shifting 'in' and tightening SEVENTH SAMURAI (Antony Raj S.) on his inside approaching 1100 Metres.

Jockey Vivek.G, the rider of PALOMINO was fined Rs.2,000/- for shifting out and causing interference to RED FALCON (S. Saqlain) on his outside approaching 300 Metres.

Jockey Vishal N Bunde, the rider of HIGH SPEED DIVE was fined Rs.5,000/for shifting 'in' and causing severe interference to RED FALCON (S. Saqlain) between the 300 Metres & 250 Metres.

Jockey C.Umesh, the rider of LORD MOI was fined Rs.1,000/- for not maintaining a straight course, whereby he shifted out and inconvenienced RED FALCON (S. Saqlain) in the final 150 Metres.

LORD MOI (C.Umesh) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g LORD MOI.

# 7<sup>th</sup> Race: 187. The August Stakes - Div. I - (About) 1200 metres. Horses rated 40 to 65, 4 years old and over (8 Runners).

Trainer Mr.S. Narredu was fined Rs.5,000/- for discrepancy in shoeing in respect of his charge ETERNAL PRINCESS (Vinod Shinde) (1st infringement).

ALWAYS HAPPY (Akshay Kumar) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Prasanna Kumar was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

It was reported after the race that ALWAYS HAPPY (Akshay Kumar) pulled up lame on left fore. Trainer Mr.Prasanna Kumar was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

ARCHWAY (Antony Raj S.) sustained superficial injury on right hock, outer gaskin and left hock.

Routine Sample was taken for analysis from the winner b g ENGLISH BAY.

#### 8<sup>th</sup> Race: 188. The Sha Tin Stakes - Div. I - (About) 1200 metres. Horses rated 20 to 45, 4 years old and over (9 Runners).

Permission was granted to trainer Mr. Sharat Kumar to withdraw THE GOLDEN DREAM (Naveen M.) from the above race.

DEFINING POWER (Rajesh Kumar M) jumped out awkwardly and lost few lengths. In view of its behaviour, Trainer Mr.Narayana Gowda V. was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

CASTANEDA (Antony Raj S.) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Arjun Mangalorkar was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

It was reported after the race that WISH AGAIN (IndraJeet Singh) pulled up lame on left fore. Trainer Mr.Neil B Devaney was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

EMPIRE OF DREAMS (Vivek.G) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b m AIR DISPLAY.
