BANGALORE SUMMER MEETING 2024 FOURTH DAY, SATURDAY, 20th JULY 2024 RACING INCIDENTS

<u>(25 - 31)</u>

GOING: Good

PENETROMETER READING: 4.4 Cms.

RAILING POSITION: Railing fixed at average width of 4.0 Meters from 1600 Meters to winning post from its original position.

1st Race: 25. The Beautiful Babe Plate - (About) 1400 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (11 Runners).

MARTHA (Vivek.G) dropped the rider on the way to the starting gates and galloped anticlockwise from winning post upto 1400 Metres. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under starter's order. Trainer Mr. Prasanna Kumar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was observed that BESTIDENTIFICATION (K. Sai Kiran) was inclined to run out between the 900 Metres till about 600 Metres.

It was observed that SPARKLING DEW (D'nuSingh Deora) was inclined to run out between the 900 Metres till about 600 Metres.

Jockey D. Patel, the rider of GROUSE MOUNTAIN reported that his mount was running green throughout the race.

Jockey Shreyas Singh S, the rider of EL ASESINO reported that his mount stopped galloping in the final 200 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

POWER OF BEAUTY (Darshan R.N) pulled up its right testicle.

An enquiry was held by the Stipendiary Steward into the interference caused by Jockey L. Alex Rozario, the rider of WONDERLAND in the above race. In that he did not exercise sufficient control on his mount, in the process shifted 'in' and caused interference to WILD CANNON (Neeraj Rawal), which in turn passed in onto FINAL CALL (A. Sandesh) approaching 250 Metres and for further shifting out and causing interference to the horses on his outside viz; EL ASESINO (Shreyas Singh S) and CHOTIPARI (J. Chinoy) in the final 75 Metres.

Jockey L. Alex Rozario was interviewed by the Stipendiary Steward. The Stipendiary Steward after considering the submissions made by Jockey L. Alex Rozario and after viewing the CCTV replay decided to charge Jockey L. Alex Rozario for Careless Riding.

The Stipendiary Steward thereafter suspended the Jockey's Licence granted to L. Alex Rozario for *four (4) race days of Bangalore Summer Meeting* **2024** *i.e.,* **2/8/2024, 3/8/2024, 8/8/2024 & 9/8/2024** as he had pleaded guilty to the charge under Rule No. 161 (i) of the BTC Rules of Racing for Careless Riding on his mount WONDERLAND (he was permitted to ride work) and was informed of his right to appeal.

Routine Sample was taken for analysis from the winner b c CASTEEL.

2nd Race: 26. The Lady Gibraltar Plate - (About) 1200 metres. Horses rated 00 to 25 (8 Runners).

Permission was granted to Trainer Mr.S. Inayathulla to withdraw MY SPACE (V.R.Jagadeesh) on veterinary grounds as it was found to be lame on right fore due to tendinitis. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Antony Raj S., the rider of EMPRESS BELLA reported that his mount was inclined to run out from the start till about 1000 Metres.

Jockey Antony Raj S., the rider of EMPRESS BELLA was reprimanded for shifting 'in' and inconveniencing BURNING ARROW (Rajesh Kumar M) on his inside passing the 350 Metres.

At the behest of the trainer's written complaint, an enquiry is being held into the running and riding of CAPRI GIRL, trained by Mr. M. Rajendra Singh and ridden by Jockey K. Sai Kiran in the above race.

Routine Sample was taken for analysis from the winner b g BRAVE MAJESTY.

3rd Race: 27. The Ministerial Plate - (About) 1600 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (7 Runners).

Permission was granted to Trainer Mr. Prasanna Kumar to withdraw MICHIKO (K. Sai Kiran) on veterinary grounds as it was found to be suffering from fever. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

QUEEN OF KINGS (V.R.Jagadeesh) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.Rajesh Narredu was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Salman Khan, the rider of ROYAL WHISPER was fined Rs.1,000/- for shifting 'in' and tightening VERRAZZANO (Suraj Narredu) on his inside passing the 800 Metres.

Routine Sample was taken for analysis from the winner b g MANDARINO.

4th Race: 28. The V.T. Velu Memorial Cup - (About) 1600 metres. Horses rated 40 to 65 (8 Runners).

TIEPOLO (Vivek.G) was extremely fractious, reared up, stuck inside the gates and sat down for a considerable period of time. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

ROMAN SPIRIT (Tousif Khan) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.S. Dominic was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

ARMORY (Rajesh Kumar M) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Narayana Gowda V. was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

An enquiry was held by the Stipendiary Steward into the interference caused by Jockey Ram Nandan Manjhi, the rider of SOUTHERN POWER in the above race. In that he shifted 'in' and causing severe interference to ARMORY(Rajesh Kumar.M) on his inside passing the 1400 Metres.

Jockey Ram Nandan Manjhi was interviewed by the Stipendiary Steward. The Stipendiary Steward after considering the submissions made by Jockey Ram Nandan Manjhi and after viewing the CCTV replay decided to charge Jockey Ram Nandan Manjhi for Careless Riding.

The Stipendiary Steward thereafter suspended the Jockey's Licence granted to Ram Nandan Manjhi for *four (4) race days of Bangalore Summer Meeting 2024 i.e., 2/8/2024, 3/8/2024, 8/8/2024 & 9/8/2024* as he had pleaded guilty to the charge under Rule No. 161 (i) of the BTC Rules of Racing for Careless Riding on his mount SOUTHERN POWER (he was permitted to ride work) and was informed of his right to appeal.

Routine Sample was taken for analysis from the winner b g ELFIN KNIGHT.

5th Race: 29. The Jayachamaraja Wadiyar Cup - (About) 1400 metres. 4 years old and over. (7 Runners).

Routine Sample was taken for analysis from the winner b h SHAMROCK.

6th Race: 30. The Ramkirpal Plate - (About) 1200 metres. Horses rated 20 to 45, 4 years old and over (10 Runners).

THE BLISSFULELYSEE (K. Sai Kiran) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Warren Singh was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey S.J. Moulin, the rider of SPRINGSTEEN reported that he could not get a clear run between the 900 Metres and 800 Metres due to closely packed feld.

Jockey Ahsan Qureshi, the rider of STAR CONCEPT was reprimanded for dropping hands before passing the winning post.

STAR CONCEPT (Ahsan Qureshi) sustained superficial injuries on both hind cannon.

Trainer Mrs. Parvati Byramji and Jockey Akshay Kumar were questioned regarding running and riding of RIVER OF GOLD in the above race. The trainer stated that:

- 1. This horse has not performed well in its previous starts.
- 2. This horse had lot of veterinary problems for which it was treated.
- 3. Subsequent, to treatment the horse had been regularly in work and also participated in the Mock Race, where it performed decently.
- 4. She had instructed the rider to take a good jump, keep it in the mid bunch and do his best in the straight.
- 5. The rider followed the riding instructions but the response of the horse was not up to the mark.

Jockey while corroborating statements of trainer, stated that his mount was making roaring noise in the final 200 Metres. The horse was impounded for veterinary examination but no abnormality was reported.

Their explanations were noted for future reference.

Surprise sample was taken for analysis from dk b g RIVER OF GOLD.

Routine Sample was taken for analysis from the winner ch m INDIAN BLUES.

7th Race: 31. The Supervite Plate - (About) 1400 metres. Horses rated 20 to 45, 4 years old and over (9 Runners).

CASTANEDA (S. Hussain) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Arjun Mangalorkar was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

SUPER SAPPHIRE (Siddaraju.P) sustained superficial clip injury on right hind cannon.

Routine Sample was taken for analysis from the winner b f ZURI.

Permission was granted to trainer Mr. S.S. Attaollahi to deputize on behalf of trainer Mr. P.Shroff who was unable to attend the races.
