# BANGALORE SUMMER MEETING 2024 SIXTH DAY, SATURDAY, 27<sup>th</sup> JULY 2024 RACING INCIDENTS

(38 - 44)

**GOING:** Good

PENETROMETER READING: 3.6 Cms.

RAILING POSITION: Railing fixed at average width of 8.0 Meters from 1600 Meters to winning post from its original position.

1<sup>st</sup> Race: 38. The Udhagamandalam Plate - Div. II - (About) 1200 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (8 Runners).

Jockey B. Nayak, the rider of AMUSING was fined Rs.1,000/- for coming 'in' and tightening GLAZE (Kiran Rai P) on his inside passing the 800 Metres.

Jockey J. Chinoy, the rider of ENJOYABLE reported that his mount was running green during the race.

Jockey D. Patel, the rider of NOBLE CAUSE reported that his mount was running green throughout the race.

AMUSING (B. Nayak) sustained superficial injury on left fore cannon and left fore tendon.

NOBLE CAUSE (D. Patel) sustained clip injury on right hock.

Routine Sample was taken for analysis from the winner b q IL VOLO.

## 2<sup>nd</sup> Race: 39. The Aureole Time Plate - (About) 1400 metres. Horses rated 00 to 25 (9 Runners).

FIREFINCH (Chandrashekar M) jumped awkwardly inwards onto SUNLIT PATH (B. R. Kumar) soon after the start.

Jockey Arvind Kumar.N, the rider of ALACERO was fined Rs.5,000/- for coming 'in' and tightening the horses on his inside viz; PRINCESS GOLD(Ikram Ahmed) and FIREFINCH (Chandrashekar. M)soon after the start.

Jockey Ikram Ahmed, the rider of PRINCESS GOLD reported that he lost his right stirrup soon after the start, which he regained passing the 1000 Metres.

Jockey Chandrashekar M, the rider of FIREFINCH was reprimanded for riding an indifferent race.

FRIYA (D'nuSingh Deora) sustained superficial injury on right hock.

Routine Sample was taken for analysis from the winner dk b g CAT WHISKERS.

# 3<sup>rd</sup> Race: 40. The Udhagamandalam Plate - Div. I - (About) 1200 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (8 Runners).

Permission was granted to trainer Mr. S. Narredu to withdraw PRICELESS PRINCE (Suraj Narredu) in the above race. An enquiry is being held into the incident.

IMPERIAL EMPEROR (Vinod Shinde) after jumping out did not raise a fluent gallop for the first 100 Metres. In view of its behaviour, Trainer Mr.Rajesh Narredu was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

DR ASH (L. Alex Rozario) was slowly away, lost few lengths at the start and ran detached thereafter. In view of its behaviour, Trainer Mr.Irfan Ghatala was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Vivek.G, the rider of IRON KING reported that his mount was lugging 'in' under pressure in the final 150 Metres.

It was observed that FEELING GOOD (Faizan Khan) was inclined to run out till about 600 Metres.

CONTINUES (Darshan R.N) was impounded for veterinary examination. On examination, it was found to have bit sore on right oral commissure.

Surprise sample was taken for analysis from ch g CONTINUES.

Routine Sample was taken for analysis from the winner ch c DON CARLOS.

## 4<sup>th</sup> Race: 41. The S. G. Madhukar Memorial Trophy - (About) 1400 metres. Horses rated 40 to 65 (8 Runners).

SUPER MARVELLA (Neeraj Rawal) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Neil B Devaney was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

LEX LUTHOR (S. Hussain) jumped awkwardly outwards.

Jockey Vivek.G, the rider of KING'S BATTALION reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination. On examination, it was found to have sustained injury on right hind fetlock.

Jockey Akshay Kumar, the rider of BHARAT was fined Rs.5,000/- for shifting out and taking out PERSIAN ROCK (Rayan Ahmed R.), which in turn passed it onto FOREST FRAGRANCE (A. Sandesh) on his outside passing the 450 Metres.

Routine Sample was taken for analysis from the winner b f CROSSWATER.

## 5<sup>th</sup> Race: 42. The Sir M. Visvesvaraya Memorial Trophy - (About) 1600 metres. Horses rated 60 to 85 (8 Runners).

SPLENDIDO (Antony Raj S.) jumped awkwardly outwards onto SIERRA DELA PLATA (Neeraj Rawal) and IRISH COFFEE (Darshan R.N) soon after the start.

Jockey Vivek.G, the rider of AQUAMATIC reported that his mount was very keen between the 1500 Metres till about approaching 1300 Metres, as such he had to check his mount to avoid striking the front runner MADAM RICH (A. Sandesh) passing the 1200 Metres.

Jockey Darshan R.N, the rider of IRISH COFFEE reported that his mount was not galloping fluently after entering the straight, as such he stopped riding. The horse was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner ch f WEST BROOK.

## 6<sup>th</sup> Race: 43. The Elite Force Plate - (About) 1200 metres. Horses rated 20 to 45 (7 Runners).

THEWHISPERQUIETLY (Tousif Khan) reared up and was stuck inside the gates, sat down for a considerable period of time. On immediate examination, it was found to have sustained superficial injury on both sides of barrel. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

LA MCQUEEN (Antony Raj S.) reared up, stuck inside the gates and sat down for a considerable period of time. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

SUPER VELOCE (K. Sai Kiran) took a fly jump.

OOH LA LA (P. Mani) ran detached from the 700 Metres. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Faraz Arshad was informed to ensure better performance of his charge in future.

Routine Sample was taken for analysis from the winner b g BOURBONAIRE.

# 7<sup>th</sup> Race: 44. The Star Contender Plate - (About) 1200 metres. Horses rated 20 to 45, 5 years old and over (8 Runners).

BENZEMA (Shreyas Singh S) bolted and completed 1000 Metres on the way to the saddling yard. Under the circumstances, it was permitted to be withdrawn on veterinary grounds. Trainer Mr. Faraz Arshad was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

STAR ADMIRAL (A. Sandesh) reard up and fell in the saddling yard. On immediate examination it was found to have sustained injuries on hip and splayed both hind shoes. Under the Circumstances, it was permitted to be withdrawn on veterinary grounds. Trainer Mr. Aravind G. was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Surprise sample (Blood) was taken for analysis from b g STAR ADMIRAL.

Routine Sample was taken for analysis from the winner b g THE ATHABASCA.
