### BANGALORE SUMMER MEETING 2024 ELEVENTH DAY, WEDNESDAY, 14<sup>TH</sup> AUGUST 2024 RACING INCIDENTS

### **GOING : Good**

#### **PENETROMETER READING: 3.7 Cms.**

**RAILING POSITION:** Railing fixed at average width of 7.0 Meters from 1600 Meters to winning post from its original position.

# 1<sup>st</sup> Race: 69. The Littleover Plate - (About) 1200 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (10 Runners).

As Jockey Arshad Alam was certified medically unfit to ride. Permission was granted to trainer Mr. Azhar Ali to declare Jockey K. Sai Kiran to ride AMUSING in place of the declared rider.

ANANYA (Shreyas Singh S) jumped awkwardly outwards and inconvenienced NAPOLEAN (Akshay Kumar) soon after the start.

HAVASKA (S. Hussain) took a fly jump.

It was observed that HAVASKA (S. Hussain) accidentally brushed the running rails passing the 1000 Metres.

Jockey Suraj Narredu, the rider of STAR HONOUR reported that there was a lot of kick back of earth as such his mount was slowing down between the 900 Metres & 600 Metres.

Jockey Faizan Khan, the rider of CONNECTING DOTS reported that he could not get a clear view between the 900 Metres to 700 Metres due to kick back of the earth.

Jockey K. Sai Kiran, the rider of AMUSING reported that he could not get a clear view between the 900 Metres to 700 Metres due to kick back of the earth.

Jockey Faizan Khan, the rider of CONNECTING DOTS was fined Rs. 3,000/- for not making sufficient effort on his mount in the final 350 Metres.

Jockey K. Sai Kiran, the rider of AMUSING was reprimanded for riding an indifferent race.

HAVASKA (S. Hussain) was subjected to veterinary examination. On examination it was found to have bit sore on left oral commissure. Trainer Mr. Arjun Mangalorkar was informed to take remedial measures before accepting with it again.

ANANYA (Shreyas Singh S) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g TRUE PUNCH.

### 2<sup>nd</sup> Race: 70. The Tudor Jet Stakes - (About) 1400 metres. Horses rated 20 to 45 (9 Runners).

As Jockey Arshad Alam was certified medically unfit to ride. Permission was granted to trainer Mr. Azhar Ali to declare Jockey K. Sai Kiran to ride SOUTHERNARISTOCRAT in place of the declared rider.

Jockey K. Sai Kiran, the rider of SOUTHERNARISTOCRAT reported that his mount was not stretching out fully during the race. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Imtiaz Khan (deputising on behalf of Trainer Mr. Azhar Ali) was informed to ensure better performance of his charge in future.

Jockey S. Hussain, the rider of SEA JACK was fined Rs.3,000/- for not sufficiently persevering his mount in the final 250 Metres.

Routine Sample was taken for analysis from the winner b f JOON.

### <u>3<sup>rd</sup> Race: 71. The Mamma's Mink Plate - (About) 1600 metres. Horses rated</u> <u>40 to 65, 4 years old and over (8 Runners).</u>

As Jockey Arshad Alam was certified medically unfit to ride. Permission was granted to trainer Mr. Azhar Ali to declare Jockey K. Sai Kiran to ride AIRCRAFT in place of the declared rider.

Jockey Vivek.G, the rider of KING OF WAR reported that his mount did not like the underfoot conditions of the track (hard ground).

It was observed that STAR CONCEPT (Siddaraju.P) accidentally brushed the running rails passing the 500 Metres.

Routine Sample was taken for analysis from the winner b f SASSY.

### 4<sup>th</sup> Race: 72. The Dr. K.M. Srinivasa Gowda Memorial Trophy - (About) 1200 metres. Horses rated 40 to 65 (9 Runners).

As Jockey Arshad Alam was certified medically unfit to ride. Permission was granted to trainer Mr. Imtiaz Khan to declare Jockey L. Alex Rozario to ride REMONTOIR in place of the declared rider.

As Jockey S.J. Moulin could not arrive in time to fulfill his riding engagement (flight rescheduled). Permission was granted to trainer Mr. Vijay Singh to declare Jockey J. Chinoy to ride LIGHT THE WORLD in place of the declared rider.

ASHWA VEDHA (Siddaraju.P) fell in the saddling enclosure. On immediate examination by the Club's Veterinary Officer, it was found to have sustained injuries on both fore fetlocks, right knee and both hocks. Under the circumstances, it was permitted to be withdrawn on veterinary grounds. Trainer Mr. S. Narredu was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

REMONTOIR (L. Alex Rozario) jumped awkwardly inwards.

Jockey Vivek.G, the rider of KNOTTY ONE was fined Rs.5,000/- for coming 'in' and causing interference to LAUTERBRUNNEN (Rajesh Kumar M) on his inside passing the 500 Metres.

Jockey Darshan R.N, the rider of SOLO PRINCE reported that his mount was not striding out well till about 800 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

Surprise sample (Blood) was taken for analysis from b f ASHWA VEDHA.

Routine Sample was taken for analysis from the winner b g NEVER GIVE IN.

## 5<sup>th</sup> Race: 73. The Karnataka Sub-Area Cup - (About) 1200 metres. Horses rated 60 to 85 (9 Runners).

As Jockey S.J. Moulin could not arrive in time to fulfill his riding engagement (flight rescheduled). Permission was granted to trainer Mr. Vijay Singh to declare Jockey J. Chinoy to ride IMPERIAL GESTURE in place of the declared rider.

Jockey Angad, the rider of AUSPICIOUS QUEEN was fined Rs.3,000/- for using unserviceable equipment (Surcingle) which was changed prior to the horses leaving the paddock.

Jockey Rajesh Kumar M, the rider of INDIAN BLUES was reprimanded for riding an indifferent race.

It was reported after the race that IMPERIAL GESTURE (J. Chinoy) burst its blood vessels. Trainer Mr.Vijay Singh was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b m AMRELI.

## 6<sup>th</sup> Race: 74. The Mahalakshmi Plate - (About) 1600 metres. Horses rated 00 to 25 (9 Runners).

Jockey Rayan Ahmed R., the rider of SOUTHERN WARRIOR was reprimanded for shifting 'in' and inconveniencing MY VISIONARY (V.R.Jagadeesh) on his inside approaching 900 Metres.

SOUTHERN WARRIOR (Rayan Ahmed R.) ran detached from the 500 Metres. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr.Faraz Arshad was informed to take appropriate corrective measures before accepting with it again.

Jockey A. Sandesh, the rider of QUICK WITTED was fined Rs.2,000/- for shfiting out and taking out SUNLIT PATH (Salman Khan), which in turn passed it onto BURNING ARROW (Kiran Rai P) on his outside approaching 300 Metres.

Jockey Salman Khan, the rider of SUNLIT PATH was reprimanded for shifting out and inconveniencing BURNING ARROW (Kiran Rai P) on his outside approaching 200 Metres.

Jockey P. Sai Kumar, the rider of SAND CASTLES was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

SUNLIT PATH (Salman Khan) was subjected to veterinary examination but no abnormality was reported.

Jockey Koshi Kumar, the rider of TIGERKING was fined Rs.2,000/- for exulting before passing the winning post.

An enquiry is being held into the relative improved performance and reversal of form of TIGERKING (Koshi Kumar) in the above race as compared to its previous run in Race No. 14 i.e., The Manitou Stakes - Div.II, (about) 1200 Metres, Horses rated 20 to 45, run on Sunday, 14th July, 2024 wherein it ran unplaced.

Routine urine and blood samples were taken for analysis from the winner ch g TIGERKING.

## 7<sup>th</sup> Race: 75. The Flirting Vision Plate - (About) 1200 metres. Horses rated 20 to 45, 5 years old and over (10 Runners).

RIGHTLY NOBLE (L. Alex Rozario) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.V. Lokanath was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Vivek.G, the rider of STAR ADMIRAL reported that his saddle shifted back soon after the start. After due examination of the equipment, Trainer Mr.Aravind G. was fined Rs.3,000/- for faulty saddling of his charge.

Jockey Salman Khan, the rider of DAWN RISING reported that his mount was inclined to run out between the 900 Metres and 700 Metres.

DAWN RISING (Salman Khan) ran detached from the 300 Metres. Trainer Mr. Faraz Arshad was informed to ensure better performance of his charge in future.

Jockey V.R. Jagadeesh, the rider of MEGA SUCCESS was fined Rs.1,000/- for shifting out and causing interference to ANCIENT HISTORY (Akshay Kumar) on his outside passing the 250 Metres.

RIGHTLY NOBLE (L. Alex Rozario) ran detached from the field and stopped galloping in the final 100 Metres. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. V. Lokanath was informed to ensure better performance of his charge in future.

Jockey V.R. Jagadeesh, the rider of MEGA SUCCESS was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

Routine Sample was taken for analysis from the winner b g STAR ADMIRAL.

#### **ADDITIONAL REPORT**

**BANGALORE SUMMER MEETING 2024** 

SECOND DAY, SUNDAY, 14<sup>th</sup> JULY 2024

### Race: 13. The Sweet Memories Stakes - Div. I - (About) 1200 metres. Horses rated 20 to 45, 5 years old and over.

The Stipendiary Stewards reported Jockey K. Sai Kiran to the Stewards for Contravention of Rule No. 159 (a) & (b) of the B.T.C Rules of Racing on his mount OXYTOCIN.

The Stewards held an enquiry on 14<sup>th</sup> August, 2024 and examined Trainer Mr. Warren Singh and Mr. P.S. Chouhan (Spokesperson) for Jockey K. Sai Kiran and Jockey K. Sai Kiran himself.

#### The Stewards considered the following:

> The Minutes of the Preliminary enquiry conducted by the enquiry officers;

- Charge sheet issued to Jockey K. Sai Kiran and Trainer Mr. Warren Singh by the Stipendiary Steward;
- The written submissions made by Jockey K. Sai Kiran to the Stewards vide his letter dated 2/8/2024;
- The Submissions made by Trainer Mr. Warren Singh, Spokesperson Mr P.S. Chouhan for Jockey K. Sai Kiran and Jockey K. Sai Kiran himself during the enquiry;
- Stewards viewed various angles of the race with specific reference to the riding by Jockey K. Sai Kiran in the above race;
- The Stewards noted that Jockey K. Sai Kiran had not pleaded guilty of alleged breach of Contravening Rule No. 159 (a) & (b) of the BTC Rules of Racing as charged by the Stipendiary Steward.

After deliberations, they decided to change the charges levied against Jockey K. Sai kiran by the Stipendiary Steward for 159 (a) & (b) to 159 (b) of the B.T.C Rules of Racing and thereafter decided as under:-

- a) To withdraw the Jockey's Licence granted to Jockey K. Sai Kiran and treat him as a disqualified person with effect from 1/9/2024 to 28/2/2025 (Both days inclusive) for Contravening Rule No. 159 (b) of the BTC Rules of Racing on his mount OXYTOCIN (He is not permitted to ride work).
- b) Trainer Mr. Warren Singh was fined a sum of **Rs.50,000/-** for Unsatisfactory explanations tendered by him during the enquiry and Unsatisfactory running of his charge OXYTOCIN in the above race.
- c) They were informed of their right to appeal to the Board of Appeal.
