RACING INCIDENTS

(94 - 105)

GOING : Soft

PENETROMETER READING: 4.6 Cms.

RAILING POSITION: Railing fixed at its original position.

1st Race: 94. The Champion Trainer Cup - Div. II - (About) 1200 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (9 Runners).

LOVEISGOD (J. Chinoy) after jumping out swerved towards the left, did not raise a fluent gallop, kept bucking & dislodged its rider and ran rider less thereafter. In view of its behaviour, Trainer Mr. Warren Singh was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

AQUASTIC (Suraj Narredu) jumped awkwardly inwards and inconvenienced BOWEN (Rayan Ahmed R.) at the start.

Jockey Arvind Kumar. N, the rider of LADYLION was fined Rs.2,000/- for coming 'in' and causing interference to LIVE THE DREAM (Akshay Kumar) on his inside approaching 1100 Metres.

Jockey Akshay Kumar, the rider of LIVE THE DREAM was fined Rs.1,000/- for coming 'in' and bumping LADYLION (Arvind Kumar. N) on his inside in the final 100 Metres.

ROCKING GIRL (S.K.Paswan) ran detached from the field. Trainer Mr. S. Dominic was informed to ensure better performance of his charge in future.

It was reported after the race that LIVE THE DREAM (Akshay Kumar) pulled up lame on left fore. Trainer Mr. Prasanna Kumar was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

LOVEISGOD (J. Chinoy) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f AQUASTIC.

2nd Race: 95. The Leading Stud Cup - Div. II - (About) 1400 metres. Horses rated 20 to 45, 5 years old and over (Whips not allowed) (9 Runners).

PERIDOT (B. R. Kumar) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Irfan Ghatala was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Vinod Shinde, the rider of BENZEMA reported that his mount was hanging out after entering the straight. The horse was subjected to veterinary examination. On examination, it was found to have bit sore on both oral commissure. Trainer Mr. Faraz Arshad was informed to take remedial measures before accepting with it again.

Routine Sample was taken for analysis from the winner b m PERIDOT.

3rd Race: 96. The Sayonara Trophy - (About) 1200 metres. Horses rated 00 to 25 (14 Runners).

FLYING BRAVE (Mohammed Aliyar) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Pradeep Annaiah was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

PRINCESS JASMINE (Faizan Khan) jumped awkwardly outwards.

Jockey S.J. Moulin, the rider of SPRINGSTEEN was fined Rs.1,000/- for shifting out and taking out PRINCESS JASMINE (Faizan Khan) on his outside passing the 900 Metres.

Jockey S.J. Moulin, the rider of SPRINGSTEEN was reprimanded for shifting out and inconveniencing PRINCESS JASMINE (Faizan Khan) on his outside passing the 200 Metres.[]

It was reported after the race that BALTIMORE (Inayat) burst its blood vessels. Trainer Mr. Azhar Ali was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b f ESTEFANIA.

4th Race: 97. The Youngsters Trophy - (About) 1400 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (9 Runners).

DR ASH (Salman Khan) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Irfan Ghatala was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

MESCALITO (Shreyas Singh S) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.S.S. Attaollahi was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

COMPLETE PACKAGE (Antony Raj S.) took a fly jump.

Jockey D. Patel, the rider of NOBLE CAUSE was fined Rs.1,000/- for shifting out and causing interference to FOREVER ROYAL (A.Ramu) on his outside passing the 1100 Metres.

Jockey Shreyas Singh S, the rider of MESCALITO had to ride his mount in check between the 900 Metres to 700 Metres.

Jockey D. Patel, the rider of NOBLE CAUSE was fined Rs.2,000/- for allowing his mount to shift out and caused interference to ASSIMILATE (S.J. Moulin) on his outside approaching 300 Metres.

Jockey D. Patel, the rider of NOBLE CAUSE was fined Rs.2,000/- for shifting out and causing interference to ASSIMILATE (S.J. Moulin) on his outside in the final 200 Metres.

Jockey D. Patel, the rider of NOBLE CAUSE reported that his mount was hanging out in the final 200 Metres. The horse was subjected to veterinary examination but no abnormality was reported. Trainer Mr. S. Dominic was informed to take appropriate corrective measures before accepting with it again.

ASSIMILATE (S.J. Moulin) sustained abrasion on both sides of barrel.

Routine Sample was taken for analysis from the winner b c BESTIDENTIFICATION.

5th Race: 98. The Champion Jockey Cup - Div. I - (About) 1200 metres. Horses rated 20 to 45 (12 Runners).

SPIRIT DANCER (Rayan Ahmed R.) jumped awkwardly outwards and inconvenienced LA MCQUEEN (Antony Raj S.) soon after the start.

Jockey Vinod Shinde, the rider of QUEEN OF KINGS was reprimanded for shifting out and bumping RED FALCON (B. R. Kumar) on his outside soon after the start.

Jockey Akshay Kumar, the rider of MONTERIO reported that his mount was hanging out after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Prasanna Kumar was informed to take appropriate corrective measures before accepting with it again.

Jockey Hemant Chandragiri, the rider of RIVER OF GOLD was fined Rs.5,000/- for not making sufficient effort on his mount during the race.

Jockey K. Sai Kiran, the rider of INSTRUCTOR was fined Rs.25,000/- for coming 'in' and causing severe interference to the horses on his inside viz; GISMO (S. Hussain) and SPIRIT DANCER (Rayan Ahmed R.), whereby LA MCQUEEN (Antony Raj S.) who was travelling directly behind also had to be checked by its rider passing the 1000 Metres. Thus, riding in a careless manner, thereby Contravening Rule No. 161 (i) of the B.T.C Rules of Racing.

INSTRUCTOR (K. Sai Kiran) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b c INSTRUCTOR.

6th Race: 99. The Leading Stud Cup - Div. I - (About) 1400 metres. Horses rated 20 to 45, 5 years old and over (Whips not allowed) (9 Runners).

GLOW IN THE DARK (A.Ramu) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Warren Singh was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Routine Sample was taken for analysis from the winner dk b g ANCIENT HISTORY.

7th Race: 100. The Champion Trainer Cup - Div. I - (About) 1200 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (9 Runners).

Jockey B. R. Kumar replaced the indisposed Jockey J. Chinoy on CARAT LOVE.

WIN WIN (S.J. Moulin) after jumping out slightly swerved towards the left and bumped CARAT LOVE (B.R. Kumar).

Jockey Shreyas Singh S, the rider of MAYNE MAGIC reported that his mount was inclined to run out between the 1000 Metres to 900 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey Vivek.G, the rider of JULLY reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr.Azhar Ali was informed to take appropriate corrective measures before accepting with it again.

Jockey Shreyas Singh S, the rider of MAYNE MAGIC reported that his whip got entangled in the reins momentarily between the 225 Metres and 200 Metres.

WIN WIN (S.J. Moulin) was subjected to veterinary examination. On examination it was found to have sharp molars. Hence, Trainer Mr. James Mckeown was fined Rs.3,000/- for his negligence.

Routine Sample was taken for analysis from the winner b c DHANTERAS.

8th Race: 101. The Leading Owner Cup - (About) 1100 metres. Horses rated 40 to 65, 5 years old and over (10 Runners).

STAR ADMIRAL (Koshi Kumar) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Aravind G. was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Shreyas Singh S, the rider of REMONTOIR was fined Rs.2,000/- for coming 'in' and causing interference to the horses viz; KNOTTY PATTON (V.R.Jagadeesh) and THE PERFECT CHOICE (A.R.Pradeep) on his inside passing the 1000 Metres.

Jockey K. Sai Kiran, the rider of BORN DANCER was reprimanded for dropping hands before passing the winning post.

It was reported after the race that REMONTOIR (Shreyas Singh S) burst its blood vessels. Trainer Mr. Imtiaz Khan was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g GOLDEN TIME.

9th Race: 102. The Bangalore St.Leger(Grade II) - (About) 2800 metres. Indian Horses 4 years old and over (Foaled in 2020 or before). (4 Runners).

At the instructions of Trainer Mr. P. Shroff, Jockey Vivek.G, the rider of SUPERNATURAL jumped out slowly from the starting gates.

Jockey Akshay Kumar, the rider of DYF was fined Rs.1,000/- for shifting 'in' and causing interference to TREVALIUS (S. Saqlain) on his inside passing the 2600 Metres.

Jockey Vivek.G, the rider of SUPERNATURAL was fined Rs.1,000/- for shifting 'in' and causing interference to DYF (Akshay Kumar) on his inside approaching 1400 Metres.

Compulsory urine and blood samples were taken for analysis from the following I,II & III placed horses viz:

10th Race: 103. The Civil Service Cup - (About) 1400 metres. Horses rated 60 to 85 (8 Runners).

Jockey Darshan R. replaced the indisposed Jockey J. Chinoy on SHUBANKAR.

PEYO (Hemant Chandragiri) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. S. Narredu was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

PEYO (Hemant Chandragiri) ran detached from the field. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. S. Narredu was informed to ensure better performance of his charge in future.

Routine Sample was taken for analysis from the winner b c PRANA.

11st Race: 104. The Raja of Bobbili Memorial Trophy - (About) 1400 metres. Horses rated 40 to 65 (12 Runners).

Jockey Suraj Narredu, the rider of BOURBONAIRE reported that his mount was lugging 'in' under pressure during the final stages of the race.

Routine Sample was taken for analysis from the winner b g BOURBONAIRE.

12nd Race: 105. The Champion Jockey Cup - Div. II - (About) 1200 metres. Horses rated 20 to 45 (11 Runners).

PURSUIT OF WEALTH (A.R.Pradeep) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Warren Singh was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey S. Hussain, the rider of SCHAFENBERG reported that he lost his left stirrup soon after jumping out of the starting gates and had to ride without the aid of stirrup throughout the race.

It was reported after the race that DEBONAIR (Afsar) pulled up lame on right fore. Trainer Mr. K. Pradeep Annaiah (deputizing on behalf of Trainer Mr. Faraz Arshad) was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g HIGH SPEED DIVE.

Permission was granted to trainers M/s. Pradeep Annaiah, James Mckeown and S. Narredu to deputize on behalf of trainers M/s. Faraz Arshad, Arjun Mangalorkar and Rajesh Narredu who were unable to attend the races.
