**RACING INCIDENTS**  
**(1-6)**

**GOING : Soft**

**PENETROMETER READING : 5.1 Cms.**

**RAILING POSITION: Railing fixed at an average width of 7.0 Meters from 1600 Meters to the winning post from its original position.**

**1<sup>st</sup> Race: 1. The Ich Dien Plate - (About) 1200 metres. Horses rated 00 to 25 (10 Runners).**

Permission was granted to Trainer Mr.Vishesh M.P. to withdraw POSTHASTE (Ram Nandan Manjhi) on veterinary grounds as it was found to have left capped elbow. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

MY SOLITAIRE (Chethan Kalay S.) after jumping out, swerved towards the left, did not raise a fluent gallop and did not take any practical part in the race. In view of its behaviour, Trainer Mr.S.Shoban Babu was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Rayan Ahmed R., the rider of MEHRA was reprimanded for shifting 'in' and bumping ESTEFANIA (Aleemuddin) on his inside passing the 100 Metres.

Jockey Ramswarup, the rider of MEGHANN reported that his mount was hanging out after entering the straight. The horse was subjected to veterinary examination. On examination, it was found to have abrasion on right hock.

Jockey Afsar, the rider of STAR SYMPHONY was reprimanded for riding an indifferent race.

ESTEFANIA (Aleemuddin) sustained clip injury on right hind cannon.

EMERALDO (G. Praveen) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f MEHRA.

**2<sup>nd</sup> Race: 2. The Kunigal Stud Plate - (About) 1400 metres. Horses rated 40 to 65, 5 years old and over (8 Runners).**

MYSTICAL AIR (P. Trevor) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.S.S. Attaollahi was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey A. Prakash, the rider of ISABELLE reported that he could not get a clear view between the 800 Metres to 600 Metres due to the kick back of the earth.

PRIME ABBESS (Neeraj Rawal) was subjected to veterinary examination. On examination, it was found to be lame on left hind. Trainer Mr. S. Padmanabhan was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

MYSTICAL AIR (P. Trevor) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g ALL ATTRACTION.

**3<sup>rd</sup> Race: 3. The International Labour Day Trophy - (About) 1200 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (12 Runners).**

MUTUAL TRUST (Shreyas Singh S) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.S.S. Attaollahi was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

DREAMER (N. S. Parmar) jumped awkwardly inwards onto SEA GLORY (A.A. Vikrant) soon after the start.

Jockey A.A. Vikrant, the rider of SEA GLORY was fined Rs.2,000/- for shifting 'in' and caused interference to SILVER QUEST (P. Mani) on his inside at the start.

Jockey P. Mani, the rider of SILVER QUEST was fined Rs.3,000/- for shifting 'in' and causing interference to the horses on his inside viz; ELYSIUM (Akshay Kumar), BEST OF US (R. Vaibhav) and MUTUAL TRUST (Shreyas Singh S) approaching 1100 Metres.

Jockey Rayan Ahmed R., the rider of VIBRANT QUEEN was reprimanded for shifting out and inconveniencing VICTORIA CROSS (Neeraj Rawal) on his outside approaching 800 Metres.

Jockey Akshay Kumar, the rider of ELYSIUM reported that his mount was running green throughout the race.

Jockey Rayan Ahmed R., the rider of VIBRANT QUEEN reported that his mount was hanging out after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Pradeep Annaiah was informed to take appropriate corrective measures before accepting with it again.

Routine Sample was taken for analysis from the winner dk b f ZIVA.

**4<sup>th</sup> Race: 4. The B.T.C. Charitable Trust Trophy - (About) 1200 metres. Horses rated 80 and above (8 Runners).**

Jockey Aleemuddin, the rider of CZAR was reprimanded for shifting out and inconveniencing VIVALDO (Imran Chisty), which in turn passed it onto ALDGATE (Antony Raj S.) on his outside at the start.

Jockey P. Sai Kumar, the rider of CROWN DRIVE was reprimanded for shifting out and inconveniencing METZINGER (S. Saqlain) on his outside passing the 800 Metres.

It was observed that METZINGER (S. Saqlain) ran detached from the field in the final 200 Metres.

Routine Sample was taken for analysis from the winner b g IMPERIAL BLUE.

**5<sup>th</sup> Race: 5. The Welcome Plate - (About) 1400 metres. Horses rated 20 to 45 (11 Runners).**

Permission was granted to Trainer Mr.Aravind G. to withdraw JOON (Vishal N Bunde) on veterinary grounds as it was found to have abscess on right upper lip. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Darshan N, the declared rider of MONTERIO was fined Rs.5,000/- for not drawing the declared weight on the scales. Subsequently permission was granted to Trainer Mr. Pradeep Annaiah to declare Jockey Ramswarup to ride MONTERIO in place of the declared rider.

ADELANTO (Koshi Kumar) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. G. Y. Rajesh Babu was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

MONTERIO (Ramswarup) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Pradeep Annaiah was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Koshi Kumar, the rider of ADELANTO was fined Rs.1,000/- for shifting 'in' and causing interference to WESTLAKE (C.Umesh) on his inside passing the 1000 Metres.

Jockey K. Sai Kiran, the rider of DIVINE PROTECTOR was reprimanded for travelling wide rounding the final bend from 700 Metres to 500 Metres for no apparent reason.

Jockey Ram Nandan Manjhi, the rider of DEFENCE COUNSEL was reprimanded for travelling wide rounding the final bend from 700 Metres to 500 Metres for no apparent reason.

Jockey V.R.Jagadeesh, the rider of LG'S STAR was reprimanded for travelling wide rounding the final bend for no apparent reason.

Jockey Vishwa. V, the rider of GISMO was fined Rs.2,000/- for his negligence in weighing "in" 800 gms excess in relation to weighing out.

DIVINE PROTECTOR (K. Sai Kiran) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f SEE THE LIGHT.

**6<sup>th</sup> Race: 6. The Racing Patrons Plate - (About) 1200 metres. Horses rated 40 to 65 (8 Runners).**

Trainer Mr. James Mckeown was fined Rs.10,000/- for failing to obtain a fitness certificate from the Club's Veterinary Officer before accepting his charge DENSETSU to run when he was specifically informed to take a fitness certificate from the Club's Veterinary Officer before accepting his charge to run in the above race.

Trainer Mr. Vishesh M.P. was fined Rs.10,000/- for failing to obtain a fitness certificate from the Club's Veterinary Officer before accepting his charge CARAT LOVE to run when he was specifically informed to take a fitness certificate from the Club's Veterinary Officer before accepting his charge to run in the above race.

Jockey A. Sandesh, the rider of ELUSIVE ART was fined Rs.3,000/- for shifting 'in' and causing interference to CHOTIPARI (Ramswarup) on his inside passing the 350 Metres.

Jockey Ritesh Gochhi, the rider of VAL D'ARAN was reprimanded for shifting 'in' and inconveniencing IL VOLO (Salman Khan) on his inside passing the 300 Metres.

Jockey Ram Nandan Manjhi, the rider of SMILE OF BEAUTY was reprimanded for dropping hands before passing the winning post.

Routine Sample was taken for analysis from the winner b f DIVINE ART.
