RACING INCIDENTS
(14-19)

GOING : Good

PENETROMETER READING : 4.2 Cms.

RAILING POSITION: Railing fixed at an average width of 5.0 Meters from 1600 Meters to the winning post from its original position.

1st Race: 14. The Royal Tern Plate - (About) 1200 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (5 Runners).

Trainer Mr. Rajesh Narredu was fined Rs.25,000/- by the Stewards for his negligence in discharge of his duties as a trainer for having accepted his charge MIDNIGHT BLUE (Suraj Narredu) to run in the above race. In that he failed to adhere to withdrawal period of the Medication Rules (**"Multi vitamins injection and intravenous Amino Acid (Amino bottles) or Lipids (Lipid bottles) can be given 72 hrs before Race Day with cut-off time being 12 noon"**), thereby contravening Rule No. 114 (b) (i) of the B.T.C Rules of Racing.

Trainer Mr. Rajesh Narredu was fined Rs.25,000/- by the Stewards for his negligence in discharge of his duties as a trainer for having accepted his charge ASSURANCES (A.A. Vikrant) to run in the above race. In that he failed to adhere to withdrawal period of the Medication Rules (**"Multi vitamins injection and intravenous Amino Acid (Amino bottles) or Lipids (Lipid bottles) can be given 72 hrs before Race Day with cut-off time being 12 noon"**), thereby contravening Rule No. 114 (b) (i) of the B.T.C Rules of Racing.

MAHLER (P. Trevor) bolted on the way to the saddling yard and ran riderless on the sand track for more than 600 Metres. On immediate examination by the Club's Veterinary Officer, it was found to have sustained injury on right fore both bulbs of heel. Under the circumstances, it was permitted to be withdrawn on veterinary grounds. Trainer Mr. S.S. Attaollahi was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

VORFREUDE (K.G. Likith Appu) was examined at the saddling enclosure and was found to be lame on right fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds. Trainer Mr. S. Padmanabhan was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was observed that HYPERDRIVE (R. Vaibhav) raced fiercely between the 1000 Metres till about 700 Metres.

Jockey Akshay Kumar, the rider of DEVATE reported that his mount was making a roaring noise and stopped galloping in the final 200 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f VEGATHA.

2nd Race: 15. The Supervite Plate - Div. II - (About) 1400 metres. Horses rated 20 to 45, 4 years old and over (8 Runners).

Trainer Mr. S. Narredu was fined Rs.25,000/- by the Stewards for his negligence in discharge of his duties as a trainer for having accepted his charge STENTORIAN (Suraj Narredu) to run in the above race. In that he failed to adhere to withdrawal period of the Medication Rules (**"Multi vitamins injection and intravenous Amino Acid (Amino bottles) or Lipids (Lipid bottles) can be given 72 hrs before Race Day with cut-off time being 12 noon"**), thereby contravening Rule No. 114 (b) (i) of the B.T.C Rules of Racing.

LEX LUTHOR (A. Prakash) was fractious while being loaded into the starting gates in the process the bridle came off. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

SOUTHERN DYNASTY (Koshi Kumar) took a fly jump and lost few lengths at the start. In view of its behaviour, Trainer Mr. Aravind G. was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

It was observed that the goggles and cap of Jockey Vivek.G, the rider of KNOTTY SCOTTY had come off while jumping out from the starting gates. As the incident was accidental no action was taken beyond noting the incident.

Jockey Vivek.G, the rider of KNOTTY SCOTTY was fined Rs.3,000/- for shifting 'in' and causing interference to the horses on his inside viz; WINFIELD (Antony Raj S.), STAR OF INDIA (Neeraj Rawal) and ART OF ROMANCE (K. Sai Kiran) at the start.

Jockey Ram Nandan Manjhi, the rider of NOBLE CAUSE was fined Rs.3,000/- for travelling wide from the start till about 500 Metres for no apparent reason.

It was reported after the race that WINFIELD (Antony Raj S.) was observed to be bleeding from right nostril in the paddock, the same was confirmed upon endoscopy. Trainer Mr. Arjun Mangalorkar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner dk b g KNOTTY SCOTTY.

3rd Race: 16. The K.N. Guruswamy Memorial Trophy - (About) 1400 metres. Horses rated 40 to 65 (9 Runners).

Trainer Mr. Rajesh Narredu was fined Rs.25,000/- by the Stewards for his negligence in discharge of his duties as a trainer for having accepted his charge EXCELLENT LASS (Yash Narredu) to run in the above race. In that he failed to adhere to withdrawal period of the Medication Rules (**"Multi vitamins injection and intravenous Amino Acid (Amino bottles) or Lipids (Lipid bottles) can be given 72 hrs before Race Day with cut-off time being 12 noon"**), thereby contravening Rule No. 114 (b) (i) of the B.T.C Rules of Racing.

Jockey Vishwa. V, the declared rider of EXTRAORDINARY was fined Rs.5,000/- for not drawing the declared weight on the scales. Subsequently, permission was granted to Trainer Mr. Joseph B. Awale to withdraw

EXTRAORDINARY from the above race as there was no substitute suitable rider available.

SASSY (Tauseef Ahmed) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.G. Y. Rajesh Babu was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least two Mock Races.

MISS SMILEY ANGEL (Abhay Singh) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.G. Shashikanth was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Abhay Singh, the rider of MISS SMILEY ANGEL was fined Rs.3,000/- for not improving his position from 1200 Metres till about 600 Metres for no apparent reason.

Jockey G. Praveen, the rider of WELLINGTON was reprimanded for shifting 'in' and inconveniencing the horses on his inside viz; FINLEY (Ramswarup) and KAVYA (N. S. Parmar) approaching 800 Metres.

Jockey G. Praveen, the rider of WELLINGTON was reprimanded for travelling wide from 700 Metres till about 500 Metres for no apparent reason.

MISS SMILEY ANGEL (Abhay Singh) sustained superficial injury on right hind fetlock.

Routine Sample was taken for analysis from the winner b m CROSSWATER.

4th Race: 17. The Col. Desraj Urs Trophy - (About) 1200 metres. Horses rated 60 to 85 (11 Runners).

Jockey Darshan.N, the declared rider on BHARAT was fined Rs.5,000/- for not drawing the declared weight on the scales. Subsequently permission was granted to Trainer Mr. Prasanna Kumar to declare Jockey Aleemuddin to ride BHARAT in place of the declared rider.

It was observed that VIJAYA FALCON (Vishal N Bunde) accidentally struck the front runner REGAL REALITY (Akshay Kumar), Jockey Vishal N Bunde was totally unbalanced and was dislodged from his mount approaching 850 Metres. As the incident was accidental no action was taken beyond noting the incident. On immediate examination by the Club's Veterinary Officer, it was found that VIJAYA FALCON (Vishal N Bunde) pulled up lame on left fore. Subsequently, it was euthanized at 06:05 p.m. on 24/05/2025 as the gelding was suffering from comminuted fracture of left carpal bones.

Jockey Ramswarup, the rider of CREDENCE reported that his saddle shifted back approaching 800 Metres. After due examination of the equipment, Trainer Mr. Shazaan Shah was fined Rs.5,000/- for faulty saddling of his charge.

REGAL REALITY (Akshay Kumar) sustained superficial injury on muzzle.

STELLANTIS (Vivek.G) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f CREDENCE.

5th Race: 11. The War Hammer Million - (About) 1400 metres. 3-year-old horses(foaled in 2022). (10 Runners).

Trainer Mr. S. Narredu was fined Rs.25,000/- by the Stewards for his negligence in discharge of his duties as a trainer for having accepted his charge GLORIOUSNESS (Suraj Narredu) to run in the above race. In that he

failed to adhere to withdrawal period of the Medication Rules (**"Multi vitamins injection and intravenous Amino Acid (Amino bottles) or Lipids (Lipid bottles) can be given 72 hrs before Race Day with cut-off time being 12 noon"**), thereby contravening Rule No. 114 (b) (i) of the B.T.C Rules of Racing.

MOUNTAIN JEWEL (MustakimAlam) after jumping out swerved towards the left and did not raise a fluent gallop for the first 100 Metres. In view of its behaviour, Trainer Mr. Prasanna Kumar was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Antony Raj S., the rider of VIBRANT BLISS reported that his mount was shying from the running rails from the start till about 400 Metres.

Jockey P. Trevor, the rider of ICE OF FIRE reported that he could not get a clear run between 400 Metres and 200 Metres due to a closely packed field.

It was observed that POLE STAR (Vivek.G) did not get a clear run between 250 Metres and 200 Metres due to closely packed field.

MORANO (A. Sandesh) ran detached from the field. Trainer Mr. Aashay Doctor was informed to ensure better performance of his charge in future.

Routine Sample was taken for analysis from the winner b c CIRCLE OF DREAMS.

6th Race: 18. The Usha Stud Plate - (About) 1200 metres. Horses rated 40 to 65, 5 years old and over (10 Runners).

Trainer Mr. Rajesh Narredu was fined Rs.25,000/- by the Stewards for his negligence in discharge of his duties as a trainer for having accepted his charge SUPER SAPPHIRE (Shezad Khan) to run in the above race. In that he failed to adhere to withdrawal period of the Medication Rules (**"Multi vitamins injection and intravenous Amino Acid (Amino bottles) or Lipids (Lipid bottles) can be given 72 hrs before Race Day with cut-off time being 12 noon"**), thereby contravening Rule No. 114 (b) (i) of the B.T.C Rules of Racing.

TREASURE CHEST (Arjun) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. S. Dominic was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Imran Chisty, the rider of GIMMLER was reprimanded for shifting out and inconveniencing DUFY (R. Vaibhav) on his outside passing the 800 Metres.

Routine Sample was taken for analysis from the winner b g KNOTTY PATTON.

7th Race: 19. The Supervite Plate - Div. I - (About) 1400 metres. Horses rated 20 to 45, 4 years old and over (8 Runners).

Trainer Mr. S. Narredu was fined Rs.25,000/- by the Stewards for his negligence in discharge of his duties as a trainer for having accepted his charge PRICELESS PRINCE (A.A. Vikrant) to run in the above race. In that he failed to adhere to withdrawal period of the Medication Rules (**"Multi vitamins injection and intravenous Amino Acid (Amino bottles) or Lipids (Lipid bottles) can be given 72 hrs before Race Day with cut-**

off time being 12 noon”), thereby contravening Rule No. 114 (b) (i) of the B.T.C Rules of Racing.

Permission was granted to Trainer Mr.Irfan Ghatala to withdraw FELISA (Pavan) on veterinary grounds as it was found to be lame on left fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey R. Vaibhav, the rider of LOCKHEED reported that his mount was hanging out from 800 Metres despite his best efforts, thereby he hampered the running of STRAVINSKY (Angad) till about 200 Metres. In view of its repeated behaviour, Trainer Mr. G. Y. Rajesh Babu was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least **two Mock Races**. However, LOCKHEED (R. Vaibhav) was subjected to veterinary examination but no abnormality was reported.

Jockey A.R.Pradeep, the rider of THE GOLDEN DREAM was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

HABIBTI (Antony Raj S.) was subjected to veterinary examination but no abnormality was reported.

THE GOLDEN DREAM (A.R.Pradeep) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f SCARLETTE LADY.
