**RACING INCIDENTS**  
**(28-34)**

**GOING : Soft**

**PENETROMETER READING : 4.6 Cms.**

**RAILING POSITION: Railing fixed at an average width of 2.5 Meters from 1600 Meters to the winning post from its original position.**

**1<sup>st</sup> Race: 28. The Classical Act Plate - (About) 1400 metres. Horses rated 00 to 25, 6 years old and over (8 Runners).**

EMBOSOM (V.R.Jagadeesh) took a fly jump.

RAFFLES (P. Trevor) was subjected to veterinary examination but no abnormality was reported.

SACRED CREATOR (Ramswarup) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g EL ALAMEIN.

**2<sup>nd</sup> Race: 29. The World No-Tobacco Day Plate - (About) 1400 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (11 Runners).**

As Jockey Akshay Kumar was certified medically unfit to ride. Permission was granted to trainer Mr.Darius R. Byramji to declare Jockey Vivek.G to ride ADORNMENT in place of the declared rider.

ASSURANCES (R. Vaibhav) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Rajesh Narredu was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

ADORNMENT (Vivek.G) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Darius R. Byramji was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

JURACAN (P. Trevor) jumped awkwardly outwards and inconvenienced SUNSHINE (S. Saqlain) at the start.

Jockey Vishal N Bunde, the rider of GALWAY GIRL was reprimanded for shifting out and inconveniencing SENECA (A. Sandesh) on his outside rounding the final bend.

Jockey P. Trevor, the rider of JURACAN reported that his mount stopped galloping in the final 200 Metres. The horse was subjected to veterinary examination. On examination, it was found to have burst its blood vessels (on endoscopy Grade - IV). Trainer Mr. P. S. Chouhan was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner ch f SUNSHINE.

**3<sup>rd</sup> Race: 30. The Romantic Dance Plate - Div. II - (About) 1400 metres. Horses rated 20 to 45 (9 Runners).**

PURSUIT OF WEALTH (K. Sai Kiran) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. M. Rajendra Singh was informed not to accept

with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

ADELANTO (R. Vaibhav) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. G. Y. Rajesh Babu was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

MARTHA (Rajesh Kumar M) ran detached from the field. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Narayana Gowda V. was informed to ensure better performance of his charge in future.

LEX LUTHOR (A. Prakash) sustained clip injury on left hind cannon.

VIBRANT QUEEN (Prashant P.Dhebe) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g AMAZING STRIDE.

**4<sup>th</sup> Race: 31. The Marilingaiah Memorial Trophy - (About) 1200 metres. Horses rated 40 to 65 (8 Runners).**

As Jockey Akshay Kumar was certified medically unfit to ride. Permission was granted to trainer Mr. S.S. Attaollahi to declare Jockey Suraj Narredu to ride AQUASTIC in place of the declared rider.

Trainer Mr. Neil Darashah was fined Rs.5,000/- for discrepancy in shoeing in respect of his charge KERRYGOLD (Vishal N Bunde).

Jockey Vishal N Bunde, the rider of KERRYGOLD was reprimanded for shifting 'in' and inconveniencing GRENOBLE (Hindu Singh) on his inside approaching 1100 Metres.

Jockey Vishal N Bunde, the rider of KERRYGOLD was severely reprimanded for dropping hands in the final 200 Metres.

KERRYGOLD (Vishal N Bunde) was subjected to veterinary examination. On examination, it was found to have bit injury on right oral commissure. Trainer Mr. Neil Darashah was informed to take remedial measures.

Routine Sample was taken for analysis from the winner ch g DIVINE STAR.

**5<sup>th</sup> Race: 32. The Dharmaprakasha L.S.Venkaji Rao Memorial Trophy - (About) 1400 metres. Horses rated 60 to 85 (12 Runners).**

EATON SQUARE (A.S.Peter) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. M. Narredu was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Vivek.G, the rider of ALL ATTRACTION reported that he could not get a clear run between the 400 Metres till about 300 Meters due to a closely packed field.

Jockey S. Saqlain, the rider of ARKADIAN was reprimanded for shifting out and inconveniencing METZINGER (Pavan) on his outside passing the 350 Metres.

ASAGIRI (Siddaraju.P) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner dk b g MAYNE MAGIC.

**6<sup>th</sup> Race: 33. The Chettinad Stud Plate - (About) 1600 metres. Horses rated 80 and above (6 Runners).**

As Jockey Akshay Kumar was certified medically unfit to ride. Permission was granted to trainer Mr.S.S. Attaollahi to declare Jockey P. Trevor to ride MESCALITO in place of the declared rider.

Trainer Mr. S. Narredu was fined Rs.1,000/- for failing to produce the declared colors at the scales in respect of his charge CASTEEL (Ramswarup). Subsequently, All Black emergency colors were permitted to be used.

MESCALITO (P. Trevor) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.S.S. Attaollahi was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Ramswarup, the rider of CASTEEL reported that his mount drifted out under pressure in the final 200 Metres.

Jockey Suraj Narredu, the rider of CHAMPIONS WAY reported that his mount drifted out under pressure in the final 200 Metres.

Jockey Neeraj Rawal, the rider of STAR OF NIGHT placed 3rd by the judge objected against Jockey Ramswarup, the rider of CASTEEL placed 1st for "at the 5 furlong the winner bumped me twice and well into the straight the winner alarmingly drifted out and has intimidated my horse for her run and made no efforts whatsoever to correct his mount and this has resulted me to finish near the sand track which has cost me the race". The Stewards held an enquiry immediately after the race and interviewed the Jockeys concerned. After deliberations, they decided to overrule the objection.

CASTEEL (Ramswarup) sustained superficial clip injury on left hind fetlock.

At the request of Trainer Mr. S. Narredu, endoscopy was performed on CHAMPIONS WAY (Suraj Narredu) and no abnormality was found.

Routine Sample was taken for analysis from the winner b c CASTEEL.

**7<sup>th</sup> Race: 34. The Romantic Dance Plate - Div. I - (About) 1400 metres. Horses rated 20 to 45 (9 Runners).**

Trainer Mr. Pradeep Annaiah was fined Rs.10,000/- for having accepted his charge MONTERIO (S.Hinayathulla) to run in the above race when he was specifically told to show it in a gate practice by the Stipendiary Stewards. Subsequently, permission was granted to him to withdraw MONTERIO.

HIGGS BOSON (Rajesh Kumar M) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Narayana Gowda V. was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Darshan R.N, the rider of STAR HONOUR reported that his mount drifting out under pressure in the final 100 Metres.

Jockey Asirvatham, the rider of ECLIPSE PULSE was severely reprimanded in the presence of Master Trainer Mr. Azhar Ali for the undesirable practice of easing his mount in the final 50 Metres.

(A)

An enquiry was held by the Stipendiary Stewards into the interference caused by Jockey Shezad Khan, the rider of STENTORIAN in the above race. In that for not exercising sufficient control on his mount, thereby shifting out and causing interference to HIGHLAND DREAM (Imran Chisty) and DOUBLE VISION (Salman Khan) on his outside passing the 200 Metres.

Jockey Shezad Khan was interviewed by the Stipendiary Steward. The Stipendiary Steward after considering the submissions made by Jockey Shezad Khan and after viewing the CCTV replay decided to charge Jockey Shezad Khan for Careless Riding.

The Stipendiary Steward thereafter suspended the Jockey’s Licence granted to Shezad Khan **on 14/06/2025** as he had pleaded guilty to the charge under Rule No. 161 (i) of the BTC Rules of Racing for Careless Riding on his mount STENTORIAN (he was permitted to ride work) and was informed of his right to appeal.

(B)

An enquiry was held by the Stipendiary Stewards into the interference caused by Jockey Darshan R.N, the rider of STAR HONOUR in the above race. In that he did not maintain a straight course from the start allowed his mount to shift ‘in’, and caused interference to CARAT LOVE (Dharshan Antony.B), which in turn passed it onto EXTRAORDINARY (R. Robert) and ECLIPSE PULSE (Asirvatham) on his inside, STENTORIAN (Shezad Khan) which was travelling directly behind had to be checked by its rider and shifted out bumping THE COMMANDER (Shivam) approaching 1200 Metres.

Jockey Darshan R.N, was interviewed by the Stipendiary Steward. The Stipendiary Steward after considering the submissions made by Jockey Darshan R.N, and after viewing the CCTV replay decided to charge Jockey Darshan R.N, for Careless Riding.

The Stipendiary Steward thereafter suspended the Jockey’s Licence granted to Darshan R.N, **on 14/06/2025** as he had pleaded guilty to the charge under Rule No. 161 (i) of the BTC Rules of Racing for Careless Riding on his mount STAR HONOUR (he was permitted to ride work) and was informed of his right to appeal.

Routine Sample was taken for analysis from the winner b g STENTORIAN.
