# BANGALORE SUMMER MEETING 2025 SIXTH DAY, SUNDAY, 01<sup>ST</sup> JUNE 2025 RACING INCIDENTS

(35 - 41)

**GOING:** Good

**PENETROMETER READING: 3.8 Cms.** 

RAILING POSITION: Railing fixed at an average width of 2.5 Meters from 1600 Meters to the winning post from its original position.

### 1<sup>st</sup> Race: 35. The Prince Khartoum Plate - (About) 1200 metres. Horses rated 20 to 45, 5 years old and over (9 Runners).

Jockey R. Robert, the rider of WAR TRAIL reported that he lost his right stirrup while jumping out of the starting gates, which he regained within a few strides.

IMMORTAL BEAUTY (M. Prabhakaran) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b m THE STRIKINGLY.

## 2<sup>nd</sup> Race: 36. The Endorsement Plate - (About) 1600 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (10 Runners).

As Jockey Akshay Kumar was certified medically unfit to ride. Permission was granted to trainer Mr.Prasanna Kumar to declare Jockey Antony Raj S to ride REFRESHMENT in place of the declared rider.

REFRESHMENT (Antony Raj S.) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Prasanna Kumar was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Yash Narredu, the rider of LIGHTNING BLITZ reported that he could not get a clear run at the start till about 300 Metres due to a closely packed field.

Jockey Yash Narredu, the rider of LIGHTNING BLITZ was reprimanded for shifting 'in' and inconveniencing EINAUDI (Shreyas Singh S) on his inside passing the 1400 Metres.

It was observed that Jockey P. Mani, the rider of MYSTIC CHARM accidentally struck the running rails and lost his whip passing 250 Metres.

Jockey Yash Narredu, the rider of LIGHTNING BLITZ reported that his mount was hanging out throughout the race. The horse was subjected to veterinary examination. On examination, it was found to have bit injury on left oral commissure. Trainer Mr. S. Narredu was informed to take remedial measures.

Routine Sample was taken for analysis from the winner b c ROSARIO.

## 3<sup>rd</sup> Race: 37. The Udhagamandalam Plate - (About) 1200 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (12 Runners).

Trainer Mr. Prasad Raju K.S.V. was fined Rs.1,000/- for failing to produce the declared colors at the scales in respect of his charge BEAST MASTER (P. Sai Kumar). Subsequently, All Black emergency colors were permitted to be used.

Trainer Mr.Neil Darashah was fined Rs.5,000/- for discrepancy in shoeing in respect of his charge ENOLA HOLMES (Vishal N Bunde).

BLUE STORM (Arvind Kumar. N) after jumping out swerved towards the left and lost few lengths at the start. In view of its behaviour, Trainer Mr. Irfan Ghatala was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

WAR ENYO (C.A.Brisson) jumped awkwardly outwards onto REPUBLICAN STAR (Koshi Kumar) soon after the start.

Jockey S. Saqlain, the rider of DONCASTER BELLE was fined Rs.2,000/- for shifting out and taking out ENOLA HOLMES (Vishal N Bunde), which in turn passed it onto FLAMING SWORD (Neeraj Rawal) on his outside passing the 450 Metres.

It was observed that Jockey Vivek.G, the rider of IMPERADOR had to stop riding in the final 200 Metres due to a closely packed field.

VICTORIA BELLA (Kuldeep Singh) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b c CHALLENGE ACCEPTED.

### 4<sup>th</sup> Race: 38. The S. G. Madhukar Memorial Trophy - (About) 1400 metres. Horses rated 40 to 65 (12 Runners).

PROKOFIEV (P. Trevor) jumped awkwardly inwards and inconvenienced AQUAMATIC (Asirvatham) on its inside soon after the start.

Jockey Vivek.G, the rider of MATISSE reported that his mount raced fiercely between the 1000 Metres and 700 Metres.

Jockey P. Trevor, the rider of PROKOFIEV reported that his mount was hanging 'in' throughout the race despite his best efforts to keep it on an even keel, in the process he shifted 'in' and tightened BISHOP (A. Prakash), subsequently he caused interference to LAGUNA SECA (Hindu Singh). As the incident was accidental no action was taken beyond noting the incident. PROKOFIEV (P. Trevor) was impounded for veterinary examination but no abnormality was reported.

Jockey A. Sandesh, the rider of KYOTO reported that his mount was making a roaring noise during the race. The horse was subjected to veterinary examination but no abnormality was reported.

Surprise sample was taken for analysis from b g PROKOFIEV.

Routine Sample was taken for analysis from the winner b f BISHOP.

### 5<sup>th</sup> Race: 39. The Benaka Developers Karnataka Juvenile Million (Grade III) - (About) 1400 metres. 3-year-old horses (foaled in 2022). (7 Runners).

BIG BAY (Yash Narredu) jumped awkwardly outwards onto SOVEREIGN KING (Antony Raj S.) soon after the start.

Jockey P. Trevor, the rider of FYNBOS reported that he could not get a clear run between the 250 Metres and 200 Metres due to a closely packed field.

An enquiry was held by the Stipendiary Stewards into the interference caused by Jockey Antony Raj S., the rider of SOVEREIGN KING in the above race. In that he shifted 'in' and bumped FYNBOS (P. Trevor) approaching 700 Metres, whereby FYNBOS (P. Trevor) was unbalanced and he further shifted 'in' & caused interference to BIG BAY (Yash Narredu), which in turn passed it onto SHINE (A. Sandesh) on his inside approaching 200 Metres.

Jockey Antony Raj S was interviewed by the Stipendiary Steward. The Stipendiary Steward after considering the submissions made by Jockey Antony Raj S and after viewing the CCTV replay decided to charge Jockey Antony Raj S for Careless Riding.

The Stipendiary Stewards thereafter suspended the Jockey's Licence granted to Antony Raj S **on 14/06/2025** as he had pleaded guilty to the charge under Rule No. 161 (i) of the BTC Rules of Racing for Careless Riding on his mount SOVEREIGN KING (he was permitted to ride work) and was informed of his right to appeal.

Jockey P. Trevor, the rider of FYNBOS had to check his mount to avoid striking the front runner ALFONSINE (Vivek.G) approaching 200 Metres.

Compulsory urine and blood samples were taken for analysis from the following I,II & III placed horses viz;

b c SOVEREIGN KING I
b f FYNBOS II
b g BIG BAY III

### 6<sup>th</sup> Race: 40. The Elite Force Plate - (About) 1300 metres. Horses rated 20 to 45 (12 Runners).

As Jockey Akshay Kumar was certified medically unfit to ride. Permission was granted to trainer Mr. Aravind G. to declare Jockey P. Trevor to ride ETERNAL GLORY in place of the declared rider.

Jockey Ikram Ahmed, the rider of THUTMOSE reported that his mount jumped awkwardly towards the left, whereby he was totally unbalanced and had to remove both his legs from stirrup irons, in the process he inconvenienced NAPOLEAN (Rajesh Kumar. M) and WINDCLEAVER (A.R. Pradeep approaching 1200 Metres, subsequently he lost control, he shifted out and took out PERFECT ATTITUDE (Antony Raj S.) approaching 900 Metres. On immediate examination of the saddle, it was found to be intact. As the incident was accidental no action was taken beyond noting the incident.

Jockey Hasib Alam, the rider of N R I JETPOWER reported that he accidently lost his whip passing the 100 Meters.

Jockey Neeraj Rawal, the rider of WOMAN AT WAR reported that his mount was running green after entering the straight.

It was reported after the race that NAPOLEAN (Rajesh Kumar M) returned bleeding from both nostrils. Trainer Mr. Narayana Gowda V. was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g SICYON.

### 7<sup>th</sup> Race: 41. The Aureole Time Plate - (About) 1200 metres. Horses rated 00 to 25 (11 Runners).

Permission was granted to Trainer Mr. Darius R. Byramji to withdraw MULTISIDED (A.R.Pradeep) on veterinary grounds as it was found to have inflamed hoof on right fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Darshan N, the rider of DARRION was fined Rs.3,000/- for coming 'in' and causing interference to the horses on his inside viz; CHIRAAG (Afsar) and SATIN LASS (Ram Nandan Manjhi), which in turn passed it onto SUNLIT PATH (Mohammed Aliyar) approaching 1100 Metres.

Jockey Darshan N, the rider of DARRION was reprimanded for shifting out and inconveniencing SATIN LASS (Ram Nandan Manjhi) and N R I GOLD (S.Hinayathulla) on his outside passing the 700 Metres.

Jockey K. Sai Kiran, the rider of WAKIZASHI reported that his mount was not striding out well during the race. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey Ram Nandan Manjhi, the rider of SATIN LASS was severely reprimanded for travelling wide rounding the final bend for no apparent reason.

Jockey Afsar, the rider of CHIRAAG was fined Rs.2,000/- for weighing 'in' excess 800 grams in relation out weighing out.

An enquiry is being held into the relative performance of GLAZE (Rajesh Kumar M), trained by Mr. Narayana Gowda V. in the above race as compared to its previous runs wherein it ran unplaced.

Routine Sample was taken for analysis from the winner b f GLAZE.
