PENETROMETER READING: 3.9 Cms.

RAILING POSITION: Railing fixed at an average width of 6.0 Meters from 1600 Meters to the winning post from its original position.

1st Race: 57. The Kranji Plate - (About) 2000 metres. Horses rated 20 to 45 (4 Runners).

CARAT LOVE (Pavan) ran detached from the field. Trainer Mr. Vishesh M.P. was informed to ensure better performance of his charge in future.

AMAZING STRIDE (Neeraj Rawal) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b c REFRESHMENT.

2nd Race: 58. The Sir Cecil Plate - (About) 1200 metres. Horses rated 20 to 45, 5 years old and over (Whips not allowed) (12 Runners).

BOLD ACT (R. Vaibhav) was subjected to veterinary examination. On examination, it was found to be lame on right fore. Trainer Mr. S. Narredu was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner dk b g EBOTSE.

3rd Race: 59. The Justice P. Medapa Memorial Trophy - (About) 1200 metres. Horses rated 40 to 65 (12 Runners).

Jockey Akshay Kumar, the rider of VIBRANT BLISS reported that his mount was trying to run out throughout the race.

Jockey Akshay Kumar, the rider of VIBRANT BLISS reported that he could not get a clear run between the 600 Metres till about 400 Metres due to a closely packed field.

Jockey Prashant P.Dhebe, the rider of IL VOLO reported that his mount threw its head up in the air during the race and he also added that the horse had a soft mouth.

Jockey K.G. Likith Appu, the rider of RUN FOR THE SUN reported that his mount was changing its legs after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey Akshay Kumar, the rider of VIBRANT BLISS was fined Rs.2,000/- for shifting out and causing interference to THESSALIAN (Mustakim Alam) on his outside approaching 200 Metres.

Jockey Neeraj Rawal, the rider of WHIRLWIND reported that he lost his right rein momentarily in the final 200 Metres.

Jockey C.A.Brisson, the rider of TESORINO was reprimanded for dropping hands in the final 200 Metres.

KALLU SAKKARE (A.Ramu) ran detached from the field. The horse was subjected to veterinary examination but no abnormality was reported. Trainer Mr. M. Rajendra Singh was informed to ensure better performance of his charge in future.

Jockey P. Sai Kumar, the rider of DIABLO was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

Routine Sample was taken for analysis from the winner b g DIABLO.

4th Race: 60. The World Blood Donor Day Cup - (About) 1600 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (6 Runners).

ASSURANCES (A.A. Vikrant) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Rajesh Narredu was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

PRISTINE GLORY (Neeraj Rawal) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Karthik Ganapathy was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

It was reported after the race that EDMONTON (Kuldeep Singh) returned bleeding from both nostrils. Trainer Mr. Prasanna Kumar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner dk b g ALAMGIR.

5th Race: 61. The Meydan Plate - (About) 1200 metres. Horses rated 80 and above (10 Runners).

Permission was granted to Trainer Mr. Rajesh Narredu to use Pacifier Blinkers in respect of his charge GLOBAL INFLUENCE (Yash Narredu) in the above race.

Jockey P. Trevor, the rider of RICARDO was fined Rs.3,000/- for shifting 'in' and causing interference to GLOBAL INFLUENCE (Yash Narredu) on his inside passing the 900 Metres.

Jockey A. Sandesh, the rider of KALAMITSI reported that his mount slipped at about 700 Metres.

Jockey Ramswarup, the rider of CLIFFORD reported that his mount was hanging out from the 350 Metres despite the best efforts of the Jockey, the horse went onto the sand track. The horse was subjected to veterinary examination but no abnormality was reported. In view of its behaviour, Trainer Mr. Neil Darashah was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one **Mock Race.**

Jockey Imran Chisty, the rider of THOUSAND WORDS reported that his mount stopped galloping after entering the straight. The horse was subjected to veterinary examination. On examination, it was found to have burst its blood vessels (on Endoscopy - Grade IV). Trainer Mr. Rutherford

Alford was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that BERRETTINI (Akshay Kumar) had apparently lost both fore shoes during the race.

Routine Sample was taken for analysis from the winner b h RICARDO.

6th Race: 62. The Royal Command Plate - (About) 1200 metres. Horses rated 20 to 45 (12 Runners).

Jockey Koshi Kumar, the rider of LG'S SCRIPT was fined Rs.1,000/- for shifting 'in' and causing interference to SIENNA PRINCESS (K. Sai Kiran) on his inside approaching 700 Metres.

Jockey P. Tejeshwar, the rider of STAR SERENADE reported that he accidentally lost his whip passing the 250 Metres.

Jockey Siddaraju.P, the rider of REAL HAPPINESS was fined Rs.1,000/- for shifting out under the use of whip and causing interference to the horses on his inside viz; STRAVINSKY (Angad) and STAR SERENADE (P. Tejeshwar) in the final 100 Metres.

VAYU (Manish R) ran detached from the field. Trainer Mr. Joseph B. Awale was informed to ensure better performance of his charge in future.

THE COMMANDER (Tousif Khan) sustained bleeding clip injury on right hind cannon.

Routine Sample was taken for analysis from the winner b g POLE STAR.

Permission was granted to trainer Mr. S. Dominic to deputize on behalf of trainer Mr. B. Suresh who was unable to attend the races.
