**RACING INCIDENTS**  
**(63 - 69)**

**GOING : Soft**

**PENETROMETER READING : 4.7 Cms.**

**RAILING POSITION: Railing fixed at its original position.**

**1<sup>st</sup> Race: 63. The Malenahalli Plate - (About) 1400 metres. Horses rated 00 to 25 (9 Runners).**

As Jockey Dharshan Antony. B was certified medically unfit to ride. Permission was granted to trainer Mr.Vishesh M.P. to declare Jockey A.S.Peter to ride WAKIZASHI in place of the declared rider.

DAIKI (Rajesh Kumar M) reared up as the gates opened and lost many lengths at the start. In view of its behaviour, Trainer Mr.Narayana Gowda V.. was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

VERRAZZANO (A.A. Vikrant) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.S. Narredu was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

WAKIZASHI (A.S.Peter) jumped awkwardly outwards.

Jockey Rajesh Kumar M, the rider of DAIKI was reprimanded for travelling wide rounding the final bend for no apparent reason.

It was observed that Jockey V.R.Jagadeesh, the rider of EMBOSOM had to ride his mount in check between the 900 Metres to 800 Metres due to a closely packed field.

SEA DIAMOND (Ramswarup) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f STAR OF INDIA.

**2<sup>nd</sup> Race: 64. The Amokbash Million - Div. II - (About) 1100 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (9 Runners).**

It was observed that FLIGHT OF FANCY (S. Saqlain) accidentally stumbled approaching 800 Metres.

It was observed that SEA GLORY (Siddaraju.P) was inclined to run out between the 900 Metres and 400 Metres, in the process he took out DIVINE SECRET (Neeraj Rawal). The horse was subjected to veterinary examination. On examination, it found to have pulled up its right testicle.

Jockey R. Ajinkya, the rider of SUPERNAL reported that he accidentally lost his whip in the final 75 Meters.

Jockey Suraj Narredu, the rider of INDIAN BROCADE was fined Rs.2,000/- for weighing 'in' 800 grams excess in relation to weighing out.

INDIAN BROCADE (Suraj Narredu) sustained superficial injury on left stifle.

Routine Sample was taken for analysis from the winner dk b f INDIAN BROCADE.

**3<sup>rd</sup> Race: 65. The Stewards Cup - (About) 1400 metres. Horses rated 60 to 85 (11 Runners).**

Jockey D. Patel, the rider of SPLENDIDO was fined Rs.2,000/- for shifting out and causing interference to the horses on his outside viz; METZINGER (R. Vaibhav) and FORSETI (Hindu Singh) at the start.

Jockey Antony Raj S., the rider of SEKHMET was reprimanded for dropping hands before passing the winning post.

Trainer Mr. S.S. Attaollahi reported that his charge POSITANO (Akshay Kumar) lost its right fore shoe during the race.

THUNDERING PHOENIX (P.S. Kaviraj) sustained superficial injuries on left gaskin and hock.

Routine Sample was taken for analysis from the winner b g MANDARINO.

**4<sup>th</sup> Race: 66. The Amokbash Million - Div. I - (About) 1100 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (9 Runners).**

It was observed that ROXXANE (Hindu Singh) accidentally stumbled soon after the start.

Jockey R. Vaibhav, the rider of JADE MOUNTAIN reported that his mount was not galloping fluently throughout the race. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey Suraj Narredu, the rider of MNEMOSYNE was reprimanded for shifting out and inconveniencing the horses on his outside viz; BEST OF US (M. Prabhakaran) and EMERALD TOUCH (Neeraj Rawal) passing the 700 Metres.

Jockey K. Sai Kiran, the rider of DOUBLE YOUR MONEY was fined Rs.5,000/- for the excessive use of the whip on his mount during the race (2nd infringement).

Routine Sample was taken for analysis from the winner b f AKITANIA.

**5<sup>th</sup> Race: 67. The Benaka Developers Fillies Championship Stakes (Grade I) - (About) 1600 metres. 3-year-old Indian Fillies (foaled in 2022) (15 Runners).**

Permission was granted to Trainer Mr. Prasanna Kumar to withdraw RAVISHING BEAUTY on veterinary grounds as it was found have sore shin on left fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

VEGATHA (Imran Chisty) reared up as the gates opened, lost many lengths at the start and ran detached thereafter. In view of its behaviour, Trainer Mr.P. S. Chouhan was informed not to accept with it again until its behaviour

improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Hindu Singh, the rider of MISS SMILEY ANGEL reported that his saddle shifted forward at 1400 Metres. After due examination of the equipment, Trainer Mr.G. Shashikanth was fined Rs.5,000/- for faulty saddling of his charge.

Jockey K. Sai Kiran, the rider of NORTHERN WAVES was fined Rs.2,000/- for shifting out and causing interference to MOUNTAIN JEWEL (Antony Raj S.) on his outside passing the 100 Metres.

DUBAI TOUCH (A. Prakash) sustained clip injury on left hock.

Compulsory urine and blood samples were taken for analysis from the following I,II & III placed horses viz:

b f BISHOP II

b f MOUNTAIN JEWEL III

**6<sup>th</sup> Race: 68. The Parsiana Plate - (About) 1400 metres. Horses rated 40 to 65, 5 years old and over (9 Runners).**

TREASURE CHEST (Ram Nandan Manjhi) planted, lost many lengths at the start and ran detached thereafter. In view of its behaviour, Trainer Mr.S. Dominic was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Akshay Kumar, the rider of AQUAMATIC was reprimanded for shifting 'in' and inconveniencing GOLDEN TIME (R.Ajinkya) on his inside approaching 1200 Metres.

It was reported after the race that TREASURE CHEST (Ram Nandan Manjhi) returned bleeding from both nostrils. Trainer Mr. S. Dominic was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner ch g VYASA.

**7<sup>th</sup> Race: 69. The Richelieu Plate - (About) 1400 metres. Horses rated 20 to 45 (12 Runners).**

LORVEN'S GLORY (Prashant P.Dhebe) reared up as the gates opened, thereby totally unbalancing the rider, whereby he was unseated and the horse ran rider less. In view of its behaviour, Trainer Mr.G. Y. Rajesh Babu was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey A.S.Peter, the rider of MOST AND MORE reported that his mount was hanging out after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. Trainer Mr. S. Narredu was informed to take appropriate corrective measures before accepting with it again.

Jockey Shamaz Shareef, the rider of SASSY SARA was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

Jockey Imran Chisty, the rider of THRILL OF BRAZIL was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

LORVEN'S GLORY (Prashant P.Dhebe) sustained injury on left nostril.

Routine Sample was taken for analysis from the winner dk b g KNOTTY SCOTTY.
