RACING INCIDENTS
(70-77)

GOING : Good

PENETROMETER READING :3.7 Cms.

RAILING POSITION: Railing fixed at an average width of 3.5 Meters from 1600 Meters to the winning post from its original position.

1st Race: 70. The International Day of Yoga Plate - Div. II - (About) 1200 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (10 Runners).

POWER PILOT (A.Ramu) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Warren Singh was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Shezad Khan, the rider of RESPLENDENCE was reprimanded for riding an indifferent race.

TYAARAA (Imran Chisty) sustained bleeding injury on right hind cannon.

Routine Sample was taken for analysis from the winner b f YOUR UNFORGETTABLE.

2nd Race: 71. The Paddiwick Plate - (About) 1200 metres. Horses rated 00 to 25, 5 years old and over (8 Runners).

MULTISIDED (A.R.Pradeep) was slowly away and did not raise a fluent gallop till 1100 Metres. In view of its behaviour, Trainer Mr. Darius R. Byramji was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

CHIRAAG (Afsar) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Faraz Arshad was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

STRIKING EYES (Suhas. K) jumped awkwardly inwards and inconvenienced EMERALDO (Anish Anamo Hangal) soon after the start.

Jockey Angad, the rider of SACRED CREATOR was reprimanded for not improving his position from the start till about 600 Metres for no apparent reason.

Jockey A.R.Pradeep, the rider of MULTISIDED was reprimanded for not maintaining a straight course in the final 100 Metres.

Routine Sample was taken for analysis from the winner b m MULTISIDED.

3rd Race: 72. The International Day of Yoga Plate - Div. I - (About) 1200 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (8 Runners).

Trainer Mr. Neil Darashah was fined Rs. 5,000/- for not obtaining prior permission to use Tongue Strap on his charge TOGO (Arul J.H). Subsequently, permission was granted to him to use Tongue Strap.

EFFICACY (P. Trevor) reared up, hit its neck on starting gate and dropped the rider. On immediate examination, it was found to have sustained injury on left side of the neck. Under the circumstances, it was permitted to be withdrawn on veterinary

grounds before coming under Starter's order. Trainer Mr. S.S. Attaollahi was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

MAGESTIC PERSONA (A.Ramu) walked out of the gates and lost few lengths at the start. In view of its behaviour, Trainer Mr. Warren Singh was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

ACES UP (A.R.Pradeep) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Warren Singh was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey A.Ramu, the rider of MAGESTIC PERSONA reported that his whip got entangled for a few strides passing the 1100 Metres.

ACES UP (A.R.Pradeep) sustained superficial clip injury on left hock.

Surprise sample was taken for analysis from b g ACES UP.

Routine Sample was taken for analysis from the winner ch g SAPPORO.

4th Race: 73. The Sir M. Visvesvaraya Memorial Cup - (About) 1400 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (11 Runners).

Trainer Mr. Neil Darashah was fined Rs.10,000/- by the Stewards for not declaring his charge CALL ME TRINITY to start after having accepted with it to run in the above race when it was under treatment.

As Jockey Darshan R.N. was certified medically unfit to ride. Permission was granted to trainer Mr. S.S. Attaollahi to declare Jockey Shreyas Singh S to ride QUEEN MAXIMA in place of the declared rider.

Jockey Arvind Kumar. N, the rider of ZEPHYRINE was reprimanded for shifting out and inconveniencing the horses on his outside viz; STAR OF THE FUTURE (Shivam), which in turn passed it onto RENOIR (A. Prakash) passing the 700 Metres.

Jockey A. Prakash, the rider of RENOIR was reprimanded for riding an indifferent race.

Jockey Arvind Kumar. N, the rider of ZEPHYRINE was reprimanded for dropping hands before passing the winning post.

STAR OF THE FUTURE (Shivam) ran detached from the field. Trainer Mr. S. Dominic was informed to ensure better performance of his charge in future.

It was reported after the race that QUEEN MAXIMA (Shreyas Singh S) had apparently lost its left fore shoe during the race.

BLACK DIAMOND (Yash Narredu) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b c MAHLER.

5th Race: 74. The D. Kumar Siddanna Memorial Trophy - (About) 1400 metres. Horses rated 40 to 65 (12 Runners).

Jockey Bhawani Singh, the rider of EXCLUSIVE BLACK had to ride his mount in check at about 1300 Metres due to crowding of the field.

Routine Sample was taken for analysis from the winner b f ICE OF FIRE.

6th Race: 75. The Chief Justice's Cup(Grade III) - (About) 1800 metres. 4 years old and over. (9 Runners).

SUPERNATURAL (Vivek.G) planted and did not take any practical part in the race. In view of its behaviour, Trainer Mr.P. Shroff was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least atleast two Mock Races.

Jockey C.Umesh, the rider of NOMITSI was fined Rs.1,000/- for coming 'in' and causing interference to the horses on his inside viz;QUEEN OF KINGS (A.S.Peter) and TOUCH OF GREY (Yash Narredu) approaching 1700 Metres.

Compulsory urine and blood samples were taken for analysis from the following I,II& III placed horses viz:

7th Race: 76. The Dupont Plate - (About) 1400 metres. Horses rated 20 to 45 (12 Runners).

Trainer Mr.Darius R. Byramji was fined Rs.1,000/- for failing to produce the declared colors at the scales in respect of his charge DONCASTER BELLE (S. Saqlain). Subsequently All Black emergency colours were permitted to be used.

HIGGS BOSON (Angad) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Narayana Gowda V. was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey L. Alex Rozario, the rider of SUPERCHARGE was fined Rs.1,000/- for shifting out and causing interference to TURKOMAN (S.A. Amit) on his outside soon after the start.

Jockey M. Prabhakaran, the rider of IMPERIAL STAR was fined Rs.1,000/- for coming 'in' and causing interference to WELLINGTON (Arvind Kumar. N) on his inside passing the 1200 Metres.

(A)

An enquiry was held by the Stipendiary Stewards into the interference caused by Jockey S. Saqlain, the rider of DONCASTER BELLE in the above race. In that he has come "in" sharply and caused very severe interference to the horses on his inside viz; "TURKOMAN" & "DOUBLE VISION" soon after the start, going further he has again allowed his mount to shift "in" causing interference to the horses on his inside viz; "SUPERCHARGE", "NIGHT RAIDER" ,"AGERA" & "DR COLCHESTER" before passing the red marker post.

Jockey S. Saqlain was interviewed by the Stipendiary Stewards. The Stipendiary Stewards after considering the submissions made by Jockey S. Saqlain and after viewing the CCTV replay decided to charge Jockey S. Saqlain for Reckless Riding.

The Stipendiary Stewards thereafter suspended the Jockey's Licence granted to S. Saqlain **for three (3) race days of BSM 2025 i.e 05/07/2025, 06/07/2025 & 12/07/2025 and fine him a sum of Rs.20,000/-** as he had pleaded guilty to the charge under Rule No. 161 (i) of the BTC Rules of Racing for Reckless Riding on his mount DONCASTER BELLE (he was permitted to ride work) and was informed of his right to appeal.

(B)

An enquiry was held by the Stipendiary Stewards into the interference caused by Jockey Neeraj Rawal, the rider of FINAL CALL in the above race. In that he has shifted 'in' and caused interference to the horses on his inside viz; "DONCASTER BELLE (S. Saqlain)" & "DIVINE PROTECTOR (A.Ramu)" passing the 1200 Metres, thereafter he restrained his mount, whereby the rider A. Ramu clipped his mount DIVINE PROTECTOR was totally unbalanced and was dislodged from his mount at about 1100 Metres.

Jockey Neeraj Rawal was interviewed by the Stipendiary Stewards. The Stipendiary Stewards after considering the submissions made by Jockey Neeraj Rawal and after viewing the CCTV replay decided to charge Jockey Neeraj Rawal for Careless Riding.

The Stipendiary Stewards thereafter suspended the Jockey's Licence granted to Neeraj Rawal **for two (2) race days of BSM 2025 i.e., 05/07/2025 & 06/07/2025** as he had pleaded guilty to the charge under Rule No. 161 (i) of the BTC Rules of Racing for Careless Riding on his mount FINAL CALL (he was permitted to ride work) and was informed of his right to appeal.

DIVINE PROTECTOR (A.Ramu) sustained superficial clip injury on left achilles.

Routine Sample was taken for analysis from the winner b f DONCASTER BELLE.

8th Race: 77. The Prabalo Plate - (About) 1200 metres. Horses rated 20 to 45 (12 Runners).

STAR ADMIRAL (Rayan Ahmed R.) walked out of the gates and did not raise a fluent gallop for the first 100 Metres of the start. In view of its repeated behaviour, Trainer Mr.Aravind G. was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least **two Mock Races** and **two jump outs on a starting gate practice day**

SILVER QUEST (Prashant P.Dhebe) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. M. Rajendra Singh was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

THUTMOSE (Antony Raj S.) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. S.Shoban Babu was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Angad, the rider of HONEYPOT reported that the saddle shifted back after entering the straight. After due examination of the equipment, Trainer Mr.Narayana Gowda V. was fined Rs.5,000/- for improper saddling of his charge.

Jockey A. Sandesh, the rider of PERFECT ATTITUDE reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. Trainer Mr. Arjun Mangalorkar was informed to take appropriate corrective measures before accepting with it again.

Jockey Prashant P.Dhebe, the rider of SILVER QUEST reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. Trainer Mr. M. Rajendra Singh was informed to take appropriate corrective measures before accepting with it again.

An enquiry was held by the Stipendiary Stewards into the interference caused by Jockey Aleemuddin, the rider of ANZAC PARADE in the above race. In that he has shifted 'in' and caused interference to ABLE ONE (Salman Khan), which in turn passed it onto the horses on his inside viz; SUPER KIND (D'nuSingh Deora), HONEYPOT (Angad) and STRIKING ARROW (Arjun) at about 1100 Metres.

Jockey Aleemuddin was interviewed by the Stipendiary Stewards. The Stipendiary Stewards after considering the submissions made by Jockey Aleemuddin and after viewing the CCTV replay decided to charge Jockey Aleemuddin for Careless Riding.

The Stipendiary Stewards thereafter suspended the Jockey’s Licence granted to Aleemuddin on **05/07/2025** as he had pleaded guilty to the charge under Rule No. 161 (i) of the BTC Rules of Racing for Careless Riding on his mount ANZAC PARADE (he was permitted to ride work) and was informed of his right to appeal.

THUTMOSE (Antony Raj S.) sustained injury on left nostril.

Routine Sample was taken for analysis from the winner b m DARRION.
