# BANGALORE SUMMER MEETING 2025 TWELFTHDAY, SUNDAY, 22ND JUNE 2025 RACING INCIDENTS

**GOING:** Good

**PENETROMETER READING: 3.3 Cms.** 

RAILING POSITION: Railing fixed at its original position.

#### 1<sup>st</sup> Race: 78. The Guindy Plate - (About) 1200 metres. Horses rated 00 to 25 (9 Runners).

Jockey R. Vaibhav, the rider of MYSTICAL FOREST reported that his mount was not galloping fluently throughout the race. The horse was subjected to veterinary examination. The Club's Veterinary Officer reported that during examination after the race the horse wobbled and collapsed. Subsequently, necessary treatment was given to the horse, however, the horse was unable to get up due to acute Paraplegia. Hence, it was euthanized.

Jockey Anish Anamo Hangal, the rider of STAR SYMPHONY was fined Rs.2,000/- for not making any sufficient effort to improve his position from the start till about 600 Metres.

STAR SYMPHONY (Anish Anamo Hangal) ran detached from the field. Trainer Mr. Pradeep Annaiah was informed to ensure better performance of his charge in future.

Jockey Md.Akram, the rider of MYSTIC CHARM was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

An enquiry is being held into the running of MYSTIC CHARM (Md.Akram), trained by Mr. M. Rajendra Singh in the above race as compared to its previous run in Race No. 36 i.e., The Endorsement Plate - (About) 1600 metres. Maiden Horses 3 years old only run on 01/6/2025 wherein it ran unplaced.

It was reported after the race that AMAZING STORM (Ramswarup) pulled up lame on right hind and sustained superficial injury on left hind pastern. Trainer Mr. S. Inayathulla was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b f MYSTIC CHARM.

## 2<sup>nd</sup> Race: 79. The Pronto Pronto Plate - (About) 1600 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (7 Runners).

KNIGHT REGENT (Neeraj Rawal) was extremely fractious inside the stalls, reared up and sat down for a considerable period of time. On immediate examination, it was found that saddle has shifted back. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

EINAUDI (P. Trevor) planted and did not raise a fluent gallop for the first 100 Metres after the start. In view of its behaviour, Trainer Mr. S.S. Attaollahi was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

SEA SOVEREIGN (A.S.Peter) after jumping out swerved towards left and lost few lengths. In view of its behaviour, Trainer Mr. Deepesh Narredu was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey A.S.Peter, the rider of SEA SOVEREIGN reported that his mount was hanging out after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. Trainer Mr. Deepesh Narredu was informed to take appropriate corrective measures before accepting with it again.

Routine Sample was taken for analysis from the winner gr f KISS OF GREY.

#### 3<sup>rd</sup> Race: 80. The Bergamo Plate - Div. II - (About) 1100 metres. Horses rated 20 to 45, 4 years old and over (10 Runners).

As Jockey A. Ramu was certified medically unfit to ride. Permission was granted to trainer Mr.M. Rajendra Singh to declare Jockey K.G. Likith Appu to ride SHE'S SO BEAUTIFUL in place of the declared rider.

FELISA (Pavan) jumped awkwardly inwards onto WOMAN AT WAR (Neeraj Rawal) at the start.

Jockey Ramswarup, the rider of SPIRIT DANCER reported that his saddle shifted back after entering the straight. After due examination of the equipment, Trainer Mr. Aravind. G was fined Rs.5,000/- for improper saddling of his charge.

Jockey D'nuSingh Deora, the rider of GLORIOUS SPECTRE reported that his mount was hanging out throughout the race, in the process he had inconvenienced NOBLE CAUSE (P. Trevor) at 700 Metres and 150 Metres. The horse was subjected to veterinary examination. On examination, it was found to have pulled up its right testicle. Trainer Mr. Neil B Devaney was informed to take appropriate remedial measures before accepting with it again.

Jockey K.G. Likith Appu, the rider of SHE'S SO BEAUTIFUL reported that his mount had a soft mouth. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey Vivek.G, the rider of LEGENDARY IMPACT reported that he accidently lost his whip passing the 150 Meters.

Routine Sample was taken for analysis from the winner b c GLORIOUS SPECTRE.

### 4<sup>th</sup> Race: 81. The Noble Prince Plate - (About) 1800 metres. Horses rated 20 to 45 (11 Runners).

ART OF ROMANCE (P. Trevor) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Warren Singh was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

JOYFUL SPIRIT (A.R.Pradeep) accidentally stumbled soon after the start.

It was observed that FOREVER ROYAL (Laxman Singh) accidentally stumbled, dislodging its rider whereby HIGHLAND DREAM (Imran Chisty) who was travelling directly behind had to steady his mount, in the process Jockey Imran Chisty was also unbalanced & dislodged from his mount approaching 1500 Metres and both the horses ran rider less thereafter. As the incident was accidental no action was taken beyond noting the incident.

Jockey Suraj Narredu, the rider of STENTORIAN was reprimanded for shifting 'in' and inconveniencing BRUCE ALMIGHTY (Mukesh Kumar) on his inside approaching 200 Metres.

Jockey Vivek.G, the rider of MONTERIO was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

Routine Sample was taken for analysis from the winner b f GALWAY GIRL.

#### 5<sup>th</sup> Race: 82. The Civil Service Cup - (About) 2000 metres. Horses rated 60 to 85 (11 Runners).

MESCALITO (Akshay Kumar) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. S.S. Attaollahi was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

EATON SQUARE (Yash Narredu) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. M. Narredu was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey K.G. Likith Appu, the rider of SPLENDIDO was fined Rs.5,000/- for not exercising sufficient control over his mount, thereby allowing his mount to shift out and causing interference to the horses on his outside viz; EATON SQUARE (Yash Narredu), EAGLE DAY (Vivek.G) and THE LEADER (Neeraj Rawal) soon after the start.

Jockey Neeraj Rawal, the rider of THE LEADER was fined Rs.1,000/- for shifting 'in' and causing interference to SPLENDIDO (K.G. Likith Appu) on his outside, whereby the rider of SPLENDIDO (K.G. Likith Appu) had to check his mount and shift out, in the process bumped ARKADIAN (S. Saqlain) approaching 1800 Metres

Jockey S. Saqlain, the rider of ARKADIAN was fined Rs.5,000/- for shifting 'in' and causing interference the horses on his inside viz; SECRET SAINT (P. Trevor) and EAGLE DAY (Vivek.G) passing the 250 Metres.

EAGLE DAY (Vivek.G) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g GOLDEN THUNDER.

### 6<sup>th</sup> Race: 83. The Zavaray S. Poonawalla Colts Championship Stakes(Grade I) - (About) 1600 metres. 3-year-old Indian Colts and Geldings (foaled in 2022) (16 Runners).

Jockey Antony Raj S., the rider of SOVEREIGN KING was fined Rs.3,000/- for coming 'in' and tightening GUNSMOKE (S. Saqlain) and ROSARIO (Vivek.G), thereby RED BISHOP (P. Trevor) had to check his mount momentarily passing the 800 Metres.

Jockey Mukesh Kumar, the rider of PROKOFIEV reported that he accidently lost his whip approaching 400 Metres.

Jockey Vivek.G, the rider of ROSARIO was fined Rs.5,000/- for shifting out and taking out STORMY SEA (N. S. Parmar) on his outside passing the 450 Metres.

Jockey A. Ashhad Asbar, the rider of WALKING THUNDER was fined Rs.2,000/- for shifting out and causing interference GLORIOUS STRIDES (Suraj Narredu) on his outside passing the 250 Metres.

CORTE MADERA (Kuldeep Singh) ran detached from the field. Trainer Mr. L. D'Silva was informed to ensure better performance of his charge in future.

Jockey P. Trevor, the rider of RED BISHOP was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

CIRCLE OF DREAMS (Akshay Kumar) was subjected to veterinary examination. On examination, it was found to have sustained superficial clip injury on left hind pastern.

Compulsory urine and blood samples were taken for analysis from the following I, II & III placed horses viz:

b c SOVEREIGN KING I

b c STORMY SEA II

b g RED BISHOP III

#### 7<sup>th</sup> Race: 84. The Bergamo Plate - Div. I - (About) 1100 metres. Horses rated 20 to 45, 4 years old and over (9 Runners).

Jockey Vivek.G, the rider of LG'S STAR reported that his mount was hanging out from 900 Metres. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. V. Lokanath was informed to take appropriate corrective measures before accepting with it again.

Routine Sample was taken for analysis from the winner dk b g DEFENCE COUNSEL.

#### 8<sup>th</sup> Race: 85. The Borsalino Plate - (About) 1600 metres. Horses rated 40 to 65, 4 years old and over (12 Runners).

It was reported after the race that LIVE THE DREAM (Mustakim Alam) pulled up lame on left fore. Trainer Mr. Prasanna Kumar was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

BLACK DUST (S.A. Amit) ran detached from the field. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Prasad Raju K.S.V. was informed to ensure better performance of his charge in future.

Routine Sample was taken for analysis from the winner b g ROCK BANK.
