RACING INCIDENTS
(86-93)

GOING : Good

PENETROMETER READING : 3.5 Cms.

RAILING POSITION: Railing fixed at an average width of 7.5 Meters from 1600 Meters to winning post from its original position.

1st Race: 86. The Royal Challenge Plate - (About) 1200 metres. Horses rated 00 to 25, 6 years old and over (11 Runners).

N R I MILLENNIUM (Rayan Ahmed R.) was extremely fractious and refused to be stalled. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

BENZEMA (Bhawani Singh) planted and lost many lengths at the start. In view of its repeated behaviour, Trainer Mr. Pradeep Annaiah (deputising on behalf of Trainer Mr. Faraz Arshad) was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least two Mock Races.

MEGHANN (Laxman Singh) jumped awkwardly outwards.

CHINKY PINKY (Aleemuddin) jumped awkwardly inwards.

Jockey Shivam, the rider of SACRED CREATOR had to steady his mount passing the 950 Metres due to a closely packed field.

Routine Sample was taken for analysis from the winner b m BALTIMORE.

2nd Race: 87. The Poonawalla Stud Plate - Div. II - (About) 1200 metres. Horses rated 40 to 65, 5 years old and over (8 Runners).

Trainer Mr. S. Shoban Babu was fined Rs.2,000/- for presenting his charge FORTUNATUS (Arjun) in the paddock without a Cross Nose Band for which prior permission was taken. Subsequently, Cross Nose Band was put on before the horse left the paddock.

SUPER MARVELLA (Darshan N) suddenly put its head towards the right as the gates opened and lost many lengths. In view of its behaviour, Trainer Mr. Neil B Devaney was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey P. Sai Kumar, the rider of THE STRIKINGLY had to steady his mount to avoid striking front runner SUPER SAPPHIRE (M. Prabhakaran) passing the 600 Metres.

It was reported after the race that GREY BEAUTY (C. Umesh) returned bleeding from both nostrils. Trainer Mr. James Mckeown was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g HIGH SPEED DIVE.

3rd Race: 88. The Smart Chieftan Plate - (About) 1400 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (11 Runners).

Jockey P. Trevor, the rider of SCENT OF RAIN was fined Rs.1,000/- for shifting 'in' and causing interference to the horses on his inside viz; BLUE PICASSO

(C.Umesh), STALINGRAD (L. Alex Rozario) and FIERY LEXI (R.Ajinkya) soon after the start.

Jockey Suraj Narredu, the rider of NEUTRALIST was reprimanded for shifting 'in' and causing interference to GOODWILL (Vishal N Bunde) on his inside at the start.

Jockey Akshay Kumar, the rider of POWER OF GOLD reported that his mount accidentally stumbled passing the 850 Metres and was running green throughout the race.

Jockey Suraj Narredu, the rider of NEUTRALIST reported that his mount accidentally stumbled passing the 700 Metres and 600 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey L. Alex Rozario, the rider of STALINGRAD reported that his mount did not relish the underfoot conditions of the track. The horse was subjected to veterinary examination but no abnormality was reported.

It was observed that BLUE PICASSO (C.Umesh) accidentally brushed the running rails passing the 300 Metres.

Routine Sample was taken for analysis from the winner ch g HYPERDRIVE.

4th Race: 89. The Malakpet Plate - Div. II - (About) 1300 metres. Horses rated 20 to 45 (9 Runners).

Trainer Mr.Pradeep Annaiah was fined Rs.10,000/- by the Stewards for not declaring his charge SUPER KIND to start after having accepted with it to run in the above race when it was under treatment.

FEMME FATALE (L. Alex Rozario) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.M. Rajendra Singh was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

EXTRAORDINARY (N. B. Kuldeep) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Joseph B. Awale was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

PERICLES (Arvind Kumar. N) jumped awkwardly outwards.

Jockey R. Vaibhav, the rider of ADELANTO reported that his mount accidentally stumbled passing the 600 Metres and was also coughing after the race. The horse was impounded for veterinary examination. On examination, it was found to have burst its blood vessels (on Endoscopy Grade - IV). Trainer Mr. G. Y. Rajesh Babu was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again. *An enquiry is being held into the running of ADELANTO, trained by Mr. G. Y. Rajesh Babu with particular reference to the difference in weight of the horse.*

Jockey Vinod Shinde, the rider of GREY IMPACT reported that his mount was lugging out under pressure after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey Rajesh Kumar M, the rider of MARTHA was reprimanded for travelling wide rounding the final bend for no apparent reason.

It was reported after the race that PERICLES (Arvind Kumar. N) returned bleeding from both nostrils. Trainer Mr.Pradeep Annaiah was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported by the Club's Veterinary Officer that EXTRAORDINARY (N. B. Kuldeep) was examined at 7:17 P.M at the trainer's stable premises and no abnormality was reported.

Surprise sample was taken for analysis from b g ADELANTO.

Routine Sample was taken for analysis from the winner b f OUT INTO SPOTLIGHT.

5th Race: 90. The Managing Committee Gold Cup - (About) 1600 metres. Horses rated 80 and above (7 Runners).

It was reported after the race that EUPHORIC (Vishwa.V) returned bleeding from both nostrils. Trainer Mr. Neil Darashah was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner dk b g MAYNE MAGIC.

6th Race: 91. The Deltin Juvenile Sprinters' Million(Grade III) - (About) 1200 metres. 3-year-old horses (foaled in 2022). (7 Runners).

POLE STAR (Akshay Kumar) jumped awkwardly outwards onto RACING RULER (S.A. Amit) soon after the start.

ZIVA (P. Trevor) was subjected to veterinary examination. On examination, it was found to have sustained injury on gums.

Compulsory urine and blood samples were taken for analysis from the following I, II & III placed horses viz:

b f ELUSIVE ART II

b g POLE STAR III

7th Race: 92. The Poonawalla Stud Plate - Div. I - (About) 1200 metres. Horses rated 40 to 65, 5 years old and over (8 Runners).

MACRON (A.R.Pradeep) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Pradeep Annaiah was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Faiz, the rider of GIMMLER was fined Rs.1,000/- for shifting 'in' and causing interference to KALLU SAKKARE (Chethan Kalay S.) soon after the start.

An enquiry is being held into the running and riding of LAUTERBRUNNEN, trained by Mr. Narayana Gowda V. and ridden by Jockey Rajesh Kumar M in the above race.

Routine Sample was taken for analysis from the winner ch g STAR CONCEPT.

8th Race: 93. The Malakpet Plate - Div. I - (About) 1300 metres. Horses rated 20 to 45 (9 Runners).

Permission was granted to trainer Mr. Azhar Ali to withdraw KNOTTY AFFAIR (Akshay Kumar) on compassionate grounds.

Jockey R. Vaibhav replaced the indisposed Jockey Vivek. G on N R I VICTORY.

FORCE OF NATURE (L. Alex Rozario) brushed the gates while jumping out of the starting gates and lost few lengths at the start. In view of its behaviour, Trainer Mr. V. Lokanath was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

It was observed that Jockey P. Trevor, the rider of SASSY SARAH had lost his right stirrup soon after the start, which he regained within a few strides.

Jockey L. Alex Rozario, the rider of FORCE OF NATURE was fined Rs.5,000/- for not making sufficient effort on his mount in the final 400 Metres of the race.

FORCE OF NATURE (L. Alex Rozario) sustained superficial injury on right fore arm.

Routine Sample was taken for analysis from the winner b f SASSY SARAH.

Permission was granted to trainers M/s. Pradeep Annaiah and Neil B. Devaney to deputize on behalf of trainers M/s. Faraz Arshad and Prasanna Kumar.P who were unable to attend the races.
