# BANGALORE SUMMER MEETING 2025 EIGHTH DAY, SUNDAY, 08<sup>TH</sup> JUNE 2025 RACING INCIDENTS (49-56)

**GOING:** Good

**PENETROMETER READING: 3.2 Cms.** 

RAILING POSITION: Railing fixed at an average width of 7.5 Meters from 1600 Meters to the winning post from its original position.

1st Race: 49. The Everynsky Plate - Div. II - (About) 1200 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (9 Runners).

ZORAWAR (R. Vaibhav) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Irfan Ghatala was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey R. Vaibhav, the rider of ZORAWAR was fined Rs.3,000/- for not improving his position from the start till about 500 Metres for no apparent reason.

An enquiry was held on 09-06-2025 by the Stipendiary Stewards into the interference caused by Jockey Rajesh Kumar M, the rider of GLOBAL HART in the above race. In that, he pushed his mount recklessly, did not maintain a proper course, cut across the entire field before passing the red marker post. Thereafter, he restrained his mount approaching 900 Metres, when it was full of running, thus he failed to exercise full control over his mount, in the process shifted out causing severe interference to the horses on his outside viz; REFINED AGGRESSION (Vivek.G), TREASURE QUEEN (K. Sai Kiran) and CATCH THE WORM (Shreyas Singh S) passing the 850 Metres.

Jockey Rajesh Kumar M was interviewed by the Stipendiary Stewards. The Stipendiary Stewards after considering the submissions made by Jockey Rajesh Kumar M and after viewing the CCTV replay decided to charge Jockey Rajesh Kumar M for Reckless Riding.

The Stipendiary Stewards thereafter suspended the Jockey's Licence granted to Rajesh Kumar M for two (2) race days of BSM 2025 i.e., 21/06/2025 and 22/06/2025 as he had pleaded guilty to the charge under Rule No. 161 (i) of the BTC Rules of Racing for Reckless Riding on his mount GLOBAL HART (he was permitted to ride work) and was informed of his right to appeal.

Jockey Vivek.G, the rider of REFINED AGGRESSION was fined Rs.1,000/- for coming 'in' and causing interference to the horses on his inside viz; CLAUDE (P.S. Kaviraj) and CATCH THE WORM (Shreyas Singh S) approaching 200 Metres.

Jockey Shreyas Singh S, the rider of CATCH THE WORM was reprimanded for shifting out and inconveniencing CLAUDE (P.S. Kaviraj) on his outside passing the 200 Metres.

GLOBAL HART (Rajesh Kumar M) sustained superficial injuries on right knee and right hind cannon.

TREASURE QUEEN (K. Sai Kiran) sustained superficial injury on right hock.

Routine Sample was taken for analysis from the winner dk b c REFINED AGGRESSION.

## 2<sup>nd</sup> Race: 50. The Nandi Plate - (About) 1400 metres. Horses rated 20 to 45, 6 years old and over (7 Runners).

Trainer Mr. Aravind G. was fined Rs.10,000/- for having accepted his charge STAR ADMIRAL (Rayan Ahmed R.) to run in the above race when the owner was under [B.T.F. BAN]. Subsequently, permission was granted to him to withdraw the horse from the above race.

Jockey V.R.Jagadeesh, the rider of MILLBROOK reported that his mount accidentally stumbled soon after the start.

Jockey Arjun, the rider of WAR TRAIL reported that his mount accidentally stumbled passing the 1100 Metres.

Routine Sample was taken for analysis from the winner b m LADY INVICTUS.

## 3<sup>rd</sup> Race: 51. The Everynsky Plate - Div. I - (About) 1200 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) 7 Runners).

Trainer Mr. Arjun Mangalorkar was fined Rs.10,000/- by the Stewards for not declaring his charge KONKRAH to start after having accepted with it to run in the above race.

The Club's Veterinary Officer reported that WINGS OF FURY (A. Sandesh) flipped over on its back twice at the weighing yard and sustained injury on both hocks. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr.Adhiraj Singh Jodha was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

MIDNIGHT BLUE (Suraj Narredu) jumped awkwardly outwards onto PETALUMA (Vivek.G) at the start.

Jockey Arvind Kumar. N, the rider of HYPERDRIVE was fined Rs.1,000/- for shifting 'in' and causing interference to OUT INTO SPOTLIGHT (Shamaz Shareef) on his inside passing the 1000 Metres.

Jockey Suraj Narredu, the rider of MIDNIGHT BLUE fined Rs.2,000/- for allowing his mount to drift out, thereby causing interference to AATHERV (Vivek) on his outside passing the 900 Metres.

Routine Sample was taken for analysis from the winner b f PETALUMA.

## 4<sup>th</sup> Race: 52. The Astounding Plate - (About) 1600 metres. Horses rated 20 to 45 (7 Runners).

Permission was granted to Trainer Mr. Warren Singh to withdraw ENJOYABLE (Vinod Shinde) on veterinary grounds as it was found to be lame on right fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

FOREVER ROYAL (Laxman Singh) took a fly jump.

Jockey Rayan Ahmed R., the rider of CARTER was fined Rs.1,000/- for shifting out and bumping the horses on his outside viz; ART OF ROMANCE (K. Sai Kiran) and DR ASH (Rajesh Kumar M) soon after the start.

Jockey K. Sai Kiran, the rider of ART OF ROMANCE was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

Routine Sample was taken for analysis from the winner ch c CHARISMATIC.

## 5<sup>th</sup> Race: 53. The Speaker's Cup - (About) 1200 metres. Horses rated 60 to 85 (12 Runners).

ART COLLECTOR (Mustakim Alam) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Aman Altaf Hussain was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Vivek.G, the rider of HURRICANE BAY was fined Rs.2,000/- for shifting out and causing interference to the horses on his outside viz; VAL D'ARAN (C.Umesh) and N R I ACE (Imran Chisty) soon after the start.

It was observed that Jockey K. Sai Kiran, the rider of GRIZZLY had to ride his mount in check between the 700 Metres to 600 Metres due to a closely packed field.

Jockey Mustakim Alam, the rider of ART COLLECTOR had to steady his mount to avoid striking the front runner BRILLIANT STAR (M. Prabhakaran) passing the 500 Metres.

It was observed that DEL AVIZ (Ramswarup) accidentally brushed the running rails passing the 400 Metres.

Jockey Yash Narredu, the rider of PLUTO was fined Rs.3,000/- for shifting 'in' and causing interference to DEL AVIZ (Ramswarup) on his inside passing the 150 Metres.

BRILLIANT STAR (M. Prabhakaran) sustained bleeding cut on right fore cannon.

Routine Sample was taken for analysis from the winner b g PLUTO.

## 6<sup>th</sup> Race: 54. The H.H.Krishnaraja Wadiyar Cup - (About) 1600 metres. 4 years old and over. (9 Runners).

SUPERNATURAL (Vivek.G) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. P. Shroff was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

LIVERMORE (K.G. Likith Appu) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b h SHAMROCK.

## 7<sup>th</sup> Race: 55. The Diablo Plate - (About) 1400 metres. Horses rated 20 to 45 (12 Runners).

Jockey S.Hinayathulla, the rider of MONTERIO was fined Rs.1,000/- for shifting out and causing interference to the horses on his outside viz; ELVEDEN (Antony Raj S.) and SUPERCHARGE (Vinod Shinde) passing the 500 Metres.

Jockey A.R.Pradeep, the rider of CONTINUES was fined Rs.3,000/- for not making sufficient effort on his mount in the final 400 Metres.

Jockey Ramswarup, the rider of LUX AETERNA reported that his mount was hanging 'in' in the final 250 Metres.

Jockey Angad, the rider of STRAVINSKY was reprimanded for riding an indifferent race.

MONEY BAGS (P. Trevor) was impounded for veterinary examination but no abnormality was reported.

Surprise sample was taken for analysis from b g MONEY BAGS.

Routine Sample was taken for analysis from the winner b f LUX AETERNA.

## 8<sup>th</sup> Race: 56. The Mystic Memory Plate - (About) 1400 metres. Horses rated 40 to 65, 4 years old and over (12 Runners).

Jockey P. Trevor, the rider of ZURI was fined Rs.1,000/- for coming 'in' and tightening the horses viz; CHOTIPARI (Imran Chisty) and EMPHATIC (A. Sandesh) on his inside approaching 1200 Metres.

Jockey Angad, the rider of ARMORY was reprimanded for travelling wide between the 700 Metres till about 500 Metres for no apparent reason.

Jockey Arvind Kumar. N, the rider of POWER OF BEAUTY reported that he accidently lost his whip passing the 200 Meters.

Jockey Kuldeep Singh, the rider of CLARA was fined Rs.2,000/- for failing to persevere his mount in the final 200 Metres.

POWER OF BEAUTY (Arvind Kumar. N) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner dk b f EMPHATIC.
